Bill Topic: SUNSET SUICIDE PREVENTION COMMISSION

Summary of Fiscal Impact:

Sunset bill. This bill continues the Suicide Prevention Commission in the Department of Public Health and Environment, which is scheduled to repeal on September 1, 2024. State fiscal impacts under the bill include only the continuation of the program's current expenditures. The program is continued until September 1, 2034.

Appropriation Summary: No appropriation is required; see the State Appropriation section.

Fiscal Note Status: This final fiscal note reflects the enacted bill.

1 Table 1 shows the new impacts resulting from changes to the program under the bill, and the continuing impacts from extending the program beyond its current repeal date. Because the bill continues a program without making any changes, there are no new impacts. The continuing program impacts will end if the bill is not passed and the program is allowed to repeal.

## Summary of Legislation

The bill continues the Suicide Prevention Commission until September 1, 2034. Under current law, the commission repeals on September 1, 2024. The bill also decreases the size of the commission from 26 to 22 people.

## Background

In 2014, the General Assembly established the Suicide Prevention Commission to provide leadership for suicide prevention and intervention. The commission advises the Colorado Department of Public Health and Environment (CDPHE) and helps establish statewide priorities related to suicide prevention. ## Continuing Program Impacts

Based on the department's current costs, CDPHE is expected to have expenditures of \$97,000 to continue to administer the commission. If this bill is enacted, current expenditures will continue for the program starting in FY 2024-25. If this bill is not enacted, the program will end on September 1, 2024, and state expenditures will decrease starting in FY 2024-25 by the amounts shown in Table 1, above.

## Effective Date

The bill was signed into law by the Governor on May 31, 2024, and takes effect on August 7, 2024, assuming no referendum petition is filed.

## State Appropriations

Funding to continue the Suicide Prevention Commission was included in the FY 2024-25 Long Bill; therefore, no appropriation is required.
