This bill continues the Human Trafficking Council in the Department of Public Safety, which is scheduled to repeal on September 1, 2024. State fiscal impacts under the bill include only the continuation of the program's current expenditures. The program is continued indefinitely. <sup>&</sup>lt;sup>1</sup> Table 1 shows the new impacts resulting from changes to the program under the bill, and the continuing impacts from extending the program beyond its current repeal date. Because the bill continues a program without making any changes, there are no new impacts. The continuing program impacts will end if the bill is not passed and the program is allowed to repeal.

### **Summary of Legislation**

Under current law, the Human Trafficking Council in the Department of Public Safety (CDPS) is scheduled to repeal on September 1, 2024. This bill continues the council indefinitely.

### **Background**

The Human Trafficking Council was created in 2014 in <u>House Bill 14-1273</u>. The council provides several services to combat human trafficking in Colorado. These services include engaging in training, collecting data, accessing services for victims, and conducting outreach campaigns. ### **Continuing Program Impacts**

Based on the department's FY 2023-24 budget request, the CDPS is expected to have expenditures of \$270,770 to administer the program. If this bill is enacted, current expenditures will continue for the program starting in FY 2024-25. Costs in FY 2024-25 are prorated for the September 1 repeal date. This continuing revenue is subject to the state TABOR limit. If this bill is not enacted, the program will end on September 1, 2024, and state revenue and expenditures will decrease starting in FY 2024-25 by the amounts shown in Table 1, above.

#### **Effective Date**

The bill takes effect 90 days following adjournment of the General Assembly sine die, assuming no referendum petition is filed.

## **State Appropriations**

For FY 2024-25, the bill requires a General Fund appropriation of \$225,642 to the Department of Public Safety, and 1.8 FTE.
