The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating \$74,257 General Fund to the Judicial Department for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.8 FTE.

JBC Staff Analysis

L.007 Bill Sponsor amendment **L.007** (attached) removes the requirement that the State Court Administrator's Office publish and update information on its website regarding upcoming trainings for family investigators and evaluators. By removing this requirement, amendment **L.007** eliminates the General Fund expenditures identified in the Fiscal Note dated April 3, 2024, as the Judicial Department will no longer require 1.0 FTE to develop a training and contract with a training facilitator. Legislative Council Staff and JBC Staff agree on the change to the fiscal impact.

If the Committee adopts L.007, it should not adopt J.001.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$93.5 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$14.0 million).

This bill requires a General Fund appropriation of \$74,257 for FY 2024-25, reducing the \$93.5 million set aside by the same amount.

If sponsor amendment **L.007** is adopted, the bill has no General Fund impact.
