Current Appropriations Clause in Bill

The bill includes a capital construction appropriation clause that provides a total of \$4,183,931 cash funds for FY 2024-25, including \$2,250,000 cash funds from the State Museum Cash Fund to the Department of Higher Education for History Colorado, and \$1,933,931 cash funds from the Capital Construction Fund to the Department of Revenue. Of the \$2,250,000 cash funds appropriated to the Department of Higher Education, \$1,600,000 is reappropriated to the Department of Revenue.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).

This bill requires a General Fund transfer of \$1,933,931 for FY 2024-25, reducing the \$63.1 million set aside by the same amount.
