Summary of Legislation

The bill requires the State Library in the Colorado Department of Education (CDE) to expand on-demand news and information services to Coloradoans who are blind or print-disabled and to increase the awareness of such services.

Background

The CDE, through the State Library, provides funds to two external programs to provide reading services for the blind. This includes the Audio Information Network of Colorado (also called Aftersight), which provides on-the-air volunteer reading services through the internet, telephone, and podcasts; and the National Federation for the Blind for its Newsline service. Newsline is a free electronic service for blind and visually impaired individuals to access newspapers, magazines, and TV listings using a touch-tone telephone.

State Expenditures

The bill increases General Fund expenditures by an estimated \$200,000 per year in the CDE. This assumes the General Assembly will appropriate \$75,000 for the Aftersight program and \$125,000 for the National Federation for the Blind. The General Assembly has the discretion to set the amount appropriated to expand these services.

Other Budget Impacts

General Fund reserve. Under current law, an amount equal to 15 percent of General Fund appropriations must be set aside in the General Fund statutory reserve. Based on this fiscal note, the bill is expected to increase the amount of General Fund held in reserve by the amounts shown in Table 1, decreasing the amount of General Fund available for other purposes.

Effective Date

This bill was signed into law by the Governor and took effect on June 7, 2024.

State Appropriations

For FY 2024-25, the bill requires and includes an appropriation of \$200,000 from the General Fund to the Department of Education.
