HOW TO USE THIS DOCUMENT

The Department Overview contains a table summarizing the staff recommended incremental changes followed by brief explanations of each incremental change. A similar overview table is provided for each division, but the description of incremental changes is not repeated, since it is available under the Department Overview. More details about the incremental changes are provided in the sections following the Department Overview and the division summary tables.

Decision items, both department-requested items and staff-initiated items, are discussed either in the Decision Items Affecting Multiple Divisions or at the beginning of the most relevant division. Within a section, decision items are listed in the requested priority order, if applicable.

DEPARTMENT OVERVIEW

The Department of Natural Resources is responsible for developing, protecting, and enhancing Colorado's natural resources for the use and enjoyment of present and future residents and visitors. The Department is comprised of the following divisions:

- The **Executive Director's Office** (EDO) develops department-wide policies and provides administrative and technical support for Department divisions including: budgeting, accounting, financial management, human resources services, and the coordination of public information and environmental education. The EDO also houses the Colorado Avalanche Information Center (CAIC) that provides avalanche information, education and promotes research for the protection of life and property.
- The **Division of Parks and Wildlife** (CPW) provides recreational opportunities at 41 state parks, manages more than 960 game and non-game wildlife species, issues hunting and fishing licenses, enforces wildlife regulations, and administers more than 350 state wildlife areas.
- The **Colorado Water Conservation Board** (CWCB) works to conserve, develop, and protect the state's water resources to ensure adequate water supply, maximize beneficial use, and reduce the impact of flooding and drought.
- The **Division of Water Resources** (State Engineer's Office) administers and enforces water rights, issues well permits, monitors streamflow and water use, regulates dam construction and safety, and represents Colorado in interstate water compact proceedings.

The three remaining divisions (the Division of Reclamation, Mining, and Safety, the Oil and Gas Conservation Commission, and the State Board of Land Commissioners) were discussed in a separate staff briefing on February 20, 2019.

DESCRIPTION OF INCREMENTAL CHANGES

R1 INCREASE STATE PARKS SPENDING AUTHORITY: The recommendation includes an increase of \$3,661,298 cash funds from the Parks and Outdoor Recreation Cash Fund intended to cover increased operational costs associated with increased parks visitation and inflation that State Park Operations has experienced since FY 2009-10.

R2 ADDITIONAL STAFFING TO ADDRESS OIL AND GAS BACKLOGS: This recommendation was discussed during the JBC Staff briefing for the Department of Natural Resources held on February 20, 2019. The amount shown in this table represent the centrally appropriated costs associated with this request.

R3 WILDLIFE SMALL CAPITAL PROGRAM: The recommendation includes an increase of \$2,043,120 cash funds for FY 2019-20 from the Wildlife Cash Fund for the implementation of a Wildlife Small Capital Program to address health, fire, and safety issues and to enact minor repairs at the states 574 wildlife facilities.

R4 CAPITAL DEVELOPMENT RESOURCING: The recommendation includes an increase of \$319,986 cash funds and 3.0 FTE for FY 2019-20 for the Division of Parks and Wildlife's Capital Development Program. The additional resources will be used to increase staffing levels in three areas: dam operations and maintenance, central design, and regional field staff.

R5 CAMEO STATE RECREATION AREA RESOURCING: The recommendation includes an increase of \$303,941 cash funds and 3.0 FTE for FY 2019-20 from the Parks and Outdoor Recreation Cash Fund for staffing and operations at the new Cameo State Recreation Area (SRA) in Mesa County. The Division will hire a park manager, a technician, and an administrative assistant.

R6 INCREASE WILDLIFE COUNCIL SPENDING AUTHORITY: The recommendation includes an increase of \$1.1 million cash funds for FY 2019-20 from the Wildlife Management Public Education (WMPE) Fund for the Wildlife Council to expand its media-based education programs.

BA1 CAIC EQUIPMENT MAINTENANCE: The recommendation includes an increase of \$36,992 reappropriated funds and 0.4 FTE for FY 2019-20 for the maintenance of state-owned avalanche control equipment.

BA2 ADDITIONAL OIL AND GAS FIELD INSPECTORS AND SUPPORT STAFF: This recommendation was discussed during the JBC Staff briefing for the Department of Natural Resources held on February 20, 2019. The amount shown in this table represent the centrally appropriated costs associated with this request.

STAFF-INITIATED – VENDOR COMMISSIONS, FULFILLMENT FEES, AND CREDIT CARD FEES: The recommendation includes the creation of a new line item and an appropriation of \$14,555,758 cash funds for FY 2019-20 for the payment vendor commissions, fulfillment fees, and credit card fees realized by the Division of Parks and Wildlife from the sale of hunting and fishing licenses, parks passes, and the registration of outdoor recreational vehicles.

STAFF-INITIATED – FY 2020-21 LINE ITEM REORGANIZATION: The recommendation includes a net zero reorganization of several line items within the Division of Parks and Wildlife, the Colorado Water Conservation Board, and the Division of Water Resources. This recommendation takes effect beginning FY 2020-21

STAFF-INITIATED – UPDATE LINE ITEM TITLE: The recommendation includes updating the line item titles for two line items in the Division of Parks and Wildlife and one line item in the Colorado Water Conservation Board.

CENTRALLY APPROPRIATED LINE ITEMS: The recommendation includes adjustments to the following centrally appropriated line items. These items are addressed in separate staff briefings for the Department of Personnel and Administration and the Governor's Office.

INDIRECT COST ASSESSMENT ADJUSTMENT: The recommendation includes a decrease of \$419,192 total funds, including an increase of \$135,747 General Fund, to the Department's indirect cost assessments to its various divisions for FY 2019-20.

MAJOR DIFFERENCES FROM THE REQUEST

The major difference between the Department's request and staff recommendation is primarily attributable to staff's recommendation for the creation of a new line item to provide the Division of Parks and Wildlife with the required spending authority for their expenditures on commissions and fees associated with the sale of hunting and fishing licenses, parks passes, and recreational vehicle registrations. Please see staff's discussion of this issue on page 34.

DECISION ITEMS AFFECTING MULTIPLE DIVISIONS

→ R4 CAPITAL DEVELOPMENT RESOURCING

REQUEST: The Department requests an increase of \$401,653 cash funds and 3.0 FTE for the Division of Parks and Wildlife's Capital Development Program.

RECOMMENDATION: Staff recommends \$319,986 cash funds and 3.0 FTE for FY 2019-20. The recommendation is made based on JBC policy to not appropriate centrally appropriated costs (i.e., POTS) and to appropriate salaries at the minimum of the current year range for the job class.

ANALYSIS: The additional resources will be used to increase staffing levels in three areas: dam operations and maintenance, central design, and regional field staff. The Department assumes that each of the planned FTE will be engineers with project design and management experience. The additional staff will add capacity for project design and management, project implementation and construction, and ongoing safety inspections. The table below summarizes the recommendation and its annualization by personal services and operating expenses for FY 2019-20 and FY 2020-21.

The Department will assign one FTE to its central design office to assist with project design, coordination, and evaluation, as well as managing design consultants. This position will be based in the Department's Denver Headquarters, but will travel frequently. The primary focus of this position will be on CPW's hatcheries. There are 19 in the state that breed, hatch, rear, and stock over 90 million fish per year, and most of these facilities are 70-100 years old. With aging infrastructure, regular maintenance and replacement of components (e.g., water collection systems, pipelines, raceways, etc.) is necessary to ensure their continuing operation. Technological improvements and innovations in hatchery practices have been developed in the years since the construction of many of these facilities, which means they are antiquated and inefficient compared to newly constructed facilities. CPW is developing a plan to overhaul and modernize their entire hatchery system in order to meet the needs of the state's anglers and to continue efforts for the recovery of threatened and endangered aquatic species.

The Department will allocate one of the new FTE to dam operations and maintenance, which is responsible for statewide planning, monitoring, maintenance, and construction work on CPW's inventory of 110 dams. This position will be based in the Department's Denver Headquarters, but will travel frequently. The dams in CPW's inventory are fairly old, with most ranging in age from 50-100 years old. From FY 2016-17 through FY 2018-19, CPW funded and initiated 15 dam projects in state parks and wildlife areas at a cost of approximately \$27.8 million. These efforts have focused on those dams with the greatest need and those in the most critical areas. Despite this work, the Division's Dam Safety Program reports a maintenance and repair backlog of approximately \$44.8 million.

The remaining two FTE will be assigned to regional offices to help with project planning, design, and construction management. These positions will help in addressing the maintenance, rehabilitation, and general capital projects at the regional level. CPW is geographically dispersed across the whole state. As such, it employs a hub-and-spoke model for locating capital development staff. This request follows that model by splitting the requested engineer positions between its central and regional offices. The table below shows the capital development budget for CPW starting in FY 2016-17.

→ R5 CAMEO STATE RECREATION AREA RESOURCING

REQUEST: The Department requests an increase of \$351,025 cash funds and 3.0 FTE from the Parks Cash Fund for staffing and operations at the new Cameo State Recreation Area (SRA) in Mesa County, which provides shooting sports amenities.

RECOMMENDATION: Staff recommends \$303,941 cash funds and 3.0 FTE for FY 2019-20. The recommendation is made based on JBC policy to not appropriate centrally appropriated costs (i.e., POTS) and to appropriate salaries at the minimum of the current year range for the job class.

ANALYSIS: The Division will hire a park manager, a technician, and an administrative assistant. The park ranger will be responsible for over-all facility management and day-to-day operations; this

position will be a POST-certified law enforcement officer. The technician will be responsible for maintaining the facilities equipment, which will be specialized or relatively uncommon from the rest of the CPW system (e.g., clay target throwers). The administrative assistant will manage front-desk operations, including reservations, payments, tours and educational activities, and volunteer coordination. The additional staff will supplement and replace current CPW staff on temporary assignment to the Cameo SRA. The Cameo State Recreation Area has already hired a Shooting Range Program Manager. The table below summarizes the recommendation and its annualization by personal services and operating expenses for FY 2019-20 and FY 2020-21.

Temporary staff support is a common and essential aspect of CPW's business model. It allows facility managers to increase staffing during high volume periods, typically in the summer and fall, while being able to easily scale staffing levels back when no longer needed. The Division assumes that they will need 6,000 temporary staff hours at an hourly rate of \$12.00. Given that the Cameo SRA is a shooting range, staff training will be required to ensure that all those working and volunteering at this facility are properly informed of basic firearm safety and first aid.

The buildout of the Cameo SRA will take place over several years, perhaps even decades. Phase 1A of construction began in 2017, with the grand opening of the facility occurring August 25, 2018. Phase 1A built essential infrastructure (e.g., rifle and pistol bays, archery lanes, toilets, etc.) to ensure the facility could open. However, while the facility is open, it is operating at a limited capacity and there several more phase of construction to build it out. Phase 1B commenced in early FY 2018-19 and will add more basic amenities, such as: 3,000 linear feet of fencing, the placement and installation of 54 clay target throwers, shooting benches, and point of sale equipment. The Phase 1A budget is \$1.7 million and Phase 1B budget is \$1.6 million. Funding for these phases has been provided by local and federal grants. Future funding will likely be a mix of federal grants, Great Outdoors Colorado grants, and Colorado Lottery funds.

→ STAFF-INITIATED – UPDATE LINE ITEM TITLES

REQUEST: The Department did not request this action, but is supportive of staff's recommendation.

RECOMMENDATION: Staff recommends renaming the S.B. 08-226 Aquatic Nuisance Species line item to "Aquatic Nuisance Species Program." The Aquatic Nuisance Species Program has operated for over a decade and there have been a number of structural change to the program since its inception. Referencing the originating legislation in the line item title is no longer necessary.

Staff recommends renaming the S.B. 03-290 Enterprise Fund line item to "Stores Revolving Fund." The Stores Revolving Fund has operated for over a decade and is continuously appropriated, per Section 33-10-111.5 (4), C.R.S. The Fund is used to acquire and distribute supplies for retails sales to visitors of state parks. Any surplus in the Fund at the end of a fiscal year is transferred to the Parks and Outdoor Recreation Cash Fund. Referencing the originating legislation in the line item title is no longer necessary.

Staff recommends renaming the S.B. 02-87 Colorado Watershed Protection Fund line item to "Colorado Watershed Protection Fund." The Fund receives revenue from income tax checkoff that allows citizens to support local watershed efforts by making a voluntary contribution. The Fund is used to provide competitive grants to projects that restore and protect land and natural resources within watersheds in Colorado, as determined by the CWCB and the Water Quality Control Division in the Colorado Department of Public Health and Environment (CDPHE). Pursuant to Section 39-22-2403 (2)(b), C.R.S., the money in the Fund is continuously appropriated. Referencing the originating legislation in the line item title is no longer necessary.

\rightarrow Staff-initiated – FY 2020-21 line item reorganization

RECOMMENDATION: Staff recommends a net zero reorganization of several line items within the Division of Parks and Wildlife, the Colorado Water Conservation Board, and the Division of Water Resources. The intent of this reorganization is to locate line items in divisional subsections in a more intuitive manner. This reorganization would take effect beginning in FY 2020-2021. Staff also recommends a request for information asking the Department to report on the impact of the reorganization.

The reason for the delayed implementation is to give the Department and affected divisions sufficient lead time to make the necessary changes to their accounting tools and to minimize the impact on their ability to manage their various contracts. For example, the recommended reorganization would require the Division of Parks and Wildlife to replace and recode 19 major accounting codes in CORE. This type of change filters down through the various transactions and expenditures from each of the impacted line items. Allowing an additional fiscal year to implement this reorganization will give sufficient time to effectively and efficiently make the necessary changes.

The following line items in the Division of Parks and Wildlife will be moved from subsection (B) to subsection (A): Information Technology, Asset Maintenance and Repairs, Annual Depreciation-lease Equivalent Payments, and Indirect Cost Assessment. In the Colorado Water Conservation Board, the Indirect Cost Assessment line item will be moved from subsection (B) to subsection (A). In the Division of Water Resources, subsection (B) will be consolidated with subsection (A), eliminating the need for subsections.

(1) EXECUTIVE DIRECTOR'S OFFICE

The Executive Director's Office is responsible for the overall administration of the Department, including budgeting, accounting, financial management, human resources services, and other general administrative services. It provides leadership and support to Department divisions and programs in order to meet strategic objectives. The Executive Director's Office is comprised of two sub-sections: (A) Administration and (B) Special Programs. Pursuant to H.B. 13-1057, the Colorado Avalanche Information Center was added as the Special Programs subdivision following the transfer of the Colorado Geological Survey to the Colorado School of Mines.

DECISION ITEMS - EXECUTIVE DIRECTOR'S OFFICE

→ BA2 CAIC EQUIPMENT MAINTENANCE

REQUEST: The Department requests an increase of \$40,233 reappropriated funds and 0.4 FTE from the Department of Transportation (CDOT) for the Colorado Avalanche Information Center (CAIC) for FY 2019-20 to support maintenance efforts on state-owned avalanche control equipment.

RECOMMENDATION: Staff recommends \$36,992 reappropriated funds and 0.4 FTE for FY 2019-20.

ANALYSIS: The CAIC and CDOT have a long standing partnership on efforts to mitigate avalanche risk on the state highway system. Through this partnership, the two agencies monitor and maintain 278 of the approximate 522 known avalanche paths in Colorado.

One of the several tools used to mitigate the impact of avalanches is to trigger an avalanche intentionally using gas guns and military artillery, a method with inherent risk. Unfortunately, in 2014 that risk was realized when an explosive charge detonated prematurely in a gas gun, leaving two state employees with serious injuries. As a result of this incident, CAIC and CDOT immediately reviewed and changed their work procedures. One of the changes implemented was the introduction of remote avalanche control systems (RACS), which are permanent structures built on mountain hillsides above roadways that trigger avalanches remotely. CDOT has installed 32 RACS to date and anticipates adding an additional 12 in the next two years.

Maintenance on RACS includes shoring up the system's structure, refueling and recharging the triggering devices, and servicing the communications equipment. For the last two years, CDOT has relied on contractor support to conduct this maintenance, but these contractors are primarily located out of state or out of country. CDOT and CAIC would like to bring this work in-house for two primary reasons. First, response times for maintenance operations would be cut drastically using state employees because they are more local. Second, as CDOT builds out its RACS inventory, having the institutional capacity to conduct this work will allow CAIC to build its expertise in maintaining this vital infrastructure. CAIC will utilize its current workforce to cover the additional work, which is conducted during the summer months when their staffing load is reduced. The table below summarizes the recommendation and its annualization by personal services and operating expenses for FY 2019-20 and FY 2020-21.

(B) SPECIAL PROGRAMS

COLORADO AVALANCHE INFORMATION CENTER PROGRAM COSTS

The Colorado Avalanche Information Center (CAIC) works to minimize the economic and human impact of snow avalanches on recreation, tourism, commerce, industry, and the citizens of Colorado by providing information and education on avalanche danger. The CAIC is responsible for forecasting avalanche danger and providing education and safety training to help reduce risks to highway travelers, Colorado Department of Transportation (CDOT) staff, recreationalists, and avalanche professionals. Approximately 48.0 percent of the funding for this program comes from cash funds, including fees, donations, and appropriations from Tier I of the Severance Tax Operational Fund. About 50.0 percent of program funding comes from CDOT as reappropriated funds with a small amount of federal funding from the U.S. Forest Service accounting for the remainder.

STATUTORY AUTHORITY: Sections 24-1-124 (2.1) (c) and 24-33-116, C.R.S.

REQUEST: The Department requests an appropriation of \$1,148,187 total funds, including \$478,101 cash funds, \$651,115 reappropriated funds, and \$18,971 federal funds, and 11.3 FTE for FY 2019-20.

RECOMMENDATION: Staff recommends \$1,148,011 total funds, including \$478,101 cash funds, \$650,939 reappropriated, \$18,971 federal funds, and 11.3 FTE for FY 2019-20. This includes staff's recommendation for BA1.

(5) DIVISION OF PARKS AND WILDLIFE

The Division of Parks and Wildlife (CPW) provides recreational opportunities at 42 state parks, manages 960 game and non-game wildlife species, issues hunting and fishing licenses, enforces wildlife regulations, and oversees more than 295 state wildlife areas. CPW is the product of a merger between the Division of Parks and Outdoor Recreation and the Division of Wildlife approved by the General Assembly in S.B. 11-208. The goal of the merger was to provide costs savings in response to a declining fund balance of the Wildlife Cash Fund. The Department requested a reduction of \$1.6 million cash funds and 20.0 FTE related to the merger in FY 2013-14, and the JBC approved a reorganization of the CPW Long Bill in FY 2014-15 to more accurately reflect the postmerger structure of the division.

DECISION ITEMS - DIVISION OF PARKS AND WILDLIFE

(1) DIVISION OF PARKS AND WILDLIFE FINANCIAL SUSTAINABILITY

Pursuant to Section 33-9-105 (1), C.R.S., the Division of Parks and Wildlife and the Parks and Wildlife Commission are established as an enterprise for the purposes of Section 20 of Article X of the State Constitution. As such, CPW can receive no more than 10.0 percent "of its total annual

revenues" from both state and local governments. In the FY 2018-17 Long Bill, the Division was appropriated \$150,000 General Fund, well below the statutory and constitutional threshold. To generate revenue, CPW assesses fees for hunting and fishing licenses, the registration of recreational vehicles, and for entry into state parks and wildlife areas. These fees, particularly those for hunting and fishing licenses are set in statute, primarily in Section 33-4-102 (1), (1.4), and (2), C.R.S.

Overall, CPW revenue has increased by 7.5 percent from FY 2014-15 to FY 2017-18. In the same period, expenditures have increased by 1.5 percent. The increase in revenue is primarily driven by population growth and an increase in the use of the State's outdoor recreational resources by residents and visitors. Expenditures have risen slowly primarily due to efforts by CPW to control costs. In the last 10 years, CPW has reduced wildlife expenditures by approximately \$40 million through a reduction of almost 60.0 FTE, the reduction or elimination of targeted programs, park closures, and deferring capital projects and maintenance.

CPW FINANCIAL SUSTAINABILITY

During the 2018 legislative session, the General Assembly passed and the Governor signed S.B. 18-143 (Hunting, Fishing, and Parks for Future Generations Act). This bill, which addresses many aspects of CPW's operations, increased fees for CPW for certain hunting and fishing licenses and park passes. The Division is now required to ensure individuals entering state parks by means other than motor vehicle purchase an entrance pass. The bill allows the Parks and Wildlife Commission to apply a the Denver-Aurora-Lakewood consumer price index for any fee or surcharge increase, per Section 33-4-102 (1.6)(b), C.R.S., which the Commission will consider beginning in 2020. The Division is required to submit an annual report on the impact of fee and surcharge increases starting to its committees of reference in the General Assembly starting November 1, 2019.

The Parks and Wildlife Commission, on November 15, 2018, approved the increase of license, camping, and park fees to the statutory maximum. Most resident wildlife license fees have been increased by \$8.00. The Commission also approved the creation of a new \$8.00 resident youth fishing license for persons age 16 and 17 years old. The Commission approved modest price increases for daily and annual park passes, with the largest increase being a \$10 increase for annual vehicle affixed park passes. A new annual hang tag park pass, which is issued to individuals instead of vehicles, was created by the Commission and will cost \$120. Additionally, the Commission changed the camping fee structure by eliminating the reservation fee charged for camping permits,

choosing to increase the base price of campsites statewide; the price increase is \$8-\$13, depending of the campsite.¹

The Final Fiscal Note for S.B. 18-143, published on August 15, 2018, estimates that the increases to fees will increase CPW revenue by approximately \$19.4 million in FY 2019-20. It is in this context of a substantial revenue increase that the Department and CPW have submitted five decisions items for cash fund spending authority increases to the Joint Budget Committee for its consideration.

→ R1 INCREASE STATE PARKS SPENDING AUTHORITY

REQUEST: The Department is requesting a net increase of \$3,661,298 cash funds, including an increase of \$5,036,298 cash funds from the Parks and Outdoor Recreation (Parks) Cash Fund and a decrease of \$1,375,000 cash funds from the Wildlife Cash Fund, in FY 2019-20.

RECOMMENDATION: Staff recommends approval of the request.

ANALYSIS: The Department's requested decrease from the Wildlife Cash Fund is a result of a rebalance of the cost allocation methodology used by CPW to split centralized expenses that are not exclusive to either the State Park or Wildlife. This rebalance calls for a greater share of these expenses to be covered by the Parks Cash Fund than are currently covered. The additional \$3,661,298 increase from the Parks Cash Fund is intended to cover increased operational costs associated with parks visitation and inflation since FY 2009-10.

The table below shows the 10-year appropriation history for the State Park Operations line item, which has not kept pace with inflation. From FY 2009-10 to FY 2018-19, inflation adjusted appropriations show a decrease of \$5.6 million in general purchasing power. As a result, to maintain operations within the current level of spending authority, CPW has reprioritize and utilized non-appropriated funding (e.g., lottery money and federal funds) to balance expenditures and revenue; intra-agency and inter-fund transfers have totaled \$39.7 million since FY 2015-16.

The Department reports that operational expenditures (i.e., expenses other than personal services) out of the State Park Operations line item have increased from \$10.0 million in FY 2009-10 to \$14.3 million in FY 2017-18, the last full fiscal year. In the same time period, park visitation has increased

by 24.6 percent, from 12.3 million visits to 15.3 million visits. The Department uses park visitation as an indicator of how expenditures will trend because park operations will need to account for the costs associated with increases or decreases in utilization. The increase in operational expenditures and park visitations were used by CPW and the Department in assessing their FY 2019-20 anticipated expenditures. They assert that the requested \$5.0 million increase in cash fund spending authority will be sufficient for their operational needs.

CPW conducted a cost allocation methodology analysis this year to determine the correct split of centralized costs between State Park and Wildlife operations. The current cost allocation methodology was implemented in FY 2013-14 after the merger of the Division of Parks and Outdoor Recreation and the Division of Wildlife was completed. This methodology splits centralized costs assuming that 75.0 percent of the costs are associated with Wildlife operations and 25.0 percent are for Parks operations. As a result of the 2018 analysis, the new methodology indicates a 65:35 ratio of Wildlife to Parks cost allocations. This new ratio is the basis for the Department's request to shift \$1,375,000 cash fund spending authority from the Wildlife Operations line item to the State Parks Operations line item.

→ R3 WILDLIFE SMALL CAPITAL PROGRAM

REQUEST: The Department requests an increase of \$2,043,120 cash funds from the Wildlife Cash Fund for the implementation of a Wildlife Small Capital (WSC) Program to address health, fire, and safety issues and to enact minor repairs at the states 574 wildlife facilities. The request also includes a \$350,000 transfer of cash fund spending authority from the Wildlife Operations line item to the Asset Maintenance and Repairs line item, which will fund the WSC Program.

RECOMMENDATION: Staff recommends approval of the request.

ANALYSIS: The WSC Program, which is in its first year, is a companion to a similar program designed to focus on State Parks small capital projects that has operated for about 15 years and addressed about 120 projects per year. The Program is currently funded through various sources of appropriated and non-appropriated funds. The Program's FY 2018-19 budget is approximately \$3.2 million, including a \$2.0 million Great Outdoors Colorado (GOCO) grant, about \$1.1 million appropriated cash funds, and \$135,120 federal funds. The Department is requesting that the WSC Program be funded through the Asset Maintenance and Repairs line item in FY 2019-20 with only Wildlife Cash Fund money.

Program spending is spread across six allocation categories based on existing capital assets. Hatcheries, of which there are 19 in the state that breed, hatch, rear, and stock over 90 million fish

per year, account for the highest allocation (30.8 percent) of the WCS Program's FY 2018-19 budget. Each region receives a roughly equal share, with the variance attributable to the number of Wildlife Areas and capital assets in each region. The smallest portion of the budget goes to Administration, which includes projects such as building and grounds maintenance, fencing and animal facility upgrades, and equipment purchases. The Administration category includes the Denver Headquarters, the Foothills Wildlife Research Center, the Aquatic Toxicology Lab, the Parvin Lake Research Center, and the Bellvue Fish Research Hatchery. The Department anticipates a similar budget allocation in FY 2019-20 and are in the processes of evaluating projects for the upcoming fiscal year.

Project work will be absorbed by existing staff at the Wildlife Areas and regional offices. Each administrative regional office has at least one staff member dedicated to capital development and maintenance. The projects are generally small in scope and can be completed by Wildlife Area staff members. For those projects that require contractors, area staff provide oversight. The Division has developed internal guidance for the types of projects that are allowed under the WSC Program. Personal services costs and operational costs, such as travel and utilities, are excluded from the Program.

→ R6 INCREASE WILDLIFE COUNCIL SPENDING AUTHORITY

REQUEST: The Department requests an increase of \$1.1 million cash funds from the Wildlife Management Public Education (WMPE) Fund (Section 33-1-112 (3.5)(a), C.R.S.) for the Wildlife Council to expand its media-based education programs.

RECOMMENDATION: Staff recommends approval of the request.

ANALYSIS: The Wildlife Council, created in 1998 and authorized by Section 33-4-102, C.R.S., is tasked with designing a "comprehensive media-based public information program" that educates the public about the "benefits of wildlife, wildlife management, and wildlife-related recreational opportunities in Colorado, specifically hunting and fishing." Perhaps the most well-known of the Council's outreach campaigns is the "Hug a Hunter/Hug an Angler" campaign that is designed to demonstrate that sportspersons and non-sportspersons share the same concerns for Colorado's wildlife resources.

The FY 2018-19 Long Bill (H.B. 18-1322) appropriates \$1.1 million in cash fund spending authority from the WMPE Fund to the Wildlife Operations line item for expenditures by the Council. This request would double that appropriation to \$2.2 million cash funds. The WMPE Fund receives revenue from a \$0.75 surcharge on each hunting and fishing license sold in the state. This surcharge will increase to \$1.50 beginning January 1, 2019, due to the enactment of S.B. 18-143 and approval

by the Parks and Wildlife Commission. Since FY 2012-13, this surcharge has generated an estimated \$7.7 million, though it should be noted that the FY 2019-20 revenue shown in the table below is underestimated due to the upcoming surcharge increase. The Council maintains a \$400,000 reserve fund balance. The fund is exempt from the uncommitted fee reserve balance pursuant to Section 24-75-402 (5)(c), C.R.S., because the surcharge is set by the Parks and Wildlife Commission which is an enterprise.

The Council has, in recent years, experienced cost increases in both traditional and digital advertising. Traditional advertising includes broadcast television, radio, and "out-of-home" media (e.g., billboards, bus shelters, etc.). These advertising methods have experienced an across the board cost increase since 2010. Measured in cost per point (CPP), a ratio based on how much it costs to buy one rating point, the inflation adjusted CPP has increase by a range of 28.6 percent to 96.8 percent, depending on the segment type. As a result, the Council has limited its Hug a Hunter/Hug an Angler campaign to two 8-week time frames, running ads exclusively on broadcast television.

Digital media has become the preferred way consumers get their information and the Council has allocated more paid media funds to digital platforms in an effort to keep pace. Digital media advertising cost are increasing due to the demand for such tools, but there is also attendant backend costs. The digital media industry is experiencing cost increases in order to ensure advertisements are serving in brand safe environments, not being clicked on by bot fraud, and are using the highest quality data to ensure accurate audience targeting. All these factors are driving a cost increase in digital media advertising.

The requested \$1.1 million cash fund spending authority increase will allow the Wildlife Council to increase its media placements, allocate a greater share of its revenue to creative production, and to conduct more research and planning to ensure its message is compelling and resonates with the target audience. With more money for creative production, the Council will be able to diversify its campaign material and to tailor its work products to specific media platforms. Audiences are more

interested and engaged when the same message is presented in different manners and using different methods. Increased spending on research and planning will allow the Council to double the sample size, from 400 to 800 individuals, used for tracking studies that assess the effectiveness of their campaigns.

→ STAFF-INITIATED – VENDOR COMMISSIONS, FULFILLMENT FEES, AND CREDIT CARD FEES

REQUEST: The Department did not request this action, but is supportive of staff's recommendation.

RECOMMENDATION: Staff recommends the creation of a new line item in the (A) Parks and Wildlife Operations subsection of the Division of Parks and Wildlife and appropriating \$14,555,758 cash funds for FY 2019-20. The line item will be titled "Vendor Commissions, Fulfillment Fees, and Credit Card Fees."

ANALYSIS: In 2018, the Division of Parks and Wildlife implemented a new online system to manage the sale of hunting and fishing licenses and park passes through a third party vendor. The system, called IPAWS, is designed to manage both online sales and point-of-contact sales made at a Division office or agent location. The vendor developed the software and other system components at no cost, in exchange for a commission charged on the sale of licenses and pass. Independent of the commission paid to the vendor, the Division also incurs credit card fees and fulfillment fees for many license and pass sales.

Prior to FY 2017-18, the State Controller allowed the Division of Parks and Wildlife to book their over-expenditures associated with vendor commissions and credit card fees against "inferred non-appropriated spending authority," a phrase used by the Department that has no statutory definition. Beginning in FY 2017-18, the State Controller no longer allowed this practice because it was in contradiction of accounting best practices. As a result, the Division does not have the appropriated spending authority to cover their vendor commissions and credit card fees. This issue primarily impacts five cash funds, they are the:

- Parks and Outdoor Recreation Cash Fund, Section 33-10-111 (1), C.R.S.;
- Wildlife Cash Fund, Section 33-1-112 (1)(a), C.R.S.;
- Division of Parks and Wildlife Aquatic Nuisance Species Fund, Section 33-10.5-108 (1)(a)(I), C.R.S.;
- Snowmobile Recreation Fund, Section 33-14-106, C.R.S.; and
- Off-highway Vehicle Recreation Fund, Section 33-14.5-106 (1), C.R.S.

Vendor commissions are established in the contract between the online sales systems vendor and the Parks and Wildlife Commission. The underlying commission rate structure established in the contract is a percentage of the cost of a product (3.7 percent) below \$100 or a flat fee (\$4.25) for products that cost over \$100. The Parks and Wildlife Commission also sets the commission rates for retail agents, with a 4.75 percent commission on hunting and fishing licenses and a 5.0 percent commission on park passes. A retail agent is defined by Commission regulations as "a business which sells Division products for the Division from its retail store or other location of record." The vendor commissions and retail agent commissions are separate expenditures. In addition to these commissions, the Division is also assessed a 2.2 percent credit card fee and a \$1.45 fulfillment fee per transaction.

The current reporting capabilities of IPAWS are focused on reconciling revenue and are not yet developed for forecasting at a granular level of detail (i.e. individual transaction fees). The Division continues to work with the vendor and may have more refined commission expenditure projections in future fiscal years. While trend analysis based on the current data is challenging, the Division has provided an estimate of their commission and fees expenditures in order to establish a baseline for the necessary spending authority. At staff's direction, the Division added an additional 10.0 percent buffer to their anticipated expenditures. This buffer is intended to mitigate the uncertain nature of the following estimates.

The estimates provided in the above table are meant to establish an appropriations baseline for FY 2019-20. The Department does not require similar appropriations in FY 2017-18 or FY 2018-19, so staff is not recommending prior year adjustments. Staff anticipates out-year technical adjustments to this appropriation as the volume and types of Division products that are sold through IPAWS grows. However, when the current contract for IPAWS expires or if there is are significant changes to the commission rate and fees structures, staff expects the Division to submit a decision item for adjustments to this line item's appropriation.

LINE ITEM DETAIL - DIVISION OF PARKS AND WILDLIFE

(A) COLORADO PARKS AND WILDLIFE OPERATIONS

STATE PARK OPERATIONS

The State Park Operations line item funds the ongoing operations and administrative staff at all state parks and central offices. This includes personal services, operating expenses, and utility expenses, as well as a seasonal work program that enables CPW to hire temporary staff to assist at state parks during the busy season. Most of the funding for this line item is from the Parks and Outdoor Recreation Cash Fund, which is predominantly supported by revenue from fees, passes, and registrations. Other sources of funding include Lottery proceeds and grants from the Great Outdoors Colorado (GOCO) program, both informational, and Tier I of the Severance Tax Operational Fund. State Parks also receives \$150,000 General Fund to offset the cost of providing free admission to state parks and recreation areas for veterans in the month of August (H.B. 15-1045 Veterans Entrance Fee State Parks).

STATUTORY AUTHORITY: Sections 33-10-101 to 33-13-116, C.R.S., and Section 33-60-101 et seq., C.R.S.

REQUEST: The Department requests an appropriation of \$36,897,982 total funds, including \$150,000 General Fund, \$36,303,176 cash funds, and \$444,806 federal funds, and 260.1 FTE for FY 2019-20.

RECOMMENDATION: **Staff recommends \$36,876,174 total funds**, including \$150,000 General Fund, \$36,281,368, and \$444,806 federal funds, and 260.1 FTE for FY 2019-20. This includes staff's recommendations for R1, R4, and R5 requests, and the annualization of prior year salary survey and S.B. 18-200 (PERA).

WILDLIFE OPERATIONS

This line item was established in FY 2014-15 to better reflect division operations after the S.B. 11-208 merger of the Division of Parks and Outdoor Recreation and the Division of Wildlife. It combines the functions of the following line items from the prior Long Bill structure:

- 1. *Director's Office*, with responsibility for the overall management and oversight of wildlife activities including policy development and implementation, budgeting, program evaluation, and grant administration;
- 2. *Wildlife Management*, which manages hunting and fishing opportunities, maintains healthy wildlife populations, preserves and enhances wildlife habitat, and engages in public awareness and educational outreach programs; and
- 3. *Technical Services*, which provides administrative support, engineering services to manage and maintain capital construction projects, and facilities management for Wildlife programs.

The line item accounts for a significant number of programs, projects, and responsibilities that were covered under each of the former Wildlife subdivision line items. Programs supporting the main activities of the former Wildlife Management line item include, but are not limited to, customer service, wildlife conservation, research, aquatic conservation, law enforcement, and CPW's regional

activities (such as energy extraction impacts on wildlife habitats). Administrative responsibilities from the former Technical Services line item include accounting and cash management, contracting, procurement, labor data collection, license services, human resources, and legal services. The Engineering Services component includes designing and managing capital construction projects. Facilities management included the maintenance of administrative facilities (offices and customer service centers) and the operation of the Division's vehicle fleet. Each of these functions is now accounted for under the new Wildlife Operations line item.

STATUTORY AUTHORITY: Sections 31-1-101 to 33-6-101 et seq., C.R.S.

REQUEST: The Department requests an appropriation of \$84,402,704 total funds, including \$65,228,021 cash funds and \$19,174,683 federal funds, and 621.6 FTE for FY 2019-20.

RECOMMENDATION: Staff recommends \$84,377,714 total funds, including \$65,203,031 cash funds and \$19,174,683 federal funds, and 621.6 FTE for FY 2019-20. This includes staff's recommendations for R1, R3, R4, and R6 requests, and the annualization of prior year salary survey and S.B. 18-200 (PERA).

VENDOR COMMISSIONS, FULFILLMENT FEES, AND CREDIT CARD FEES (NEW LINE ITEM)

This line item provides funding for vendor commissions, fulfillment fees, and credit card fees associated with the sale of hunting and fishing licenses, park passes, and recreational vehicle registration (e.g., snowmobiles, boats, etc.).

STATUTORY AUTHORITY: Sections 33-10-101 to 33-13-116, C.R.S., Sections 31-1-101 to 33-6-101 et seq., C.R.S., Section 33-14-102, C.R.S., Section 33-14.5-106, C.R.S., and Section 33-60-101 et seq., C.R.S.

REQUEST: The Department did not request the creation of this line item, but is supportive of staff's recommendation.

RECOMMENDATION: Staff recommends the creation of this line item and an appropriation of \$14,555,758 cash funds for FY 2019-20, in accordance with staff's recommendations on page 34.

(B) SPECIAL PURPOSE

Line items in this subdivision support programs that have a dedicated funding source or are related to federal programs that do not directly pertain to the operations of the Colorado parks system or wildlife programs.

SNOWMOBILE PROGRAM

This line item provides funding for the Snowmobile Program, which is responsible for the registration of snowmobiles, mandatory safety certification of young operators, enforcement of registration requirements, trail marking and signing, establishment and maintenance of snowmobile trails and related facilities. The source of funds is the Snowmobile Recreation Fund, established pursuant to Section 33-14-106, C.R.S. to receive fees from the registration of snowmobiles.

STATUTORY AUTHORITY: Section 33-14-102, C.R.S.

REQUEST: The Department requests an appropriation of \$1,015,295 cash funds and 1.3 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA).

RECOMMENDATION: Staff recommends approving the request.

RIVER OUTFITTERS REGULATION

The River Outfitter Licensing (ROL) Program is now incorporated as part of the CPW Boating Program, which is comprised of three state parks programs that were combined during the merger. The ROL Program is responsible for the administration of the annual licensing for river outfitters, regulation of the river outfitters, and ensuring the safety of river running activities through inspections. This program performs inspections on these companies to ensure river outfitters employ qualified personnel, follow appropriate operating parameters and meet minimum equipment standards to ensure customer safety. Funding comes from registration and licensing fee revenue from river outfitters credited to the River Outfitters Cash Fund established pursuant to Section 33-32-111, C.R.S.

STATUTORY AUTHORITY: Section 33-32-103, C.R.S.

REQUEST: The Department requests an appropriation of \$150,541 cash funds and 0.5 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA).

RECOMMENDATION: Staff recommends approving the request.

OFF-HIGHWAY VEHICLE PROGRAM SUPPORT

This line item funds the administrative costs of the Off-Highway Vehicle (OHV) Program, which is responsible for the administration of OHV registration and grants. The program provides promotes the availability of OHV recreational opportunities, and encourages safe and responsible use through brochures, news releases and other media. The program is also responsible for OHV safety awareness through the promulgation and enforcement of rules and regulations. Partnerships with land management agencies and enthusiasts are formed to leverage grant funds and promote good management of motorized recreation. Funding is from OHV registration fees credited to the Off-Highway Vehicle Recreation Fund.

STATUTORY AUTHORITY: Section 33-14.5-106, C.R.S.

REQUEST: The Department requests an appropriation of \$570,631 cash funds and 3.0 FTE for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request.

OFF-HIGHWAY VEHICLE DIRECT SERVICES

This line item supports direct services provided by the OHV Program including activities and expenses associated with law enforcement, capital equipment, rescue and first aid equipment, off-highway vehicle facilities, and division and contract services related to clearing parking lots and providing trail maintenance. This is mostly in the form of grants to federal, state, and local government agencies and non-profit user groups to construct and maintain off-highway vehicle trails, parking areas, signage and maps. Funding is from off-highway vehicle registrations collected in the Off-Highway Vehicle Registration Fund. This line item was added during FY 2010-11 as part of a capital construction budget reorganization that moved part of the capital construction budget into the operating budget. As part of this line item, the Committee approved a footnote that authorized three year spending authority and to account for projects that require more than a year of funding to complete.

STATUTORY AUTHORITY: Section 33-14.5-106, C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$4,000,000 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request.

FEDERAL GRANTS

The Department anticipates the receipt of federal funds related to this line item, which reflects a grant from the United States Coast Guard to fund a portion of the requirements of the federal Boat

Safety Act. These moneys are shown for informational purposes only. Half of this money is distributed to local governments and the other half funds state sponsored projects. The Parks and Wildlife Board evaluates the proposals and distributes the funds.

STATUTORY AUTHORITY: Section 33-13-101, C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$750,000 federal funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request. This funding is from a federal grant and is included in the Long Bill for informational purposes only.

S.B. 03-290 ENTERPRISE FUND (NEW TITLE: STORES REVOLVING FUND)

This line item appropriates money into the Stores Revolving Fund, which was established pursuant to S.B. 03-290. This fund is used for the acquisition of warehousing stock and distributing supplies for retail sales to park visitors. At the end of every fiscal year, any fund balance exceeding \$200,000 reverts back to the Parks Cash Fund. The Stores Revolving Fund is continuously appropriated and this appropriation is for informational purposes only.

STATUTORY AUTHORITY: Section 33-10-111.5 (4), C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$200,000 cash funds for FY 2019-20.

INFORMATION TECHNOLOGY

This line item supports communications infrastructure, connectivity at Parks and Wildlife properties, asset management, user support, standardized software applications, internet oversight, development of information technology policies and plans, and the development and maintenance of business

applications. The current line item combined duplicate line items within in the former Parks and Outdoor Recreation and Wildlife subdivisions in the old Long Bill structure.

STATUTORY AUTHORITY: Section 33-10-109, C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$2,605,016 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approval of the request.

TRAILS GRANTS

The Trails Grants line item was added during FY 2010-11 as part of a capital construction budget reorganization that moved part of the capital construction budget into the operating budget. This program provides technical assistance and training on trail design, development, and maintenance to agencies, communities, and non-profit groups statewide. It provides public information on trails through maps, newsletters, and electronic media. The Trails program also encourages Youth Corp trail projects, volunteerism and public stewardship for trails on public lands. Grants are made to third parties and the work does not result in a physical asset owned by the state. Cash funds in this line item come from Great Outdoors Colorado (GOCO) and lottery proceeds and are shown in the Long Bill for informational purposes only.

STATUTORY AUTHORITY: Sections 33-60-104 (1) (b) and 33-60-104 (1) (c), C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$2,200,000 total funds, including \$1,800,000 cash funds and \$400,000 federal funds, for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request. This funding consists of continuously-appropriated cash funds and a federal grant and is included in the Long Bill for informational purposes only.

S.B. 08-226 Aquatic Nuisance Species (New Title: Aquatic Nuisance Species Program)

The Aquatic Nuisance Species Program was established in by S.B. 08-226 (Aquatic Nuisance Species Prohibition) to prevent, control, contain, monitor and eradicate ANS, both wildlife and plants, from state waters. The program coordinates a network of state, federal, local, and private watercraft inspection and decontamination stations. Watercraft on trailers are required to be inspected for ANS and decontaminated, if needed, prior to entering Colorado waters. House Bill 18-1008 (Mussel-free Colorado Act) created an Aquatic Nuisance Species stamp to be purchased by boaters in the State, which will provide a revenue stream for the Aquatic Nuisance Species Program that will partially cover expenses. Pursuant to Section 33-10.5-108 (1)(a)(I), C.R.S., the Division of Parks and Wildlife Aquatic Nuisance Species Fund (ANS Fund) is granted continuous spending authority for all money in the Fund.

STATUTORY AUTHORITY: Sections 33-10.5-101 to 33-10.5-108, C.R.S.

REQUEST: The Department requests an appropriation of \$3,916,497 cash funds and 4.0 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA).

RECOMMENDATION: Staff recommends approving the request. This funding consists of continuously-appropriated cash funds and is included in the Long Bill for informational purposes only.

GAME DAMAGE CLAIMS AND PREVENTION

The Game Damage program is a prevention and reimbursement program that compensates ranchers, farmers, and landowners for damage caused by big game animals. This line item also includes funds for the purchase of fencing, pyrotechnics and other materials provided to landowners to prevent damage (and potential CPW liability) to standing and harvested crops, forage, and other

property. Approximately half of the expenditures for this line item are for game damage prevention and the other half is for claims. However, spending on claims is unpredictable and dependent upon a myriad of factors, including the weather.

STATUTORY AUTHORITY: Sections 33-3-101 et seq., C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$1,282,500 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request.

HABITAT PARTNERSHIP PROGRAM

The Habitat Partnership Program is managed through 19 local committees and a state council, for the purpose of reducing wildlife conflicts, especially those related to forage and fencing issues. Local committees develop big game distribution management plans designed to minimize such wildlife conflicts. This line item funds fencing projects and performs various habitat improvement projects designed to meet game management objectives and to keep big game off of private property. Pursuant to Section 33-1-112 (8) (e), C.R.S., the program is funded by an annual transfer of 5.0 percent of the net sales of big game hunting licenses used in geographic locations represented by a Habitat Partnership Committee. Moneys in the Habitat Partnership Cash Fund are continuously appropriated and included in the Long Bill for informational purposes only.

STATUTORY AUTHORITY: Sections 33-1-110 et seq., and 33-1-112 (8) (a) to 33-1-112 (e), C.R.S.

REQUEST: The Department requests an appropriation of \$2,517,245 cash funds and 3.0 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA).

GRANTS AND HABITAT PARTNERSHIPS

This line item, formerly in the Capital Construction budget, contains projects related to (1) grants for habitat improvement on private property under the Pheasant Habitat Partnership Program; (2) small habitat improvement projects on State Wildlife Areas that cost less than \$50,000 each and are more appropriately categorized as operating expenses; and (3) grants for improvements, repairs and development for wetlands and shooting ranges. Appropriations under this line item are available for three years, as authorized in a Long Bill footnote.

STATUTORY AUTHORITY: Sections 33-3-101 et seq., C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$1,625,000 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request and continuing the Long Bill footnote associated with this line item.

ASSET MAINTENANCE AND REPAIRS

This line item is the product of the FY 2014-15 consolidation of two line items with similar functions, one from each of the former Parks and Wildlife subdivisions. The original line items were transferred from the Capital Construction budget in FY 2010-11. The appropriation provides funding for controlled maintenance projects that are generally under \$50,000. Typical projects include weed spraying, roof repairs, shoreline stabilization, repairs to water and sewer lines, road and parking lot repairs, and ADA compliance updates. Appropriations under this line item are available for three years, as authorized in the Long Bill footnote included below.

STATUTORY AUTHORITY: Sections 33-3-101 et seq., and 24-75-112, C.R.S.

REQUEST: The Department requests an appropriation of \$5,100,000 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request and the continuation of the footnote associated with this line item. This includes staff's recommendation for the R3 request.

BEAVER PARK DAM REPAYMENT

This line item was moved from the capital construction budget to CPW's operating budget in FY 2015-16. It provides spending authority for CPW to repay the Colorado Water Conservation Board for a \$10 million loan for improvements to the dam at Beaver Park Reservoir. This zero interest loan is being repaid at \$333,333 per year for 30 years.

STATUTORY AUTHORITY: Section 39-29-109 (2) (a) (X), C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$333,333 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request, as it is consistent with the terms of the agreement between CPW and the CWCB regarding the repayment of the loan.

CHATFIELD REALLOCATION REPAYMENT

This line item was added to the CPW's operating budget in FY 2017-18. It provides spending authority for CPW to repay the Colorado Water Conservation Board for a \$6.5 million interest-free 30 year loan. The loan agreement obligates CPW to repay \$216,829 to CWCB annually for 30 years, beginning in FY 2017-18.

STATUTORY AUTHORITY: Sections 37-60-120.1 and 37-60-122 (1) (b), C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$276,700 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request.

INDIRECT COST ASSESSMENT

This line item reflects indirect cost assessments to cash and federal funds within the Division of Parks and Wildlife. The Department uses indirect cost recoveries to offset General Fund that would otherwise be required to pay for services from the Executive Director's Office.

REQUEST: The Department requests an appropriation of \$4,527,546 total funds, including \$3,826,037 cash funds and \$701,509 federal funds, for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request, but requests permission to adjust this amount as necessary once the Committee has finalized all common policies for FY 2019-20.

(6) COLORADO WATER CONSERVATION BOARD

The Colorado Water Conservation Board (CWCB) was created in 1937 with a mission to conserve, develop, protect, and manage Colorado's water for present and future generations. Section 37-60-104 (1), C.R.S., defines the requirement of the 15-member Board of Directors and Section 37-60-106, C.R.S., describes the duties of those board members "to promote the conservation of the waters of the state of Colorado in order to secure the greatest utilization of such waters and the utmost prevention of floods."

The CWCB has access to two large cash fund accounts, the CWCB Construction Fund and the Severance Tax Perpetual Base Fund, to provide loans and grants for projects that will increase the beneficial consumptive use of Colorado's undeveloped compact entitled waters.

(B) SPECIAL PURPOSE

INTRASTATE WATER MANAGEMENT AND DEVELOPMENT

This line item was added to the Long Bill in the 2006 session with the approval of the Department's decision item for a Statewide Water Supply Initiative (SWSI) and provides the CWCB with funding for an on-going basin-by-basin analysis. The objective of the SWSI is to help Colorado maintain an adequate water supply for its citizens and the environment.

STATUTORY AUTHORITY: Articles 60 to 69 of Title 37, C.R.S.

REQUEST: The Department requests a continuation-level appropriation \$470,464 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request.

FEDERAL EMERGENCY MANAGEMENT ASSISTANCE

This is a federally-funded program that provides flood plain mapping and information about flood prevention. This line item supports 2.0 FTE for the Map Modernization Coordinator and the State Coordinator for the National Flood Insurance Program (NFIP). The Map Modernization Coordinator is responsible for the management of the Map Modernization Program and ensuring high quality mapping products. The State Coordinator for NFIP is responsible for performance measurement, community assistance visits, ordinance assistance, community information system, floodplain mitigation strategies, education and outreach, technical assistance, Community Rating System (CRS) support, mapping coordination assistance, intra- and inter-state coordination, and other related activities. The position also serves as the State Hazard Mitigation Officer in the event of a federally declared flood disasters, and has a primary responsibility as the CWCB representative within Disaster Field Offices when they become active.

STATUTORY AUTHORITY: Section 37-60-121 (3) (b), C.R.S.

REQUEST: The Department requests an appropriation of \$165,912 total funds, including \$13,732 cash funds and \$152,180 federal funds, and 2.0 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA).

RECOMMENDATION: Staff recommends approving the request. The majority of the appropriation for this line item is federal funds, which are included in the Long Bill for informational purposes only.

WEATHER MODIFICATION

The CWCB's Weather Modification Program is responsible for issuing permits for weather modification projects, monitoring environmental conditions, regulating weather modification activities, and engaging in public outreach. This program is supported by cash funds from fees charged for weather modification permits as specified in Section 36-20-113, C.R.S. If the operation is a commercial project, statute requires the fee to be sufficient to pay the direct costs for review of the permit application, public hearings regarding the application, and the monitoring of the permitted operation.

STATUTORY AUTHORITY: Section 36-20-101 et seq., C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$25,000 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request. Fees from weather modification permits are continuously appropriated to the CWCB for the purpose of administering this program.

WATER CONSERVATION PROGRAM

This line item supports the Office of Water Conservation and Drought Planning (OWCDP), which promotes water use efficiency and drought management planning. Funding for the program comes from the CWCB Construction Fund. Program responsibilities include the administration of municipal and agricultural grants, the provision of technical assistance, precipitation harvesting pilot projects, and water conservation training. The OWCDP also promotes drought planning by encouraging and assisting communities to prepare and implement drought mitigation plans and by monitoring drought impacts and informing the public, media, and state officials.

STATUTORY AUTHORITY: Section 37-60-124, C.R.S.

REQUEST: The Department requests an appropriation of \$397,740 cash funds and 4.0 FTE for FY 2019-20. This includes the annualization of prior salary survey and S.B. 18-200 (PERA).

RECOMMENDATION: Staff recommends approving the request.

WATER EFFICIENCY GRANT PROGRAM

The Water Efficiency Grant (WEG) Program was established in 2005 by H.B. 05-1254, and offers financial assistance to covered entities and qualifying agencies seeking to perform or promote more meaningful water conservation statewide. This line item supports the implementation of water conservation plan goals and programs identified in locally adopted water conservation plans. The WEG Program also gives grants to help agencies promote the benefits of water efficiency through public education and outreach programs. Funding for this program is from the Water Efficiency Grant Program Cash Fund, which receives \$550,000 in annual transfers from Tier II of the Severance Tax Operational Fund, and the CWCB Construction Fund.

STATUTORY AUTHORITY: Section 37-60-126, C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$604,956 cash funds and 1.0 FTE for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request. It is consistent with the statutory provisions outlining the funding for this program (Sections 37-60-126 (12)(a)(III) and 39-29-109.3 (2 (c)(I), C.R.S.), as well as a legislative change refinancing \$100,000 in severance tax funding with the same amount from the CWCB Construction Fund starting in FY 2009-2010, as directed by S.B. 09-125 (CWCB Projects Bill).

SEVERANCE TAX FUND

This line item provides funding for water projects with cash funds from Tier I of the Severance Tax Operational Fund. The CWCB prepares an annual proposal for projects to be funded from this line item comprised of agency initiatives and grant requests submitted by other parties. Proposals are forwarded to the CWCB Board and the Executive Director of the Department for review and approval, and the list of approved projects is included in the annual budget request. This line item accounts for most of the CWCB's Tier I appropriation each year.

STATUTORY AUTHORITY: Section 39-29-109.3 (1) (d), C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$1,275,500 cash funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request, as the amount is consistent with prior year expenditures from this line item. Additionally, the CWCB is a Tier I agency and is authorized to receive up to 5.0 percent of available moneys in the Severance Tax Operational Fund. Based on the December 2018 LCS revenue forecast, the total Tier I appropriation for the CWCB will be approximately \$1.3 million for FY 2019-20.

INTERBASIN COMPACTS

House Bill 05-1177 created nine permanent basin roundtables to develop a common understanding of existing water supplies and future water supply needs and demands throughout Colorado, and possible means of meeting those needs. These "Basin Roundtables" include municipal users, agricultural users, local governments, water conservation and conservancy districts, recreational and environmental interests, and the business community. The Basin Roundtable meetings are focused on consensus building and the exchange of information on water use. This line item is funded in part by the continuously-appropriated Interbasin Compact Committee Operation Fund, which receives annual transfers from Tier II of the Severance Tax Operational Fund. The remainder is from CWCB Construction Fund.

STATUTORY AUTHORITY: Article 75 of Title 37, C.R.S.

REQUEST: The Department requests an appropriation of \$1,168,169 cash funds and 3.7 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA).

RECOMMENDATION: Staff recommends approving the request. Approximately 63.4 percent of the requested appropriation is informational and the remainder is consistent with a legislative change refinancing \$400,000 in severance tax funding with the same amount from the CWCB Construction Fund starting in FY 2009-2010, as directed by S.B. 09-125 (CWCB Projects Bill).

PLATTE RIVER BASIN COOPERATIVE AGREEMENT

Colorado became a participant in the Platte River Basin Endangered Species Cooperative, now known as the Platte River Recovery Implementation Program, in 1997. The Cooperative Agreement is a three-year agreement signed by the governors of Wyoming, Colorado, and Nebraska and by the Secretary of the Interior to address the protection and restoration of various endangered species habitats along the North Platte River. The cash funds appropriation from the Fish and Wildlife Resources Fund supports 1.0 FTE and contractual personal services for ongoing administration of the program and Colorado's portion of contract technical support.

STATUTORY AUTHORITY: Sections 24-33-111 and 37-65-101, C.R.S.

REQUEST: The Department requests an appropriation of \$246,212 cash funds and 1.0 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA).

RECOMMENDATION: Staff recommends approving the request.

STATUTORY AUTHORITY: Section 39-22-2402 to 2403, C.R.S.

REQUEST: The Department requests an appropriation of \$90,000 cash funds for FY 2018-19.

RECOMMENDATION: **Staff recommends approving the request.** Pursuant to Section 39-22-2403 (2)(b), C.R.S., the money in the Colorado Healthy Rivers Fund allocated to the CWCB and the Water Quality Control Division in CDPHE is continuously appropriated and shown in the Long Bill for informational purposes only.

(7) DIVISION OF WATER RESOURCES

The Water Resources Division, also called the Office of the State Engineer, is primarily responsible for administration of water resources, which includes overseeing over 170,000 intrastate surface and groundwater rights, as well as ensuring compliance with nine interstate compact agreements. The Division has seven field offices that monitor and distribute water based on priority and ensure dam safety. Additionally, the Division issues permits for well construction; engages in community education; consults with water suppliers and conservation districts; and collects, preserves, and provides current and historic water records and information.

DECISION ITEMS – DIVISION OF WATER RESOURCES (NONE)

The Department of Natural Resources did not submit any decision items for this division.

LINE ITEM DETAIL – DIVISION OF WATER RESOURCES

(A) DIVISION OPERATIONS

WATER ADMINISTRATION

Water Administration consists of two sub-programs: administration of intrastate water rights and interstate compact enforcement. It is the statutory responsibility of DWR to verify: 1) stream diversions are per decree; 2) wells are operated in compliance with their decrees; 3) augmentation plans, or substitute water supply plans are replacing stream depletions; and 4) interstate compact flows are delivered to downstream states. This requires daily oversight of the water allocation

system. There are seven division offices located throughout the state, one in each major drainage basin; these division offices employ field staff, including water commissioners, who perform duties that contribute to water administration. Duties of the field staff include turning headgates to control water flow, collecting water use and/or diversion data, and enforcing decrees and water laws.

STATUTORY AUTHORITY: Articles 61 to 69, 80 to 90, and 92 of Title 37, C.R.S., and Section 37-90-137, C.R.S.

REQUEST: The Department requests an appropriation of \$22,409,279 total funds, including \$21,687,678 General Fund and \$721,601 cash funds, and 247.0 FTE for FY 2019-20. This includes the annualization of prior year salary survey and S.B. 18-200 (PERA), as well as a technical adjustment for increased funding for monitoring the South Platte River alluvial aquifer.

RECOMMENDATION: Staff recommends approval of this request.

WELL INSPECTION

The Well Inspection Program was established by S.B. 03-045 and continues to be funded by well permit application fees. The Well Inspection Program licenses water well construction contractors and enforces existing rules and regulations for the construction, repair, plugging, sealing, and abandonment of all wells; test holes; monitoring and observation wells; and dewatering wells. The General Assembly created the State Board of Examiners of Water Well Construction and Pump Installation Contractors to develop standards for construction to protect the aquifers and to license contractors for well construction.

STATUTORY AUTHORITY: Article 90.5 of Title 37, C.R.S., and Section 37-91-113, C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$379,038 cash funds and 3.0 FTE for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request.

SATELLITE MONITORING SYSTEM

This line item supports satellite-linked water resource monitoring stations throughout the state. This system provides "real-time" stream flow information that is used by the Division, consumptive water users such as agricultural users, and other interested persons such as rafters and anglers. Stations record stream flow, and transmit the information to a database. Some revenue is generated through voluntary fees from local conservancy districts, water users, user associations, and municipalities, which are deposited in the Satellite Monitoring System Cash Fund.

STATUTORY AUTHORITY: Sections 37-80-102, 37-80-111.5, C.R.S., and Article 92 of Title 37, C.R.S.

REQUEST: The Department requests an appropriation of \$575,204 total funds, including \$194,968 General Fund and \$380,236 cash funds, and 2.0 FTE for FY 2019-20.

FEDERAL GRANTS

This line item is funded by federal grants from the Federal Emergency Management Agency (FEMA) and the U.S. Bureau of Reclamation (BOR). FEMA grants are used support the Division's Dam Safety Program and BOR grants support a water project in the San Luis Valley and provide gauging station maintenance for the Williams Fork gauge in northwestern Colorado.

REQUEST: The Department requests a continuation-level appropriation of \$230,000 federal funds for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request. This funding is from federal grants and is included in the Long Bill for informational purposes only.

RIVER DECISION SUPPORT SYSTEMS

This line item supports a statewide decision support system for the Colorado, Rio Grande, South Platte, and Arkansas River Basins. The Colorado Decision Support System consists of databases and models that facilitate decision making related to interstate compacts, water resource planning, and water rights administration, through use of historic data and geographic information systems.

STATUTORY AUTHORITY: Article 60 of Title 37, C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$212,467 cash funds and 2.0 FTE for FY 2019-20.

RECOMMENDATION: Staff recommends approving the request.

(B) SPECIAL PURPOSE

DAM EMERGENCY REPAIR

This appropriation provides funding to the State Engineer in the event emergency action is necessary to repair a dangerous or threatened dam. Cash funds are from the Emergency Dam Repair Cash Fund, which is replenished from transfers from the CWCB Construction Fund. A maximum amount of \$50,000 is continuously appropriated. These funds have only been required in one year to day (FY 2013-14), but any funds expended are recoverable from the dam owner.

STATUTORY AUTHORITY: Sections 37-60-122.5 and 37-87-108.5, C.R.S.

REQUEST: The Department requests a continuation-level appropriation of \$50,000 cash funds for FY 2019-20.

RECOMMENDATION: **Staff recommends approving the request**, as it is consistent with statutory provisions regarding funding for this line item. While expenditures are not made from this line item on a regular basis, maintaining the current appropriation will allow the Department the flexibility to respond in the event there is an incident or emergency at a dam.

N Department of Natural Resources, Division of Parks and Wildlife, Wildlife, Special Purpose, Asset Maintenance and Repairs – This appropriation remains available for expenditure until the completion of the project or the close of the 2020-21 2021-22 state fiscal year, whichever comes first.

COMMENT: This footnote provides roll-forward authority three fiscal years to accommodate grant reimbursements for multi-year projects.

REQUESTS FOR INFORMATION

Staff recommends the following **NEW** request for information:

1 Department of Natural Resources, Division of Parks and Wildlife, Colorado Water Conservation Board, and Division of Water Resources – The Department and Divisions are requested to provide a report on the impact of the staff recommended line item reorganization for the FY 2020-21 budget. The report should identify any unresolved problems stemming from the reorganization and suggest any additional actions. The report is requested to be submitted by November 1, 2019.

Staff recommends **CONTINUING AND MODIFYING** the following request for information:

2 Department of Natural Resources, Division of Parks and Wildlife – The Division of Parks and Wildlife is requested to provide the Joint Budget Committee with a report on Parks and Outdoor Recreation and Wildlife sources of revenue, as well as the expenditures of revenues by revenue type. The report should provide an analysis of lottery funds Great Outdoors Colorado Board Grants used for operations and capital projects. The report is requested to be submitted by November 1, 2018 2019.

INDIRECT COST ASSESSMENTS

DESCRIPTION OF INDIRECT COST ASSESSMENT METHODOLOGY

The Department of Natural Resources indirect cost assessment methodology is calculated based on two components: an "Indirect Cost Pool" and an "Indirect Cost Base".

INDIRECT COST POOL

The *Indirect Cost Pool* is comprised of approved Executive Director's Office (EDO) and other overhead FY 2017-18 actual costs, including statewide indirect costs, used to provide support to the entire department. The *Indirect Cost Base* is comprised of FY 2017-18 actual personal services costs by division. *Table 1* outlines which line items are included in the Department's Indirect Cost Pool. Of the Total Indirect Cost Pool, the Department subtracts \$906,528 of non-recoverable indirect costs. This amount is associated with General Fund personal services costs not assessed in the Division of Water Resources (the majority of personal services costs in DWR are General Fund costs).

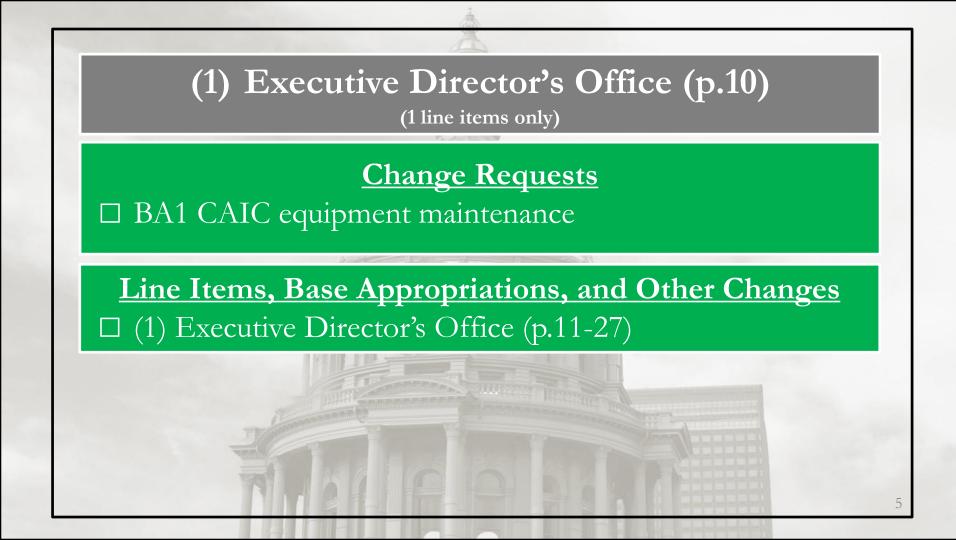

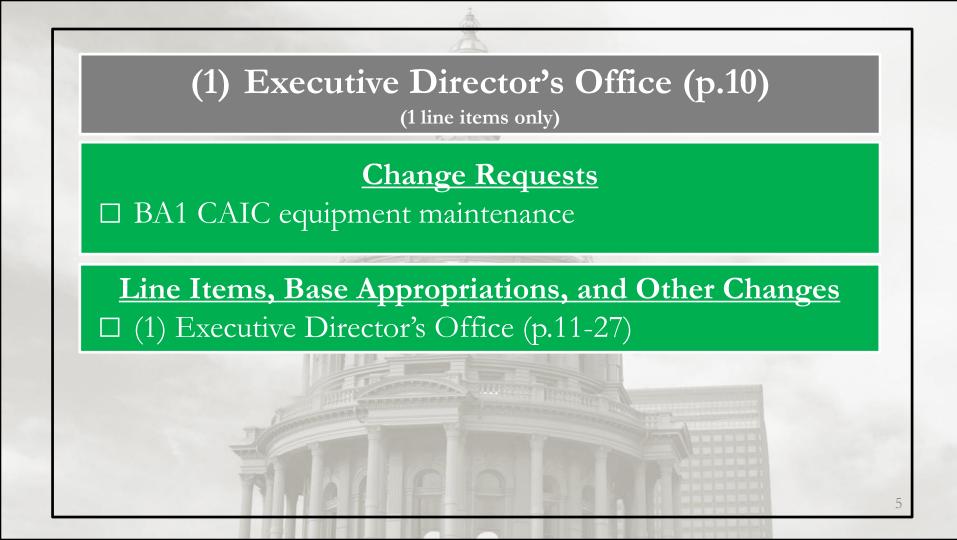
