DEPARTMENT OVERVIEW

The Department provides trained and ready military forces for the U.S. active armed services and for preserving life and property during natural disasters and civil emergencies in Colorado; supports federal and state homeland security missions; maintains equipment and facilities for state military forces; provides for safekeeping of the public arms, military records, relics and banners of the state; assists veterans and National Guard members with benefits claims; operates the Western Region One Source Center in Grand Junction; maintains the Western Slope Veterans' Cemetery; supports the Civil Air Patrol, Colorado Wing; and assists in fighting the spread of drug trafficking and abuse.

DESCRIPTION OF INCREMENTAL CHANGES – FY 2024-25

R1 CONG RECRUITING & RETENTION: The recommendation includes \$500,000 General Fund in FY 2024-25 and ongoing to support recruiting and retention efforts for the Colorado National Guard (CONG). The CONG is currently facing recruiting and retention setbacks, with a current end strength below its target. End strength affects the state's ability to utilize the National Guard as an asset, as the lack of personnel can inhibit its ability to respond effectively.

R2 CONSTRUCTION AND FACILITIES OPERATING: The recommendation includes an increase of \$195,000 General Fund to the Army National Guard Cooperative Agreement in FY 2024-25 and ongoing. This request intends to cover the increased costs associated with repairs and maintenance at the Colorado National Guard facilities. The average age of COARNG facilities is thirty-two years, and seven facilities are over sixty years old. This request would allow the Department to invest in repairing, maintaining, and modernizing its facilities and assist in meeting rising utility and maintenance costs.

R3 EDO TRAINING SPECIALIST: The recommendation includes \$57,067 General Fund and 0.9 FTE within the Executive Director's Office (EDO) for a dedicated training specialist in FY 2024-25. This recommendation annualizes to \$70,351 General Fund and 1.0 FTE in FY 2025-26. This request addresses the comprehensive federal and state training requirements for the DMVA, which have grown significantly over time without adequate resources to keep pace.

R4 VTF EXPANDED SPENDING AUTHORITY: The recommendation includes a \$250,000 increase in cash fund spending authority from the Colorado State Veterans Trust Fund (VTF) in FY 2024-25 and ongoing. The VTF currently has a fund balance in excess of \$4.0 million. The increased spending authority would allow the Department to utilize these funds to support Colorado Veterans through various initiatives, including funding for veteran community living centers, state veteran cemeteries, veteran programs operated by nonprofit veteran organizations, mental health services, family counseling services, job training, employment, and housing for homeless veterans.

R5 CAP / JROTC CAPACITY BUILDING: The recommendation includes an increase of \$152,245 General Fund and 0.9 FTE in FY 2024-25 for operational support to coordinate statewide efforts for the Civil Air Patrol (CAP) and Junior Reserve Officer Training Corps (JROTC). This recommendation would annualize to \$127,052 General Fund and 1.0 FTE impact in FY 2025-26.

CENTRALLY APPROPRIATED LINE ITEMS: The recommendation includes adjustments to centrally appropriated line items. The Committee has only acted on some of these. The table below shows previously approved amounts and, where denoted by an asterisk, the requested amounts that are pending Committee action.

STAFF INITIATED VETERANS ASSISTANCE GRANT FUNDING: The recommendation includes a continuation in FY 2024-25 and ongoing of a \$500,000 increase in the General Fund appropriation to the Veterans Assistance Grant Program. This funding originally passed as one-time funding through a Long Bill Conference Committee Amendment in FY 2023-24.

NON-PRIORITIZED DECISION ITEMS: The recommendation includes a net increase of \$244,463 total funds, including an increase of \$244,230 General Fund and \$206 cash funds to reflect the FY 2024-25 impact of non-prioritized decision items, shown in the table below.

STAFF INITIATED TOBACCO MASTER SETTLEMENT ADJUSTMENT: The recommendation increases spending authority from the Veterans' Trust Fund by \$17,427 cash funds. The Colorado State Veterans Trust Fund is supported by a transfer of one percent of the State's revenue from the Tobacco Master Settlement Agreement.

STAFF-INITIATED REPCF STATUTORY TRUE-UP: The recommendation includes permission to work with Legislative Legal Services to draft legislation modifying the statutory language regarding the Real Estate Proceeds Cash Funds (REPCF) in the Department of Military and Veterans Affairs.

STAFF-INITIATED INFORMATIONAL FEDERAL FUNDS ADJUSTMENT: The recommendation includes a decrease of \$3.6 million in informational federal funds and 220.0 FTE to reflect annual changes to FTE and compensation within the Colorado National Guard.

ANNUALIZE PRIOR YEAR BUDGET ACTION: The recommendation includes a net decrease of \$385,104 General Fund to reflect the net annualization of prior year budget actions.

(1) EXECUTIVE DIRECTOR AND ARMY NATIONAL GUARD

The Executive Director's Office is responsible for the administration of the Department. It provides leadership to the Department by managing the general administrative functions, which include policy development; human resource management; accounting; purchasing and contracting; and budgeting. The Executive Director's Office is also responsible for the legislative program of the Department at the state and federal level.

The Army National Guard is funded by the federal government and managed and staffed by Federal Civil Service employees. The federal government fully funds National Guard training and provides most of the funding for construction of armories and other military facilities. Under its cooperative agreements with the federal government, the Department provides 50 percent of maintenance and utilities costs at fifteen armories on state-owned land, and 20 to 25 percent of these costs at four other facilities.

DECISION ITEMS - EXECUTIVE DIRECTOR AND ARMY NATIONAL GUARD

→ R1 CONG RECRUITING AND RETENTION

REQUEST: The request includes a \$500,000 General Fund increase beginning in FY 2024-25 and ongoing to support recruiting and retention efforts for the Colorado National Guard (CONG).

RECOMMENDATION: Staff recommend approval of the request. Additionally, Staff note that given the magnitude of this problem this funding amount may not be adequate to provide a level of funding necessary to accomplish the Department's recruiting and retention goals. However, given the pilot status of the program, Staff feel it appropriate to err on the side of conservatism and encourage the Department to submit a supplemental request for additional funding should this amount prove inadequate.

EVIDENCE LEVEL: The Department indicated evidence informed, level 2, but provided no further supporting documentation.

BACKGROUND AND ANALYSIS: The Department of Military and Veterans Affairs is requesting an ongoing increase of \$500,000 General Fund to support its Colorado National Guard recruiting efforts. The Department is facing a challenging recruiting and reenlistment environment, and current setbacks leave the current end strength of the force at 96.9 percent. The compromised end strength has negative implications for the CONG's capabilities when deployed in the event of wildfire mitigation, public emergencies, federal deployment, and surge capability. Additionally, federal investments in infrastructure and new units are prioritized based on end strength, and guard units with high-end strength numbers receive more federal support than those without.

COLORADO NATIONAL GUARD

The federal government fully funds the training and salary of National Guard troops and provides the majority of the funding for the construction of armories and other military buildings. Under the cooperative agreements with the federal government, the State provides funding for 50.0 percent of maintenance and utilities costs at the fifteen armories located on state land, and between 20.0 and 25.0 percent of costs at four other facilities. The State also funds most of the central administrative costs for the National Guard.

Colorado National Guard expenditures are driven by the number of Guard personnel authorized by the U.S. National Guard Bureau, or the "federal force structure," and the state's ability to fill the force structure. Combined with the associated facilities maintenance and utility needs, this determines the amount of federal funds flowing into and through the Department. Colorado has both Army National Guard and Air National Guard units.

The table below shows the recent authorized strength and active membership of the Colorado National Guard.

Population, demographic variables, geography, and historical participation rates drive the number of authorized personnel in each National Guard unit. The table below shows the federal force structure across the fifty-four states and territories. Note that Colorado currently ranks thirty-eighth out of fifty-four.

The end strength in Colorado has been trending down for the last five years. While the CO Air National Guard has been able to maintain a stable and comparatively high force structure, the CO Army National Guard has decreased steadily and faces a significant shortfall in the current year. The table below shows the status of the Colorado Army National Guard's recruiting goals as of February 8, 2024. As of this date, the recruiting goal should be 33 percent complete. This figure represents an improvement from the June 1, 2023 figures presented during the Departmental Briefing.

filling the federal force structure and meeting the recruiting goals. States are also responsible for funding the benefits to incentivize recruits and reward re-enlistment. There are significant differences in the benefits states offer to their guard units. For instance, some states provide their National Guard members property tax exemptions, child care reimbursement, license plates, and employment assistance.

Colorado currently has a tuition assistance program for its National Guard members. Additionally, the Governor recently approved the Joint Enlistment Enhancement Program to award members for a successful referral who enlists. However, without additional funding, the program is currently unsustainable. The table below describes the various benefits available to guard members by state.

JBC Staff recommendation includes \$500,000 General Fund in FY 2024-25 to establish ongoing funding to pay out recruiting and retention bonuses to National Guard service members, with \$50,000 earmarked for the Joint Enlistment Enhancement Program. This funding will award small bonuses to service members who are able to recruit someone into the force. The remaining \$450,000 would allow the CONG to offer up to a \$10,000 enlistment and retention bonuses to forty-five service members depending on the time in service and length of the enlistment contract. According to the Department, both initiatives have been effective and seen success in other states.

→ R2 CONSTRUCTION AND FACILITIES OPERATING

REQUEST: The request includes an increase of \$195,000 General Fund to the Army National Guard Cooperative Agreement in FY 2024-25 and ongoing.

RECOMMENDATION: Staff recommend approval of the request.

EVIDENCE LEVEL: The Department indicated N/A.

BACKGROUND AND ANALYSIS: The operating budget for the Colorado Army National Guard (COARNG) Cooperative Agreement line item has been challenged by significant increases in utilities, operations, and maintenance costs since 2015. The average age of COARNG facilities is 32 years, and seven active facilities are over 60 years old. Age has therefore, resulted in substantial increases to repair, maintenance, modernization, and utility costs.

In 2023, the Construction and Facilities Management Office (CFMO) received about \$12.7 million in federal funds to support the COARNG statewide building footprint via its Facilities and Environmental Cooperative agreements. However, not all facilities are covered with federal funding; those facilities with a state match requirement (i.e., not 100% federally supported) will have a reduced level of preventative maintenance and improvements, whereas those 100% federally supported facilities will take advantage of fully federal funding sources. Though costs for repairs, maintenance, construction, and utilities have continued to increase, this appropriation has remained at a fixed or reduced level year-to-year.

To mitigate rising costs and financial strain, the Department has had to defer maintenance, repairs, and improvements to facilities that require a significant state match for costs. Consequently, the Department has had to reprioritize efforts to focus on federally supported facilities so that CONG can still maximize the benefit from the Cooperative Agreement federally-supplied funding and minimize returning funds to the Federal government for non-execution.

With an increase in the appropriation to construction and facilities maintenance, state share-funded facilities and operations are less likely to defer routine maintenance and standard levels of repair. Routine maintenance leads to higher-functioning facilities and can reduce much larger and impactful maintenance issues in the long run. Finally, maintained and functional facilities improve the National Guard's morale and response capabilities to state and federal missions.

The table below outlines the Department's construction and facilities operating budget over the previous five years, and compares the annual appropriation to what the FY 2019-20 appropriation would be if adjusted annually for inflation. You can see that in FY 2023-24 the budget for operations and maintenance in real dollars is approximately \$500,000 less than in FY 2019-20.

→ R3 EDO TRAINING SPECIALIST

REQUEST: The request is for \$73,098 General Fund and 0.9 FTE within the Executive Director's Office (EDO) in FY 2024-25 for a dedicated training specialist.

RECOMMENDATION: Staff recommend approval of \$57,067 General Fund and 0.9 FTE in FY 2024-25, annualizing to \$70,351 General Fund and 1.0 FTE in FY 2025-26. Differences from the request are primarily due to JBC common policy regarding salaries and centrally appropriated line items.

EVIDENCE LEVEL: The Department indicated Theory-informed, level 2, but provided no supporting documentation. This is an administrative FTE request, and JBC staff generally consider these requests to be not applicable.

BACKGROUND AND ANALYSIS: The Department has undergone significant growth in its leadership structure, including the recent addition of a Chief Operating Officer as well as a Chief Financial Officer. Funding for these two positions was approved by the Joint Budget Committee during figure setting in FY 2023-24, and both positions have been filled by the Department. Additionally, in March of 2022 the Department hired a new Director of Strategic Plans and Organizational Development. The addition of fresh leadership has led to a reevaluation of the Departments current operations, and the identification of gaps in its current structure. One of the significant voids identified by leadership was in cross Departmental training.

Training demands have grown substantially over time within the Department, without a significant change in the organizational training structure. The rise in these training demands has led to an increase strain on existing employees tasked with maintaining their current administrative roles in addition to trying to keep up with the growing training demands of the state and federal government across the entire Department.

DMVA requests funding for an additional full-time training specialist within the EDO, who would play a central role in devising, managing, and evaluating the efficacy of the Department's diverse and comprehensive training programs. This individual would be tasked with understanding the unique development needs of staff, executing impactful training initiatives, aligning costs with budgets, and gauging the successful outcomes of training programs. This specialist will undertake the coordination and administration of:

- Training and Professional Development;
- Mandatory Safety Training;
- Safety Learning Management Systems (LMS);
- Annual LMS training for all Departmental employees;
- Supervisor Program Academy, which features internal and external curriculum to bolster supervisory capabilities and adherence to policy;
 - Equity, Diversity, Inclusion, and Accessibility (EDIA) Training ensuring representation and growth of diverse socio-demographic backgrounds within the Department;
- Partnerships with internal and external entities for further training prospects:
 - Local Workforce Centers;
 - o Cooperation with other state agencies for broader training opportunities;
 - o Nationwide training for service members and veterans; and
 - In-house training for emergency preparedness, such as Active Shooter scenarios, evacuations, etc.
- Collaboration with the Center for Organizational Effectiveness to upgrade trade-specific personnel training and identify new vendor opportunities;
- Exploration of contractual discounts with approved vendors;
- Curating and maintaining a Departmental Intranet page for a centralized training repository and announcement of upcoming training events; and
- Formulating a Professional Development Guide as a comprehensive source of training Opportunities.

The table below outlines the Department's request, staff recommendation, and the FY 2025-26 recommended annualization.

→ R5 CIVIL AIR PATROL / JROTC PROGRAM

REQUEST: The request includes an increase of \$193,400 General Fund and 0.9 FTE in FY 2024-25 for operational support to coordinate statewide efforts for the Civil Air Patrol (CAP) and Junior Reserve Officer Training Corps (JROTC). According to the Department, this would annualize to 1.0 FTE and \$193,400 General Fund in FY 2025-26.

RECOMMENDATION: Staff recommends approval of \$152,245 General Fund and 0.9 FTE in FY 2024-25. This recommendation would have a \$127,052 General Fund and 1.0 FTE impact in FY 2025-26. Staff recommendation reflects standard adjustments to centrally appropriated line items per JBC common policy.

BACKGROUND AND ANALYSIS: Currently, the State does not have a centralized JROTC and youth program coordinator. Instead, youth programs such as Young Marines and JROTC are independently coordinated between military branches and school districts. The current system leads to a significant lack of uniformity in access to students across the State. Many students who would benefit greatly from these programs cannot participate simply because of the school district they live in. Though not implicitly stated in the request, Staff hypothesize that many of the school districts that do not currently have these programs are already socio-economically disadvantaged. By not having uniform access to the JROTC program, students who may have the most to gain from this, and similar programs are unable to participate.

This request aims to establish a JROTC liaison who could coordinate with school districts across the state and provide a single touchpoint for schools for access and information on enrollment. This role would require significant time and focus and thus would require a dedicated full-time FTE. This individual would be able to better identify and respond to these socioeconomic and resource disparities within districts, and respond to them. This FTE could coordinate and provide resources to underfunded and neglected programs and schools. Most importantly, the FTE will be able to provide education and workforce resources to students in marginalized communities who currently do not have access to these very valuable and in many instances transformational life opportunities.

Currently the Civil Air Patrol (CAP) Administrator does not directly administer the CAP cadet program which is largely left to volunteer administrators. By being more directly involved with the cadet program, the CAP Administrator will add greater continuity and communication across the state, leaving the cadet squadrons in a much better position to provide awareness of education and employment pipeline opportunities.

This request is intended to increase awareness and drive additional participation in CAP and JROTC programs through direct engagement with K-12 schools across Colorado. This request seeks to achieve this through:

Increasing the scope of responsibility and funding for the existing CAP Administrator;

- Creating a new FTE to serve as the State JROTC coordinator, which will provide education and workforce resources to students in marginalized communities who currently do not have access to these opportunities; and
- Increasing the operational funds to perform outreach across the State of Colorado.

→ STAFF-INITIATED REAL ESTATE PROCEEDS CASH FUND STATUTORY TRUE-UP

RECOMMENDATION: The recommendation includes permission to work with Legislative Legal Services to draft legislation modifying the statutory language regarding the Real Estate Proceeds Cash Funds in the Department of Military and Veterans Affairs.

BACKGROUND AND ANALYSIS: During FY 2023-24 supplementals, the Department submitted an operating request for funding to make final payment to contractors for the Fort Logan expansion project, which commenced in FY 2020-21. JBC Staff research of the request made it clear that OSPB and the Department had mischaracterized this request and that the request was, in reality, for a capital project that had never received approval from the JBC, the CDC or the Colorado General Assembly.

Numerous issues regarding the Real Estate Proceeds Cash Fund have come to light through this inquiry. Statute is clear that funds from the Real Estate Proceeds Cash Fund are subject to appropriation by the Colorado General Assembly and that Section 28-3-106 (1)(s)(I), C.R.S. is neither unclear nor ambiguous.

If, in the judgment of the adjutant general, any real estate that has been acquired for military purposes is unsuitable for military purposes, the adjutant general, by and with the approval of the governor, in writing, has authority to sell, trade, or

otherwise dispose of such real estate, but, except as otherwise provided by subsection (1)(s)(II) of this section, such real estate shall not be disposed of for less than its appraised value. The appraised value of such real estate shall be determined by an appraiser who is licensed or certificated pursuant to part 6 of article 10 of title 12 and who is selected by the adjutant general from a list of three qualified individuals submitted to the adjutant general by the department. Appraisers shall be selected for the list, and their fees shall be negotiated in accordance with the standards established by part 14 of article 30 of title 24. The adjutant general, by and with the advice and approval of the governor, is authorized to lease any property belonging to the department when it is not needed for the immediate use of the department. All conveyances that are required for the purpose of this section shall be executed by the governor under the seal of the state, and the proceeds of all sales, trades, or other disposition shall be placed in an account to be invested by the state treasurer as provided in section 24-36-113. Any interest earned on the investment or deposit of such proceeds shall remain in such account and shall not be credited to the general fund or any other fund of the state. Said proceeds and any interest thereon shall be disbursed by authority of the adjutant general, subject to appropriation by the general assembly, only for the construction, repair, improvement, acquisition, or costs of acquisition or sale of armories throughout the state. Costs of acquisition or sale shall include but need not be limited to appraisals, site surveys, environmental surveys, title work, property inspections, closing costs, legal fees, real estate fees, site preparation, or utility studies. Prior to disposing of any real property pursuant to the provisions of this subsection (1)(s), the adjutant general shall submit a report to the capital development committee that describes such real property, the maintenance costs related to such real property, the current value of such real property, any conditions or limitations that may restrict the use of such real property, and the terms of the proposed disposition of such real property. The capital development committee shall review any such report that is submitted to the capital development committee and shall provide recommendations to the adjutant general concerning the proposed real property disposition within thirty days after the date of receipt of such report. The adjutant general shall not complete any such real property disposition without considering any recommendations of the capital development committee that are provided within such thirty-day period.

However, the Department and Controller's Office have pointed to other portions of the Department of Military and Veterans Affairs statutes as potentially creating "ambiguity" regarding the Adjutant General's authority to purchase land and build on it without legislative approval or oversight. Given this, Staff feels it is essential to clarify any portions of statute that OSPB, the Department of Military and Veterans Affairs, or the State Controller may interpret as ambiguous.

In a letter to the Joint Budget Committee from the State Controller and the Department of Personnel dated January 22, 2024 (appendix B), the Office of the State Controller indicates that they feel statute 28-3-106 C.R.S.(1)(q) and 28-3-106 C.R.S.(1)(r) are unclear. Neither JBC Staff nor Legislative Legal Services share this interpretation. Nonetheless, Staff recommends modifying the following sections of the statute related to the Real Estate Proceeds Cash Fund:

28-3-106 C.R.S.(1)(q) The adjutant general shall have charge of the campgrounds and military reservations of the state and shall be responsible for the protection and safety thereof, and he or she shall promulgate regulations for the maintenance of order thereon, for the enforcement of traffic rules, and for all other lawful regulations as may be ordered for the operation, care, and preservation of existing facilities and installations on all state military reservations. He or she shall keep in repair all state buildings and other improvements thereon. He or she may make such sound improvements thereon as the good of the service requires.

28-3-106 C.R.S.(1)(r) The adjutant general, by and with the advice and approval of the governor, is authorized to rent, hire, purchase, take the conveyance of, and hold in trust for the use of the state of Colorado such buildings, lands, tenements, and appurtenances thereof as may be from time to time

deemed necessary for use by the National Guard. All such expenditures shall be paid out of the military fund, but all titles shall be taken in the name of the governor of the state of Colorado for the use of the National Guard. Prior to acquiring any real property pursuant to the provisions of this paragraph (r), the adjutant general shall submit a report to the capital development committee which describes the anticipated use of such real property, the maintenance costs related to such real property, the current value of such real property, any conditions or limitations which may restrict the use of such real property, and any potential liability to the state which could result from acquiring such real property. The capital development committee shall review any such report which is submitted to the capital development committee and shall provide recommendations to the adjutant general concerning the proposed real property acquisition within thirty days after the date of receipt of such report. The adjutant general shall not complete any such real property acquisition without considering any recommendations of the capital development committee which are provided within such thirty-day period.

Specifically, staff recommends:

- Adding language to Section 28-3-106.(1)(q), C.R.S., to clarify that use of state funds for repair and improvements is subject to appropriation by the General Assembly; and
- Modifying Section 28-3-106, (1)(r), C.R.S., to strike "All such expenditures shall be paid out of the military fund..." and the remainder of that subsection. This could be replaced with language clarifying that purchase of buildings or land using state funds shall be subject to appropriation by the General Assembly.

LINE ITEM DETAIL — EXECUTIVE DIRECTOR AND ARMY NATIONAL GUARD

PERSONAL SERVICES

This line item funds the administrative FTE in the Executive Director's Office. Staff who provide maintenance and other functions eligible for federal match under the Army National Guard Cooperative Agreement were moved to the Cooperative Agreement line item beginning in FY 2019-20. The federal funds remaining in this line item represent the federal contribution to supporting these central administrative staff. These funds are provided in lieu of an indirect cost payment.

A footnote added in FY 2019-20 provides significant flexibility for the Department to transfer funds between this line item and the Cooperative Agreement line item.

STATUTORY AUTHORITY: Section 28-3-105 to 106, C.R.S.

REQUEST: The Department requests is summarized in the table and includes the R3 (EDO Training Specialist) and R5 (Civil Air Patrol / JROTC Program) decision items.

RECOMMENDATION: The staff recommendation is shown in the table below and reflects Committee common policy. Staff requests permission to make adjustments if necessary based on the Committee's final action on total compensation policy.

The State Board of Veterans Affairs advises the Division on matters pertaining to veterans, makes grants from the Colorado State Veterans Trust Fund for capital improvements and amenities at state veteran's nursing homes; costs of state veteran's cemeteries; costs of the Division, and for veteran's programs operated by non-profit veterans' organizations.

DECISION ITEMS - DIVISION OF VETERANS AFFAIRS

→ R4 VTF EXPANDED SPENDING AUTHORITY:

REQUEST: The request includes a \$250,000 increase in cash fund spending authority from the Veterans Trust Fund (VTF) in FY 2024-25 and ongoing to assist CO veterans through nonprofit grants, (list allowable uses of funds).

RECOMMENDATION: Staff recommend an approval of \$250,000 in cash fund spending authority.

BACKGROUND AND ANALYSIS The Colorado State Veterans Trust Fund is funded through Tobacco Master Settlement funds and receives 1 percent annually of this distribution. Pursuant to Section 28-5-709, C.R.S., the total Tobacco Master Settlement Agreement funds may be used for:

- Capital improvements or needed amenities for state veterans nursing homes;
- Costs incurred by state veteran cemeteries;
- Costs incurred by the Division of Veterans Affairs to administer the program; and
- Grants to veteran programs operated by nonprofit veterans' organizations that meet criteria adopted by the Colorado Board of Veterans Affairs and selected by that Board as grant recipients.

Currently, the Department's Veterans Trust Fund has a balance in excess of \$4 million beyond what it is permitted to spend. At the same time, the demand for eligible, worthy grant programs from across the State who are serving veterans by providing housing assistance, financial resources, job training, and education opportunities is greater than the current authorized spending authority of the Department. Due to these limitations, the Department has been unable to provide grants to many eligible grantees and programs.

This increased spending authority would allow the Department to utilize these funds to assist the states veteran population by providing additional funding for the authorized use of Tobacco Master Settlement funds. capital improvements and amenities for existing or future veterans' community living centers. Additionally, according to the Department, access to these funds would provide additional assistance to all veterans across Colorado uniformly and improve veteran outcomes.

The table below shows the Colorado State Veterans Trust Fund account balance projected through FY 2026-27, and incorporates the impact of the Department's R4 request for additional spending authority in FY 2024-25 and ongoing.

→ STAFF-INITIATED TOBACCO MASTER SETTLEMENT AGREEMENT ADJUSTMENT

RECOMMENDATION: The recommendation includes an increase of \$17,427 cash funds to the Colorado State Veterans Trust Fund from the Tobacco Master Settlement Agreement (TMSA). The adjustment

results from the forecast change in TMSA revenue. JBC requests permission to adjust the appropriation to commiserate with the March revenue forecast.

→ STAFF-INITIATED VETERANS ASSISTANCE GRANT PROGRAM FUNDING

RECOMMENDATION: The recommendation includes a continuation of the \$500,000 General Fund increase to the Veterans Assistance Grant Program passed in conference committee in FY 2023-24. The ongoing funding would provide support to nonprofit organizations and governmental entities that serve Colorado veterans through services that increase overall well-being, such as mental health services, suicide prevention family counseling, job training, employment, and housing for homeless veterans.

REQUEST: The Department requests an appropriation of \$1,380,592 General Fund, reflecting a 3.0 percent increase in the community provider rate.

These funds can be used for capital improvements and amenities at state veterans' nursing homes; costs of state veterans' cemeteries; costs of the Division, and for veterans' programs operated by non-profit veterans' organizations.

STATUTORY AUTHORITY: Section 28-5-709, C.R.S.

REQUEST: The Department requests a continuation appropriation of \$1,432,658 cash funds.

RECOMMENDATION: Staff recommends \$1,450,085 based on the most recent Tobacco Master Settlement Agreement. Staff requests permission to adjust the appropriation based on the March revenue forecast.

GRAND JUNCTION VETERANS ONE-STOP CENTER

This line item provides funding for the operation of the One-stop Center for Veterans in Grand Junction. In FY 2017-18, the General Assembly funded renovation of an old armory building in Grand Junction to create a one-stop resource center for veterans on the site. DECISION ITEMS – FEDERAL FUNDED PROGRAMS

The Executive Branch did not submit any decision items for this division.

→ STAFF-INITIATED INFORMATIONAL FEDERAL FUNDS ADJUSTMENT

This line item includes an estimate of federal expenditures for the salaries of uniformed members of the Colorado National Guard, based on the number of members of the National Guard (full-time and part-time) and the current E7 (mid-grade) salary. The Department did not request adjustments to federal funds shown for informational purposes, but staff recommends figures shown be updated based on changes to FTE and compensation.

Using the same calculation approach adopted in FY 2021-22, staff recommends reflecting \$109,500,000 and 2,087.0 FTE. This is a decrease of \$3.6 million federal funds and a decrease of 220.0 FTE from the previous year and the request. Calculations are reflected in the table below.

Staff recommends **rounding** the total dollars included in the Long Bill to the nearest \$100,000 and FTE to the nearest 1.0 to help clarify that the figure represents an estimate.

Because associated federal funds do not pass through the State accounting system, Department civilian staff do not have an easy way to identify actual expenditures. The Department's United States Property and Fiscal Officer (USPFO) is responsible for all federal funds allocated to the State, including funds for National Guard uniformed personnel. However, a consolidated federal funds figure is not readily available. This is in part because a significant portion of operating resources used by state National Guard personnel are purchased through purchasing agreements at the national level and are not managed by the USPFO (e.g., national fuel purchase agreements).

LINE ITEM DETAIL – FEDERAL FUNDED PROGRAMS

FEDERAL FUNDED PROGRAMS OPERATIONS

This line item includes an estimate of federal expenditures for uniformed National Guard salaries, based on the number of members of the National Guard (full-time and part-time) and the current E7

(mid-grade) salary. These funds do not flow through the state accounting system, so this amount represents an estimate to reflect the scale of the Colorado National Guard.

STATUTORY AUTHORITY: Code of Federal Regulations: Title 32 and Title 10.

REQUEST: The Department requests a continuation appropriation of \$113,100,000 federal funds and 2,307.0 FTE.

RECOMMENDATION: The staff recommendation is for \$109,500,000 federal funds and 2,087.0 FTE. The calculation is detailed in the table for the division, as there is only a single line item in this division.

LONG BILL FOOTNOTES

Staff recommends **CONTINUING** the following footnotes:

The General Assembly includes footnotes in the annual Long Bill to: (a) set forth purposes, conditions, or limitations on an item of appropriation; (b) explain assumptions used in determining a specific amount of an appropriation; or (c) express legislative intent relating to any appropriation. Footnotes to the 2022 Long Bill (H.B. 22-1329) can be found at the end of each departmental section of the bill at https://leg.colorado.gov/bills/HB20-1360. The Long Bill footnotes relevant to this document are listed below.

Department of Military and Veterans Affairs, Executive Director and Army National Guard, Personal Services, Operating Expenses, Vehicle Lease Payments, and Army National Guard Cooperative Agreement -- In addition to the transfer authority provided in Section 24-75-108, C.R.S., the Department is authorized to transfer up to 20.0 percent of the total General Fund appropriations in these line items between these line items. Transfers to or from the Vehicle Lease Payments line item may be used solely to address changes in the portion of costs covered by federal authorities for vehicle lease payments.

COMMENT: This flexibility was added for FY 2019-20 to help the Department make more efficient use of its appropriations. Additional information will be available ongoing regarding how this flexibility is used and the impact on Department expenditures.

Staff recommend **DISCONTINUING** the following footnote:

xx Department of Military and Veterans Affairs, Division of Veterans Affairs, Veterans Service Operations — It is the General Assembly's intent that at least 1.0 FTE for which the Department is appropriated funding shall be responsible for developing and implementing an equitable, diverse, and inclusive outreach program for veterans and armed services.

COMMENT: This footnote was added for FY 2022-23 to provide additional focused support to marginalized veteran populations.

REQUESTS FOR INFORMATION

Staff recommend **DISCONTINUING** the following requests for information:

The Department of Military Affairs, Division of Veterans Affairs -The Department is requested to provide a report to the Joint Budget Committee by November 1, 2023, describing its plan for an equitable, diverse, and inclusive outreach program to marginalized veteran populations of the armed services. Additionally, the Department is asked to provide an update on the plan deliverables that have been accomplished to date.

COMMENT: This request was added in FY 2022-23 to update the JBC on the Department's efforts to support marginalized veteran populations.

Staff recommend **DISCONTINUING** the following requests for information:

The Department of Military Affairs, Division of Veterans Affairs -The Department is requested to provide a report to the Joint Budget Committee by November 1, 2024, describing its ongoing progress towards meeting the performance audit recommendations published in the September 2022 Department of Military Affairs, Veterans Services Performance Audit conducted by the Colorado Office of the State Auditor.

COMMENT: This request provided detail to the JBC regarding the Department's progress toward achieving the Office of the Colorado State Auditor's recommendations and could be beneficial in guiding future Committee action.

INDIRECT COST ASSESSMENTS

DESCRIPTION OF INDIRECT COST ASSESSMENT METHODOLOGY

The Department of Military and Veterans Affairs does not collect departmental or statewide indirect costs per the Centralized Personnel Plan (CPP), as negotiated with the federal government. The National Guard Bureau, which reimburses the state with federal funding to run the Air National Guard and Army National Guard program, prohibits indirect cost recoveries with the following criteria in the CPP:

"Congress has prohibited the expenditure of Army National Guard and Air National Guard appropriations for reimbursement of any indirect costs, except fringe benefits, of the States under NCB cooperative agreements."


In lieu of indirect cost collections, the CPP allows for direct federal cost-share of some central administrative staff and expenses. The Department has received approval for 11.0 administrative staff to complete the following functions:

- 3.0 Purchasing/Contracting
- 2.0 Personnel
- 1.0 Accounts Payable
- 1.0 Payroll
- 4.0 Accountants

The 11.0 FTE are located in the Executive Director and Army National Guard Long Bill group.

Statewide indirect costs appear in the Department of Personnel and Administration's plan, but are only collected for cash funds sources, since federal funds are not allowed to be collected.

The following is the Department of Personnel & Administration response to the concerns raised by the JBC regarding the DMVA Real Estate Proceeds and the Fort Lupton Expansion Project.

Office of the State Controller

The Office of State Controller (OSC) provided the full history of spending from the DMVA Real Estate Proceeds Cash Fund in the <u>attached spreadsheet</u>. Legislative authority is noted for each expenditure (see color coding) as well as the <u>CDC approval</u> and <u>settlement statement</u> for the "non appropriated" amount in the spreadsheet.

In terms of the Fort Lupton Expansion Project, the OSC felt that the statute is unclear notwithstanding legislative staff comments. OSC acknowledges that 28-3-106 C.R.S.(1)(s)(I) requires a separate appropriation. However, subsections (q) and (r) indicate otherwise. Therefore, the OSC staff granted spending authority based on the following interpretation of the statute:

28-3-106 C.R.S. Powers and duties of adjutant general

28-3-106 C.R.S.(1)(q) - This subsection could be interpreted as providing the adjutant general with the authority for the installation of this building. Subsection (a) states, in part, "the adjutant general shall have charge of the campgrounds and military reservations of the state and shall be responsible for installations on all state military reservations."

28-3-106 C.R.S.(1)(r) - This subsection refers to the "military fund" but this fund has not been set up separately. Instead, DMVA stated it uses the Real Estate Proceeds Cash Fund as the military fund. Therefore, it is unclear if the military fund is interchangeable with the Real Estate Proceeds Cash Fund. Subsection (r) provides that "the adjutant general, by and with the advice and approval of the governor, is authorized to rent, hire, purchase, take the conveyance of, and hold in trust for the use of the state of Colorado such buildings, lands,

tenements, and appurtenances thereof as may be from time to time deemed necessary for use by the National Guard. All such expenditures shall be paid out of the military fund ..."

At the time the spending authority was originally granted, the OSC believed it was acting per the legislative authority granted to DMVA in Section 28-3-106, C.R.S. However, the OSC acknowledges the concerns raised by the staff and Committee.

Office of the State Architect

The Office of the State Architect has no record of the DMVA Fort Lupton Expansion Project budget submission in 2018 or otherwise. It appears that the Fort Lupton Expansion project was not part of the OSA capital construction budget process.
