Dear Jeffco GOP leadership:

Are you familiar with HB23-1180?

It would mandate that Jeffco expand the BCC to five seats and that at least three of them would have to be elected by district instead of countywide.

If Jeffco has five districts and commissioners are elected by district, you could count on at least one of those districts electing a Republican. With Jeffco being more blue than red nowadays, the current system of three commissioners all elected countywide is likely to favor the Democratic Party. Currently, all three county commissioners are Democrats.

I favor this change personally and will be testifying in favor of HB23-1180 this Thursday, 3/2, at 10 a.m. (or thereabouts) before the State, Civics, Military, and Veterans Affairs Committee in LSB A (big white building across the street to the South of the Capitol). ## Public Comment on HB23-1180, Mar. 2, 2023

My name is Jim Smith. I am the broker/owner of Golden Real Estate, and you may know me from my weekly real estate column in the Denver Post.

I was part of a group in 2013 called "Jeffco5" which attempted to put on the ballot an initiative expanding the Board of County Commissioners to 5 commissioners, each elected by district.

The expansion of any public board from 3 to 5 members is made compelling by the Open Meetings Law of 1972 which says that no two members of a 3-member board (because they constitute a quorum) may talk, text or email each other about county business without announcing that conversation in advance and opening it to the public. I don't recall any such meetings being called, and it's hard to believe that a 3-member board can function effectively when it's illegal for them to discuss county business with each other between board meetings.

Being elected by district makes eminent sense and should appeal to board members, because they wouldn't have to campaign countywide to win a seat representing one-third or one-fifth of the county. County residents also suffer because, with all commissioners elected countywide, they don't have the full attention of any one commissioner.

Indeed, I don't even know which of the Jeffco commissioners is "my" commissioner, and that's probably true of 99% of Jeffco residents.

The only argument one can make against HB23-1180 is that it is an unfunded mandate, and that adding two commissioners would cost over half a million dollars per year according to Jeffco's own analysis. But Jeffco has 580,000 residents. That's only \$1 per resident to improve county-level representation.

On Tuesday, I videotaped an interview with the chair of the Jeffco Board of Commissioners, Andy Kerr, who couldn't be here in person but wanted to state his support for expanding his board to 5 commissioners and having them elected by district. You have received a link to that 5-minute video.

I'm submitting with this testimony a print-out of my email exchange this week with Nancy Pallozzi, chair of the Jeffco Republican Party, in which she says, "I too feel it would be good for Jeffco" and thanked me for testifying today.

If you feel the need to amend HB23-1180, my only suggestion would be to limit it to counties over 250,000 population instead of counties over 70,000. Thank you for your time and consideration.
