HB23-1236 be amended as follows:

1 Amend printed bill, page 14, line 8, strike "introductory portion".

2 Page 14, after line 17 insert:

3 "(a) ~~At least~~ One individual with expertise in the behavioral health
4 needs of children and youth APPOINTED BY A LOCAL OR REGIONAL PUBLIC
5 HEALTH OR HUMAN SERVICE AGENCY WITHIN THE SUBCOMMITTEE'S
6 REGION;

7 (b) ~~At least~~ One individual who represents a behavioral health
8 safety net provider that operates within the region APPOINTED BY A LOCAL
9 OR REGIONAL PUBLIC HEALTH OR HUMAN SERVICE AGENCY WITHIN THE
10 SUBCOMMITTEE'S REGION; ~~and~~

11 (c) A county commissioner of a county situated within the region
12 APPOINTED BY THE BHA;

13 (d) ONE INDIVIDUAL WITH A CONNECTION TO A KINDERGARTEN
14 THROUGH TWELFTH GRADE SCHOOL DISTRICT WITHIN THE
15 SUBCOMMITTEE'S REGION APPOINTED BY A LOCAL OR REGIONAL PUBLIC
16 HEALTH OR HUMAN SERVICE AGENCY WITHIN THE SUBCOMMITTEE'S
17 REGION;

18 (e) ONE INDIVIDUAL WITH THE CRIMINAL JUSTICE SYSTEM WITHIN
19 THE SUBCOMMITTEE'S REGION APPOINTED BY A LOCAL OR REGIONAL
20 PUBLIC HEALTH OR HUMAN SERVICE AGENCY WITHIN THE SUBCOMMITTEE'S
21 REGION;

22 (f) ONE INDIVIDUAL WITH LIVED EXPERIENCE OR A COMMUNITY
23 MEMBER WHO IS NOT ALSO A BEHAVIORAL HEALTH PROVIDER APPOINTED
24 BY A LOCAL OR REGIONAL PUBLIC HEALTH OR HUMAN SERVICE AGENCY
25 WITHIN THE SUBCOMMITTEE'S REGION;

26 (g) ONE INDIVIDUAL WITH LIVED EXPERIENCE APPOINTED BY THE
27 BHA; AND

28 (h) TWO INDIVIDUALS WITH LIVED EXPERIENCE NOT ASSOCIATED
29 WITH A BEHAVIORAL HEALTH TREATMENT PROVIDER APPOINTED BY THE
30 BEHAVIORAL HEALTH ADMINISTRATIVE SERVICE ORGANIZATION CREATED
31 PURSUANT TO PART 4 OF THIS ARTICLE 50 THAT REPRESENT THE
32 SUBCOMMITTEE'S REGION."
