What is the BHA?

The Behavioral Health Administration (BHA) is a new cabinet member-led agency within the State of Colorado, housed within the Department of Human Services and is designed to be the single entity responsible for driving coordination and collaboration across state agencies to address behavioral health needs.





Provided funding for **twelve distinct projects** through SB 21-137 for behavioral health support across the continuum:

- Ten projects are >90% encumbered
- Nine projects are >50% expended

Four projects contribute to the majority of the 35% unencumbered amounts:

- Statewide Care Coordination Infrastructure
- Behavioral Health-Care Workforce Development Program
- Community Mental Health Centers School Aged Children
- BH and SUD Treatment for Children, Youth, and Their Families

2021 SB 21-137 Project Highlights

SB 21-137

Behavioral Health Workforce Development Program

Recruit, retain, and train the behavioral health workforce. Activities include: Developing an online LMS system and associated trainings, providing fiscal incentives, providing capacity-building grants

County-Based Behavioral Grant Program

Provide matching grants to county departments of human or social services for the expansion or improvement of local or regional behavioral health disorder treatment programs.

Crisis System for Colorado Residents

Improve statewide access to crisis system services for children and youth. This funding has helped provide specialized in-home crisis resolution services for children, youth, and their families who do not need inpatient level of care.


Behavioral Health Statewide Care Coordination Infrastructure

Develop coordination infrastructure for all Coloradans to identify and locate behavioral health services in their community.



Provided funding for **fifteen distinct projects** from eight bills.

- The majority of spending is allowed through December 31, 2024
- Many projects are in the early stages of planning and implementation



Unencumbered



SB 22-196, HB 22-1281, SB 22-148

Five of the BHA 2022 SLFRF projects are grant programs (\$145.7m):

- (1) SB22-196 Health Needs of Persons In the Criminal Justice System (\$50.7m)
 (2) HB22-1281 Behavioral Health Community Investment Grants (\$35m)
 (3) HB22-1281 Children, Youth, and Family Behavioral Health Services Grants (\$40m)
 (4) HB22-1281 Substance Use Workforce Stability Grant Program (\$15m)

 RFAs released and began accepting applications

 Tentative schedule for awards of first grants

 Final spending authority for all funds

 Grant awards will be made on a rolling basis until Dec 31, 2024, unless all funds are awarded prior.
 - (5) SB22-148 Colorado Land-Based Tribe Behavioral Health Services Grant Program (\$5m)

The state is working directly with eligible Colorado land-based tribes for this grant program.



SB 22-181

- Released Strategic Plan "Strengthening the Behavioral Health Workforce in Colorado: An Approach to Community Partnership"
- \$4.5M in grant opportunities released in Feb 2022 to aid behavioral health employers in **retaining and recruiting** behavioral healthcare providers.
- Additional priorities include:
 - Expand peer support and develop a behavioral health aide program
 - Paid internships and pre-licensure stipends
 - Establish career pipeline development grants
 - Continuing development of Behavioral Health Learning Academy, including cross-system training certification and modules to supporting justice-involved people or those at risk of justice involvement
 - Expand behavioral health apprenticeships



Strengthening the Behavioral Health Workforce in Colorado: **An Approach to Community Partnership**





HB 22-1243



- Continuation of I Matter Program, offering free mental health and substance use disorder services for youth
- Program has provided up to six sessions for over 5,600 youth statewide
- 83% show rate for scheduled appointments so far in FY23
- Currently a network of 80+ provider agencies and 190+ clinicians

SB 22-177

- Builds upon the Care Coordination Infrastructure initiated through SB 21-137 and further facilitates implementation of critical components of Colorado's care coordination infrastructure, namely a cloud-based platform that will allow behavioral health providers that currently do not utilize an electronic health record to actively participate in the state's care coordination infrastructure.
- BHA will train new and existing navigators on behavioral health safety net system services, procedures, and social determinants of health resources.

HB 22-1283

- Partnering with MSOs to expand capacity of residential substance use treatment beds for youth.
- Continue the innovative pilot program established by 21-137 to support crisis stabilization services for children, youth, and their families by providing personalized services to reduce referrals to higher levels of care.

HB 22-1326

- Provide technical assistance to all county jails that participate in Colorado's Jail Based Behavioral Health Services Program with development and implementation of medication-assisted substance use treatment (MAT)
- This support includes development of guidelines for evaluations, timelines, and administration of medical withdrawal management by prescribers.
- Support identifying bulk purchasing opportunities for necessary MAT services
