Emerging and Expanding Grant - Data Report by County

August 16, 2021

Purpose

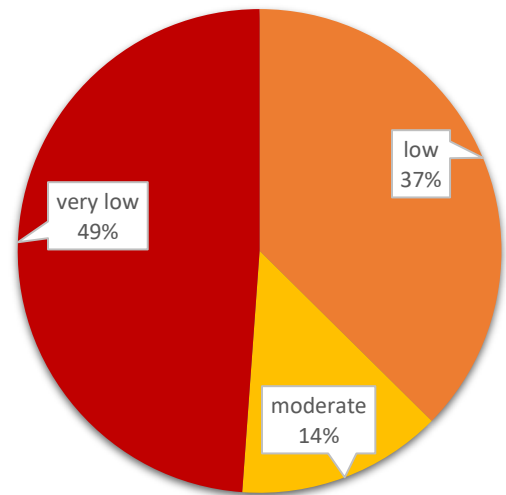
The Emerging and Expanding Child Care Grant Program has been created for the purpose of expanding access and availability of licensed child care throughout Colorado. Priority is given to programs in underserved communities, areas with low child care capacity, and for infant and toddler slots.

Status

As of August 16, 2021, 83 grants have been awarded totaling \$3,220,725 with 86% are from counties with low or very low child care capacity compared to the population (reflected in graph 1 below).

Methodology

Child Care Capacity vs. Child Care Desert

The calculations used for child care capacity differ from those used to determine child care deserts. Child care deserts utilize demand as a denominator whereas capacity data utilize population. Determining demand requires a much more nuanced analysis that considers multiple factors, at this point demand data are not readily available for our evaluation. The map on page 5 reflects licensed child care capacity data as it relates to the estimated birth to five population.

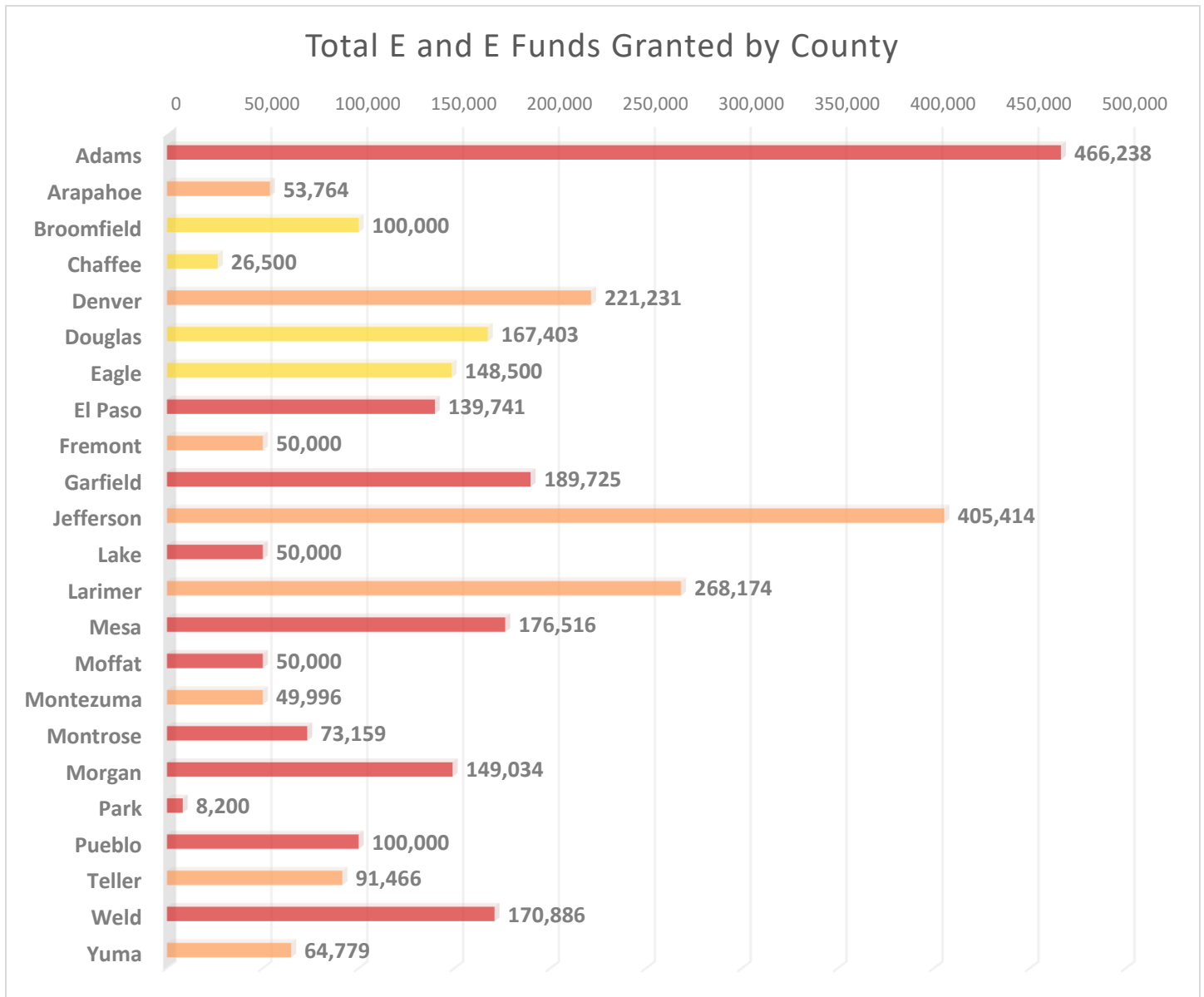
To calculate capacity to population percentage, we divide the reported capacity by the estimated birth to five population within the county. Counties considered to have a very low capacity to population percentage (red on the map) are at 17.5-39.3%; those considered low (orange) have a percentage of 39.4-58.9%; moderate (yellow) are 59-82.5%; high (green) are 82.6-105.7%; and very high (dark green) are 107.8 -250%. It should be noted that figures indicating a high or very high capacity to population percentage is not necessarily indicative of a county having more than adequate available child care slots but may be a result of a very low population of children ages birth to five in that county. Table 1 below reflects numbers of slots and estimated population for funded counties.

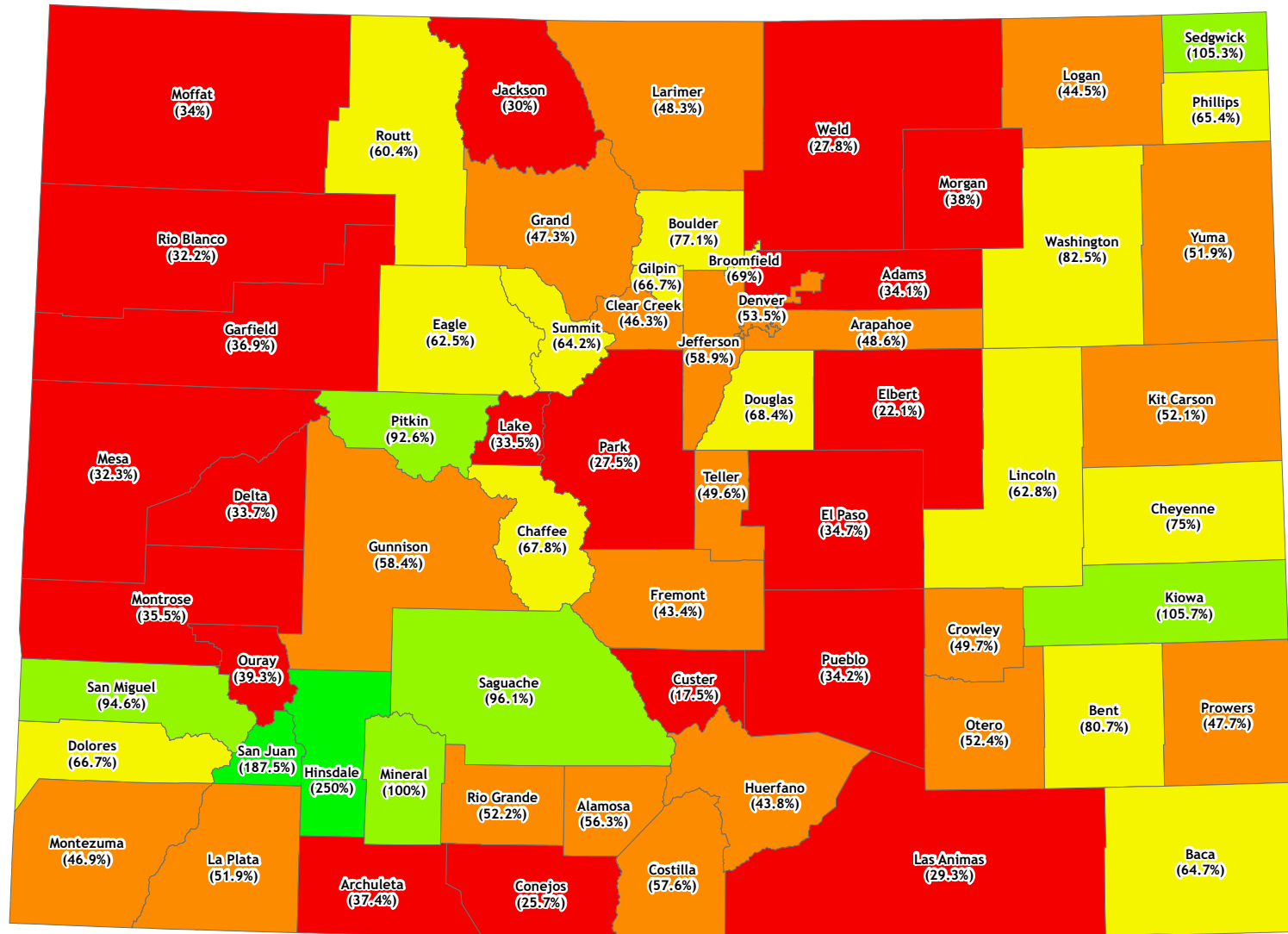

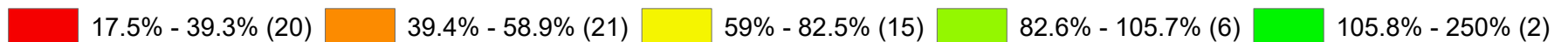


 Indicates County of Very Low Capacity (17.5% - 39.3%)
