



## Modify Conduct of Elections in Small Counties

ASSIGNED COMMITTEE: State, Civic, Military, & Veteran Affairs

## THE ISSUE:

Currently in most rural/ frontier counties in Colorado, Clerk and Recorder offices have a large pressure to find three election judges for multiple voting centers throughout their county. In Colorado, roughly 47 out of 64 counties are considered rural/ frontier counties meaning these parts of Colorado have 37,500 or less electorates, of those 47 counties, 27 have less than 10 thousand electorates.

## IF PASSED:

HB23-1149 will allow counties with 37,500 or less electorates to combine voting centers in close proximity with one another or which have little to no use on election day. The Secretary of State's office will review the county's local voting center data and review on a case by case basis. Additionally, this bill will also allow a Clerk and Recorder staff member to fill in one of the three election judge positions.

With in-person voting being down and threats against election judges on the rise. Voting season can be a heavy lift for many rural/ frontier Clerk and Recorder offices. From finding three election judges per voting center to purchasing and providing equipment, ballots and supplies for multiple low traffic voting booths around the county, a YES on HB23-1149 will help our rural/ frontier Colorado counties spend money efficiently and help mitigate the lack of election judges.
