HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB20-200 be amended as follows:

1 Amend reengrossed bill, page 15, line 26, strike "BOARD." and substitute  
2 "BOARD, AND ANY GIFTS, GRANTS, DONATIONS, OR INVESTMENTS  
3 RECEIVED BY THE STATE TREASURER."

4 Page 16, strike lines 8 through 13 and substitute:

5 **"24-54.3-109. Implementation and administration - costs.** THE  
6 STATE TREASURER MAY SEEK, ACCEPT, AND EXPEND GIFTS, GRANTS,  
7 DONATIONS, OR INVESTMENTS NOT REQUIRED TO BE REPAID, FROM  
8 PRIVATE OR PUBLIC SOURCES FOR THE COSTS ASSOCIATED WITH THE  
9 ADMINISTRATION OF THIS ARTICLE 54.3."

10 Page 17, after line 15 insert:

11 **"SECTION 9. Appropriation - adjustments to 2020 long bill.**

12 To implement this act, the general fund appropriation made in the annual  
13 general appropriation act for the 2020-21 state fiscal year to the office of  
14 the governor for use by the office of information technology for  
15 applications administration is decreased by \$1,197,552.

16 **SECTION 10. Appropriation.** (1) For the 2020-21 state fiscal  
17 year, \$1,197,552 is appropriated to the department of the treasury. This  
18 appropriation is from the general fund. Any money appropriated in this  
19 section not expended prior to July 1, 2021, is further appropriated to the  
20 department for the 2021-22 state fiscal year for the same purpose. To  
21 implement this act, the department may use this appropriation as follows:

22 (a) \$1,133,592 for the Colorado secure savings program, which  
23 amount is based on an assumption that the department will require an  
24 additional 5.0 FTE; and

25 (b) \$63,960 for the purchase of legal services.

26 (2) For the 2020-21 state fiscal year, \$63,960 is appropriated to the  
27 department of law. This appropriation is from reappropriated funds  
28 received from the department of the treasury under subsection (1)(b) of  
29 this section and is based on an assumption that the department of law will  
30 require an additional 0.3 FTE. To implement this act, the department of  
31 law may use this appropriation to provide legal services for the  
32 department of the treasury."

33 Renumber succeeding section accordingly.

34 Page 1, line 103, strike "WORKERS." and substitute "WORKERS, AND, IN  
35 CONNECTION THEREWITH, MAKING AND REDUCING AN  
36 APPROPRIATION."
