HOUSE COMMITTEE OF REFERENCE AMENDMENT
Committee on Transportation, Housing & Local Government.
HB23-1014 be amended as follows:

- 1 Amend printed bill, page 2, line 4, strike "**definition.**" and substitute
2 "**definitions.**".
- 3 Page 2, strike line 5 and substitute:
4 "(1) AS USED IN THIS SECTION:
5 (a) "LARGE VEHICLE" MEANS A TRUCK, BUS, EMERGENCY VEHICLE,
6 OR RECREATIONAL VEHICLE THAT GENERALLY HAS A TOTAL LENGTH OF
7 MORE THAN FORTY FEET OR A TOTAL WIDTH OF MORE THAN TEN FEET.
8 (b) "ROUNDAABOUT" MEANS A CIRCULAR".
- 9 Page 2, line 8, strike "APPROACHING OR DRIVING THROUGH" and substitute
10 "ENTERING, EXITING, OR DRIVING IN THE CIRCULATORY LANES IN".
- 11 Page 2, line 10, strike "VEHICLE WITH" and substitute "LARGE VEHICLE".
- 12 Page 2, strike lines 11 and 12 and substitute "THAT IS ENTERING, EXITING,
13 OR DRIVING IN THE CIRCULATORY LANES IN A ROUNDAABOUT AT THE".
- 14 Page 2, line 17, strike "DRIVING A VEHICLE THROUGH" and substitute
15 "ENTERING, EXITING, OR DRIVING IN THE CIRCULATORY LANES IN".
- 16 Page 2, line 18, strike "VEHICLE WITH A TOTAL LENGTH OF" and substitute
17 "LARGE VEHICLE".
- 18 Page 2, strike line 19.
- 19 Page 2, after line 20 insert:
20 "(c) THIS SUBSECTION (2) DOES NOT REQUIRE A PERSON WHO IS
21 DRIVING A VEHICLE THAT IS ENTERING, EXITING, OR DRIVING IN THE
22 CIRCULATORY LANES IN A ROUNDAABOUT TO YIELD THE RIGHT-OF-WAY TO
23 A LARGE VEHICLE THAT IS DRIVING BEHIND THE PERSON'S VEHICLE AND
24 ALLOW THE LARGE VEHICLE TO PASS THE PERSON'S VEHICLE."
- 25 Page 2, strike lines 21 through 23 and substitute:
26 "(3) IF TWO VEHICLES THAT ARE LARGE VEHICLES ENTER, EXIT, OR
27 DRIVE IN THE CIRCULATORY LANES IN A ROUNDAABOUT AT THE SAME TIME
28 OR SO CLOSELY AS".
- 29 Strike "STOP IF NECESSARY TO" on: **Page 2**, line 14; and **Page 3**, line 1.
