BILL TOPIC: Standards For Wildfire Mitigation Efforts

A BILL FOR AN ACT

101 CONCERNING STANDARDS FOR WILDFIRE MITIGATION PROJECTS
102 SUPPORTED BY STATE FUNDS.

Bill Summary

Wildfire Matters Review Committee. The bill requires the Colorado state forest service to promulgate rules setting forth standards for any wildfire mitigation efforts supported in whole or in part by state funds. The bill requires any state agency or other entity conducting wildfire mitigation supported in whole or in part by state funds to comply with the rules.

2	SECTION 1. In Colorado Revised Statutes, add 23-31-321 as
3	follows:
4	23-31-321. Wildfire mitigation standards - rules - definitions
5	(1) As used in this section, unless the context otherwise
6	REQUIRES, "FOREST SERVICE" HAS THE MEANING SET FORTH IN SECTION
7	23-31-310 (2)(c).
8	(2) (a) Pursuant to article 4 of title 24, by January 1, 2025
9	THE FOREST SERVICE SHALL PROMULGATE RULES FOR ANY WILDFIRE
10	MITIGATION EFFORTS SUPPORTED IN WHOLE OR IN PART BY STATE FUNDS.
11	(b) Rules promulgated pursuant to this section must
12	REQUIRE THAT ANY WILDFIRE MITIGATION EFFORTS SUPPORTED IN WHOLE
13	OR IN PART BY STATE FUNDS:
14	(I) ARE BASED ON THE BEST AVAILABLE SCIENCE AND SCIENTIFIC
15	APPLICATION TOOLS IN ECOLOGICAL RESTORATION STRATEGIES;
16	(II) FOCUS ON REDUCING THE RISK OF DAMAGE TO STRUCTURES
17	AND HARM TO PEOPLE, RESTORING NATURAL FIRE REGIMES AND THE
18	ECOLOGICAL HEALTH OF COLORADO'S WILDFIRE-PRONE ECOSYSTEMS, AND
19	MINIMIZING UNINTENDED ECOLOGICAL DAMAGE;
20	(III) DO NOT HARM UNDERSERVED COMMUNITIES;
21	(IV) ARE COST-EFFECTIVE AND ENABLE STRATEGIC INVESTMENT
22	OF LIMITED RESOURCES; AND
23	(V) Are transparently developed and implemented
24	THROUGH COLLABORATIVE PROCESSES REPRESENTING A WIDE RANGE OF
25	RELEVANT STAKEHOLDERS.
26	SECTION 2. In Colorado Revised Statutes, add part 15 to article

1	75 of title 24 as follows:
2	PART 15
3	STANDARDS FOR WILDFIRE MITIGATION PROJECTS
4	SUPPORTED BY STATE FUNDS
5	24-75-1501. Wildfire mitigation standards. ANY STATE AGENCY
6	OR OTHER ENTITY CONDUCTING WILDFIRE MITIGATION SUPPORTED IN
7	WHOLE OR IN PART BY STATE FUNDS SHALL COMPLY WITH RULES
8	PROMULGATED PURSUANT TO SECTION 23-31-321.
9	SECTION 3. Act subject to petition - effective date. This act
10	takes effect at 12:01 a.m. on the day following the expiration of the
11	ninety-day period after final adjournment of the general assembly; except
12	that, if a referendum petition is filed pursuant to section 1 (3) of article V
13	of the state constitution against this act or an item, section, or part of this
14	act within such period, then the act, item, section, or part will not take
15	effect unless approved by the people at the general election to be held in
16	November 2024 and, in such case, will take effect on the date of the

official declaration of the vote thereon by the governor.
