- SUBJECT: Overview of the Override Mill Levy Match Working Group

Summary

This memorandum provides an overview of the 2024 membership and charge of the Override Mill Levy Match Working Group (working group). Materials for the working group can be found on the <u>General Assembly's website</u>.

Background

Current law allows school districts, with voter approval, to levy additional property tax mills, over and above total program mills, up to a limit set in state law. These additional mills are known as mill levy overrides (MLOs). Currently, 124 of the 178 school districts in Colorado levy MLOs, generating over \$1.6 billion annually in additional school district funding. <u>Senate Bill 22-202</u> created the MLO Match Program to address the funding inequities that result from MLOs by providing state matching funds for qualifying school districts and state Charter School Institute (CSI) schools that raise local revenue through the passage of MLOs. Committee Charge

The working group was created pursuant to <u>House Bill 24-1448</u> to meet during the 2024 interim. It is charged with making recommendations for modifying the MLO Match Program, including:

- ensuring more equitable funding distributions and greater access to funding for eligible school districts and CSI schools;
- determining which districts and CSI schools will receive a distribution from the MLO Match Fund for FY 2024-25; and
- identifying and analyzing inequities between neighboring districts that have differing MLOs, levels of property tax bases, or demonstrated levels of local effort.
