²Pursuant to Section 37-98-103, C.R.S., no bill may be reported to the Legislative Council unless a two-thirds majority of the appointed members of the committee (at least 7 members) vote to report such bill to the Legislative Council. Also, the committee may report no more than three bills or other measures to the Legislative Council, unless a two-thirds majority of the members of the committee vote to report a greater number. Such greater number may not exceed one bill or other measure per member.
