# A BILL FOR AN ACT CONCERNING AN EXPANSION OF THE PROCEDURAL PROTECTIONS THAT APPLY TO UPDATED WATER QUALITY GENERAL PERMITS TO UPDATED WATER QUALITY INDIVIDUAL PERMITS.

## **Bill Summary**

Water Resources Review Committee. Current law requires the division of administration in the department of public health and environment to provide a rationale for, public notice of, and an opportunity for comment regarding proposed new or amended permit requirements for general water quality permits.
