


Jail Consolidation: Lake County's Experience

Lake County has one municipality, Leadville.

7,500 full-time residents

Bedroom community for surrounding resort communities

Six counties in Colorado have less than 2,000 people: Cheyenne, Kiowa, Jackson, Mineral, San Juan, and Hinsdale.

Twenty-one other counties have less than 10,000 people and are required to operate a jail, including Lake County.

CRS 17-26-101 Jail in Each County

"There shall be maintained in each county in this state, at the expense of the county, a county jail for the detention, safekeeping, and confinement of persons and prisoners lawfully committed. Nothing in this article shall be construed to compel the erection of jails in counties having a population of less than two thousand or when the county owns a jail erected in any other place in the county."

Small communities like Lake County cannot support the construction, maintenance, operation and staffing of a jail without impacting their ability to fund other state-mandated programs.

Unlike other state-mandated functions, the State does not provide funding for jail operations to counties.

Counties should be incentivized and supported in consolidating jail functions. Intergovernmental Agreements (IGAs) can be challenging when local officials (Commissioners and Sheriffs) are elected.

State Support for Jail Consolidation

If two or more counties enter into an IGA in order to consolidate jail functions, they will be eligible for additional support by the State which includes:

- The county sheriff's office, jail and staff can enter the staterun liability/insurance pool.
- A State funded grant program will be available to offset the costs associated with staffing, liability, jail operations, and transportation (gas, vehicle wear and tear, additional vehicles etc...).
- Funding will be prioritized for the county that hosts defendants from other counties due to increased liability and cost to house defendants.
- Additionally, funding will be prioritized for counties with smaller populations and lower average daily populations.
 This funding will not support the capital construction costs of a new regional jail.

Supporting counties with operational costs associated with jail consolidation has a greater impact than that same amount for jail construction

\$300,000 for a county to build a \$65M jail is 0.05% of total construction cost.

\$300,000 of a \$4M annual sheriff office budget is 7.5% of their total budget.

These operating incentives can keep an IGA in place even with leadership changes.
