1. Retention of counsel for pending and potential litigation.

The Committee may go into executive session pursuant to 24-6-402 (3)(a)(II), C.R.S., for the purpose of conducting attorney-client discussions concerning pending or imminent court action, specific claims or grievances, or for the purpose of receiving legal advice on specific legal questions related to a lawsuit recently filed in Denver District Court and retention of counsel to represent legislative defendants in the pending or potential litigation

2. Selection of applicants to be interviewed by the Committee for the position of Director of the Office of Legislative Legal Services

The Committee may go into Executive Session in accordance with Section 24-6-402 (3)(a)(III), C.R.S., for the purposes of conducting a discussion on matters required to be kept confidential by section 24-72-204 (3)(a)(XI)(A), C.R.S., that denies the right to inspect records submitted by or on behalf of an applicant or candidate for an executive position with a state agency who is not a finalist.

3. Other business
