# **Agency Overview**

### **Regional Transportation District**

- Created in 1969 by Colorado General Assembly
- Publicly elected Board of Directors
  - 15 members
- Primary modes
  - 126 bus routes
  - Six light rail lines
  - Four commuter rail lines
  - Paratransit
  - Microtransit







### **Regional Transit Network**

- Eight counties and more than 40 municipalities
- 2,342 square miles
- 3M+ population
- Approximately 65 million boardings in 2023

## **Back to Basics**

#### **Agency Assets**

- RTD has more than \$9 billion in fixed assets
- Ensuring assets are in a state of good repair is one of the agency's highest priorities
  - Guarantees previous investments in the system remain intact
  - Supports operationally safe, accessible, and dependable services
- Guided by the Federal Transit Administration's mandated Transit Asset Management (TAM) Plan
  - Includes principles used to make decisions aligned to the Strategic Plan
- Regularly monitored and inspected







### **State of Good Repair Efforts**

#### Planned Projects Completed Ahead of Schedule

- Downtown Denver Near-Term Rail Reconstruction Project: Phase 1
- Coping Panels Project

#### Slow Zones on Light Rail

- Staff discovered rail surface defects following the implementation of enhanced track inspections
- Track conditions that make temporary speed restrictions necessary can develop for several reasons, including the age of infrastructure and weather
- As repairs are made, restrictions are lifted



## **Bus Operations: Staffed by Position – August'24**






# Welcoming Transit Environment


### **Community Policing Model**

- RTD has been transitioning from contracted security to Peace Officer Standards and Training (POST) certified officers
  - RTD-PD has approximately 80 POST-certified officers and 20+ recruits
- Six mental health clinicians and five unhouseless outreach coordinators to be added during 2024
- RTD-PD introduced an overnight shift in early May to support 24-hour policing across the transit system
- Live look-in cameras have been added to the agency's entire bus fleet
  - Installation underway on light rail vehicles





### **Transit Watch Mobile App**



- Quick, easy, and anonymous way for customers to directly communicate with Transit Police
  - Ability to report personal safety and security-related concerns
- Available in English and Spanish
- Free to download for Apple and Android smartphones
- Customers can also call 303.299.2911 or text 303.434.9100

### White House Challenge to Save Lives from Overdoses

- RTD is an active participant in the White House's national effort to increase training and access to opioid overdose reversal medications
- Narcan opioid reversal medication
  - Used for individuals experiencing an overdose at stops and stations, in buses and trains, and at facilities
  - Carried by all POST-certified Transit Police officers and contracted security supervisors
  - Stored and readily available at all major transit hubs
  - 2023: Administered to 103 individuals
  - Jan-May 2024: Administered to 64 individuals



### **Impact Team**

- In May 2024, RTD launched an in-field customer engagement program
- Approximately 45 employee volunteers are regularly deployed to assist at stops and stations
  - Dispatched during events, service disruptions, and peak service times
- Available to answer frequently asked questions, provide trip information, report incidents, and show customers how to sign up for Service Alerts and purchase fare









## **Community and Paratransit Surveys**

### **Community Value Survey: Methodology**

- Distribution: mailed to random sample of households in the Denver metro area
- Survey period: June 19 through July 12, 2024
- Results were monitored to maintain demographic distribution in proportion to the region
- Target sample: 400 (+/- 4.9% at the 95% confidence level)
- 629 completed surveys


### **Paratransit Customer Survey: Methodology**



- Provides transparent agency performance overview
- Includes on-time performance metrics, community outreach metrics, boardings, survey data, and financial information
- Regularly updated to identify trends and measure RTD's efficiency and effectiveness

# **Coordination on Rail and Transit Funding**

### SB24-184 and SB24-230

 SB24-184 Requires RTD to participate in a study to implement rail service from Denver to Fort Collins

- RTD completed Northwest Rail Peak Service Study Data will inform SB24-184 effort
- Currently working with CDOT, FRPR, and CTIO to produce a report for TLRC and Governor Polis by September 30, 2024

#### SB24-230 Provides new funding from CO to support transit construction and operations

- New fees begin collection in July 2025
  - RTD will work with Clean Transit Enterprise on developing the grant formula and regulations in a manner that will support expanding transit services





# Legislative Requests

### **2025 Legislation to Consider**

#### Permanent Funding for Zero Fare for Youth

- Current state funding will assist RTD in implementing Zero Fare for Youth through 2025
  - RTD has signed a grant with Colorado Energy Office for funding through 2025
- New funding source or appropriation is needed to continue the grant program

#### Transit Worker Assault Deterrence Measures

- In 2021, the Colorado General Assembly reduced penalties associated with assaulting transit workers
  - RTD, in partnership with ATU 1001, supports reclassifying "transit workers" as protected frontline public employees
  - Encourages the State of Colorado to convene a commission to look at best practices
