A BILL FOR AN ACT

101 CONCERNING THE THREE YEAR PERIOD THAT CAPITAL CONSTRUCTION

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-75-303, **add** (5)  
3 as follows:

4           **24-75-303. Appropriation for capital construction.** (5)

5 (a) EXCEPT AS PROVIDED IN SUBSECTION (5)(b) OF THIS SECTION OR IN  
6 PARTICULAR LINE ITEMS OF APPROPRIATION, APPROPRIATIONS FOR CAPITAL  
7 CONSTRUCTION, EITHER IN THE ANNUAL GENERAL APPROPRIATION ACT OR  
8 IN SUPPLEMENTAL APPROPRIATION ACTS, ARE AVAILABLE UPON  
9 ENACTMENT OF THE ACT AND REMAIN AVAILABLE UNTIL COMPLETION OF  
10 THE PROJECT OR FOR A PERIOD OF THREE YEARS, WHICHEVER COMES FIRST,  
11 AT WHICH TIME UNEXPENDED AND UNENCUMBERED BALANCES REVERT TO  
12 THE FUNDS FROM WHICH THEY WERE APPROPRIATED. FOR PURPOSES OF  
13 THIS SUBSECTION (5)(a), THE THREE YEAR PERIOD COMMENCES FROM THE  
14 FISCAL YEAR FOR WHICH THE ANNUAL GENERAL APPROPRIATION ACT IS  
15 ENACTED AND IF AN APPROPRIATION IS LATER MODIFIED OR AMENDED IN  
16 A SUPPLEMENTAL APPROPRIATION ACT THE THREE YEAR PERIOD  
17 RECOMMENCES IN THE FISCAL YEAR THE SUPPLEMENTAL APPROPRIATION  
18 IS ENACTED, REGARDLESS OF WHEN THE ORIGINAL APPROPRIATION WAS  
19 ENACTED IN AN ANNUAL GENERAL APPROPRIATION ACT.

20           (b) AN APPROPRIATION FOR A LEASE-PURCHASE PAYMENT IS FOR  
21 THE FISCAL YEAR FOR WHICH THE APPROPRIATION IS ENACTED.

5           **SECTION 2. Applicability.** This act applies to appropriations for  
6 capital construction enacted on or after the effective date of this act.

7           **SECTION 3. Safety clause.** The general assembly hereby finds,  
8 determines, and declares that this act is necessary for the immediate  
9 preservation of the public peace, health, and safety.
