# **Initiative 138: Constitutional Right to School Choice**

Placed on the ballot by citizen initiative • Passes with 55 percent of the vote

## 1 Initiative 138 proposes amending the Colorado Constitution to:

- create the right to school choice for children in kindergarten through twelfth grade (K-12) and create the right for parents to direct the education of their children; and
- define school choice to include neighborhood, charter, private, and home
  schools, open enrollment options, and future innovations in education.

# **Summary and Analysis of Initiative 138**

#### 21 Does Colorado law allow school choice?

- 22 Under Colorado law students may attend any public school for free, even if they do not live
- 23 in the school district. Public schools include neighborhood schools, charter schools, and
- 24 some online schools. Each school district has policies allowing parents to enroll students in
- 25 the public school of their choice. State law also permits parents to choose non-public
- 26 education options, such as private schools or home schools. Public schools receive public
- 27 funding from local and state governments. Private schools and home schools do not receive
- 28 any public funding.

#### What does this measure do?

- 30 Initiative 138 creates the right to school choice in the Colorado Constitution. The new
- 31 language gives K-12 children the right to school choice and equal opportunity to access a
- 32 quality education. The measure also creates the right of parents to direct the education of
- their children. The measure defines school choice to include both public and private schools,
- 34 home schools, open enrollment options, and future innovations in education.

#### 1 Will the measure change school choice laws in Colorado?

- 2 The measure results in no immediate change to state law, or the enrollment policies of
- 3 school districts. The state legislature currently makes laws to govern public education. By
- 4 creating a new constitutional right to school choice for children and parents, this measure
- 5 may lead to future changes to state law.

## 6 Arguments For Initiative 138

- 7 1) Initiative 138 guarantees that school choice is a right of parents and children. By placing
- 8 this right in the constitution, Coloradans affirm their commitment to a parent's right to
- 9 school choice for their children, including all forms of education, both public and private.
- 10 A constitutional measure ensures this right can only be changed by voter approval.

## 11 Arguments Against Initiative 138

- 12 1) The language in the measure is vague and unnecessary. The Colorado Constitution
- already guarantees a free public education and Colorado already has robust school
- 14 choice laws that allow parents to choose from many public school options, or choose to
- educate their children in private or home schools. The measure may conflict with current
- 16 law and require interpretation by the courts, which could impact current school choice
- 17 policies and public school funding.
