Initiative 145: Establishing Veterinary Professional Associates

1 Initiative 145 proposes amending the Colorado statutes to:

- create the state-regulated profession of veterinary professional associate (VPA) in
 the field of veterinary medicine; and
- outline the minimum education and qualifications required to become a VPA.

16 Summary and Analysis of Initiative 145

17 Who can provide veterinary care in Colorado and how does Initiative 145 change this?

- 18 Under current law, licensed veterinarians, registered veterinary technicians, and registered
- 19 veterinary technician specialists may provide veterinary care in Colorado. These professionals
- 20 are regulated by the Colorado State Board of Veterinary Medicine (board). The board creates
- 21 rules for the practice and supervision of veterinary care, including rules for professional
- 22 qualifications, continuing education, and disciplinary measures. Additional federal
- 23 regulations apply to some types of veterinary care, such as prescribing medicine.
- 24 Initiative 145 creates the new role of veterinary professional associate, a mid-level role with a
- 25 scope of practice between a veterinarian and a veterinary technician. This profession would
- also be regulated by the board. Table 1 describes the differences between each profession.

4 What training programs exist for VPAs?

Currently, two universities outside Colorado offer master's degree programs in veterinary clinical care. At least one state university in Colorado has proposed offering a master's

7 program in veterinary clinical care. Under the measure, the board will determine what 8

degree programs, clinical experience, final examinations, and other qualifications will be

necessary for VPA registration.

Arguments For Initiative 145

- Many Coloradans struggle to get veterinary care for their animals, especially in rural and agricultural communities. Introducing new providers of veterinary care may help the industry meet demand, expand access, and make care more affordable. The VPA role could provide needed relief to overworked veterinarians, allowing them to delegate tasks and take better care of animals in Colorado.
- 7 2) The measure creates new jobs with viable economic and social benefits to Colorado. It will support new academic programs in the state and create a career pathway with greater income potential in the veterinary field. This regulated career would attract skilled professionals to the state and allow them to provide valuable services.

11 Arguments Against Initiative 145

- 12 1) There are no existing academic programs in Colorado that can educate VPAs and there is 13 no indication this measure will bring more professionals to the state to fill the need for 14 veterinary care in the near future. Allowing new practitioners with less training to provide 15 complex care may not help Coloradans get veterinary care and could harm their animals.
- Current law allows veterinary technicians and veterinary technician specialists to provide a wide variety of veterinary care. Rather than creating a new position, Colorado could focus its efforts on developing existing veterinary technicians or encouraging more people to pursue this profession. Increasing the use of existing qualified veterinary technicians will provide greater access and higher quality veterinary care without a new regulated profession.
