Initiative 157: Funding for Law Enforcement

Placed on the ballot by citizen initiative • Passes with a majority vote

1 Initiative 157 proposes amending the <u>Colorado statutes</u> to:

- require the state to spend \$350 million to help recruit, train, and retain local law enforcement officers; and
- provide an additional benefit for families of officers killed in the line of duty.

22 Summary and Analysis of Initiative 157

23 What does the measure do?

- Initiative 157 provides \$350 million in additional state funding to local law enforcement
 agencies to be distributed by the Colorado Department of Public Safety (CDPS). The funding
- 26 must be used to:
- increase annual pay;
- provide one-time hiring, recruitment, and retention bonuses;
- hire additional officers to address specific geographic locations or types of crime;
- provide ongoing training to new and veteran officers in areas such as the use of force,
 restraints, and physical fitness; and
- establish a one-time death benefit of \$1 million for law enforcement officer, firefighter,
 or first responder killed while on duty.

1 How would the measure change funding for law enforcement?

- 2 Local law enforcement agencies in Colorado are funded through county or municipal
- 3 budgets, and the state funds law enforcement agencies within the Colorado State Patrol and
- 4 the Colorado Bureau of Investigation in CDPS. The CDPS also provides technical assistance
- 5 and grants to local law enforcement agencies, most recently providing \$30 million in grants
- 6 over the past two years to local law enforcement agencies to improve officer recruitment
- 7 and retention. Additionally, there are other grants available to local law enforcement from
- 8 federal and other state sources. The initiative requires the legislature to increase funding to
- 9 CDPS by \$350 million, which CDPS will distribute to local law enforcement agencies and for
- 10 death benefits to families of officers killed while on duty.

11 What death benefits do law enforcement officers and their families currently receive?

- 12 Currently, spouses and children of local law enforcement officers receive ongoing survivor
- 13 benefits through the officer's pension. For example, the Fire and Police Pension Association
- 14 pays beneficiaries at least 70 percent of a fallen officer's base salary when the officer is killed
- 15 in the line of duty.

16 Argument For Initiative 157

 Law enforcement is a critical and underfunded public need. The state has a vested interest in ensuring that local governments can recruit and retain the best police officers possible to protect Coloradans and their property. With additional funding, local governments can supplement current resources, which helps to improve public safety and foster trust within the community. Furthermore, providing additional compensation for families of those who have died in the line of duty upholds a social obligation to honor their sacrifice.

24 Argument Against Initiative 157

25 1) No evidence exists to demonstrate that increased funding to law enforcement agencies 26 has made communities safer. The initiative mandates the legislature to spend millions 27 without considering local decisions about public safety needs or the state's broader 28 public safety obligations, such as funding for courts and correctional facilities. The 29 requirement to spend more than 10 times the amount of recent state funding on a local 30 funding obligation is an irresponsible use of taxpayer dollars. The death of an officer in 31 the line of duty is tragic, and fortunately Colorado already takes care of fallen officers' 32 families through a robust pension system.
