Consistent with JBC policy, all amount transferred to the Department or appropriated in another line item will now be classified as reappropriated funds. Funds classified as Cash Funds Exempt that are not appropriated elsewhere will now be classified as Cash Funds. In each affected line item, a table will show the effects of this change in policy.

#### (1) EXECUTIVE DIRECTOR AND ARMY NATIONAL GUARD

The Executive Director's Office is responsible for the overall administration of the Department It provides leadership to the Division by managing the general administrative functions, which include: Leadership and Policy Development; Human Resource Management; Accounting; Purchasing/Contracting; Budgeting; and Information Technology. Except for the Leadership and Policy Development, each of the functions has multiple operations within the Department, representing the different state and federal responsibilities of the Department. The Executive Director's office is also responsible for the legislative program of the Department at both the state and federal level.

The Army and Air National Guards are each separate entities, funded by the federal government and managed and staffed by Federal Civil Service employees. The federal government fully funds National Guard training and provides most of the funding for construction of armories and other military facilities. Under its cooperative agreements with the federal government, the Department provides 100 percent of maintenance and utilities costs at fifteen state owned armories, and 20 or 25 percent of the costs at four federal facilities.

#### Personal Services (Decision Items #3, #4, #5, #7)

The Department requests \$2,206,235 and 35.2 FTE, comprised of \$1,979,057 and 32.5 FTE General Fund, \$3,662 and 0.1 FTE cash funds from armory rental fees, and \$223,516 and 2.6 FTE federal funds.

Most of Department's General Fund personnel expenditures are for administrative and professional staff in the Executive Director/Army National Guard office, and for the labor trades and crafts employees who maintain and repair the armories and other military facilities. The table below shows the breakdown of personnel in the Executive Directors Office. (Please note that the FY 2008-09 Request column shows the addition of personnel from the Administrative Services line as well as increased personnel count as a result of Decision Items.)

Following is a brief description and analysis of the Decision Items that affect this line item.

**Decision Item #3** - The Department requests \$37,190 and 0.5 FTE General Fund to hire a Facilities Manager.

The Department's responsibility for the oversight and execution of facilities acquisition, sale, and maintenance is distributed throughout the department. At the present time, no one individual is responsible for the oversight and coordination of these tasks that constitute the Department's core function. The Department is responsible for the upkeep of 26 state owned facilities located throughout Colorado, as well as the execution of \$1.3 million of minor maintenance and \$1.6 million in controlled maintenance funds. The duties of the new position will include:

- Facilities Maintenance Management
- Facilities Construction Management for State Funded Projects
- Capital Construction/Controlled Maintenance Budget
- Environmental Programs
- Energy Conservation
- Real Estate Programs

The Department states that the existing situation whereby the authority and decision making functions regarding facilities leads to "fuzzy" lines of responsibility and authority regarding facilities that are partially state owned and partially federal owned. Staff contends that this result could be achieved by giving the authority to oversee facilities management to one person on staff with a realignment of duties within the Department's existing staff.

Staff Recommendation – Staff recommends against approval of this Decision Item. The Department has not provided information as to why this function could not be consolidated under one person with a realignment of duties within existing personnel resources. If the Committee does approve this item, it will also affect the following lines in the Executive Director's Office: S.B. 04-257 Amortization Equalization Disbursement - \$533, S.B. 06-235 Supplemental Amortization Equalization Disbursement - \$250, and Operating Expenses - \$4,155.

**Decision Item #4** – The Department requests \$23,982 and 0.5 FTE to add a Purchasing Agent (General Professional III)

Up until FY 2002-03, the Department's purchasing/contracting section consisted of one contracting and one purchasing FTE. When the Division of Veterans Affairs was transferred to the Department, another 0.5 FTE was transferred as support. This 0.5 FTE position was eliminated in the budget reductions of FY 2003-04, and restored in the FY 2006-07 budget. The restoration of this position did not, however, address the existing backlog of contracting and purchasing work.

Currently, the Department has identified a backlog of purchasing and contracting work of 1,040 hours. The backlog will increase as the Department's purchasing/contracting necessary for conducting \$6.9 million in accumulated Controlled Maintenance Projects and the upcoming construction of three to four new armories by FY 2010-11. When the Department constructed a new Guard Maintenance Facility at Fort Carson in FY 2002-03, Purchasing and Contracting transactions increase from about 500 per year to over 1,700 per year. They since dropped to about 800 per year, before a predicted increase in FY 2007 due to new construction and controlled maintenance projects.

In addition, the state dollars at risk from purchasing and contracting transactions has increased from about \$2 million in FY 2000 to about \$4.5 million in FY 2006, and were projected to increase to over \$8 million in 2007. Trend analysis shows that the progression of transactions and the dollars involved are increasing.

Staff Recommendation – Staff recommends approval of Decision Item #4, adding \$23,982 and 0.5 FTE General Fund for a Purchasing Agent. Approving this request will also change the following line items in the Executive Director's Office: S.B. 04-257 Amortization Equalization Disbursement - \$344, S.B. 06-235 Supplemental Amortization Equalization Disbursement - \$161, and Operating Expenses - \$250.

*Decision Item #5* – The Department requests \$26,884 and 0.5 FTE for a Budget Analyst II, bringing the Department to a full FTE Budget Analyst.

Currently the Department has a permanent part time Budget Analyst II (0.5 FTE). Due to the extensive nature of the duties of the position, responsibilities must be shared with the Resource Manage and Deputy Executive Director, even though the current incumbent spends 20 to 40 hours per month of uncompensated time to meet the deadlines imposed by the Executive and the Legislature. While the incumbent in the position has been willing to spend the extra time, he will be leaving the Department in 2008.

The Department states that the budget preparation duties exceed the permanent part-time employee's hours by the following amounts:

- The Deputy Director spends approximately 10 to 15 hours per week from July through December on budget preparation (260 to 390 total hours).
- The Resource Manager spends approximately 20 to 30 hours per week from July through December on budget preparation (520 to 780 total hours).
- The Budget Analyst spends approximately 10 to 15 hours per week year round in uncompensated time for budget preparation (520 to 780 total hours).

In addition to budget preparation, the Budget Analyst's duties include budget tracking, providing management reports on expenditure rates, federal fund tracking and state share tracking, and preparation of capital construction budgets.

Staff Recommendation – Staff recommends approval of Decision Item # 5, adding \$26,684 and 0.5 FTE General Fund to give the Department a full-time Budget Analyst (1.0 FTE). Approving this request will also change the following line items in the Executive Director's Office: S.B. 04-257 Amortization Equalization Disbursement - \$385, S.B. 06-235 Supplemental Amortization Equalization Disbursement - \$181, and Operating Expenses - \$250.

**Decision Item #7** – The Department requests permission to merge the Administrative Services line into the Personal Services line.

The request to merge the two lines has no budgetary impact. It would move 5.1 FTE and \$281,525 (comprised of \$146,992 General Fund and \$134,533 Federal Funds) to the Personal Services line from the Administrative Service Line, which would then be eliminated. Both lines are in the Executive Director's Office.

The Administrative Service line was added to the Executive Director's Office in the FY 1999-2000 Long Bill. The FTE in this line provide the administrative support in accounting, personnel, and purchasing for the management, expenditure and accounting of federal funds in the Master Cooperative Agreement for the funding of the National Guard.

According to the Department, personal services lines that have five or fewer FTE are difficult to manage because the funds allocated to them are based on the Option 8 calculation rather than the

actual costs of the positions. It is difficult for these lines to generate vacancy savings to pay for retirements and potential promotions as the responsibilities and duties of the person in such lines change over time. Consolidating lines with few FTE into the EDO-Personal Services lines allows for a more flexible, people oriented and cost effective management of those FTE and more properly incorporates them into the line that contains the rest of the Department's general administrative support personnel.

**Staff Recommendation** – Staff recommends approval of Decision Item # 7, merging the Administrative Services line with the Personal Services line in the Executive Director's Office. This item has no impact on the Department's or Division's overall budget.

Staff recommends an appropriation of \$2,147,047 and 34.7 FTE, comprised of \$1,922,542 and 32.0 FTE General Fund, \$3,624 and 0.1 FTE cash funds from armory rental fees, and \$220,881 and 2.6 FTE federal funds. The recommendation includes a personal services base reduction of \$(18,365). These amounts include Decision Items #4,5, and 7, for which staff recommends approval, but not Decision Item #3, for which staff does not recommend approval.

#### **HEALTH, LIFE, AND DENTAL**

The Department requests \$552,233, comprised of \$191,994 General Fund, \$474 cash funds exempt, and \$359,765 federal funds.

Staff recommends an appropriation of \$552,233, comprised of \$191,994 General Fund, \$474 cash funds from the Western Slope Military Veterans Cemetery Fund, and \$359,765 federal funds, pursuant to Committee common policy.

**Decision Item #1 - Deferred Maintenance on Armories.** During the State's fiscal downturn, the General Assembly cut approximately \$185,000 from the Department's operating expenses line item. Among the steps the Department took in response were selling, trading or leasing six armory facilities to reduce maintenance costs, changing from a 5 day/8 hour schedule to a 4 day/10 hour

schedule to reduce maintenance and utility costs, and authorizing only health and safety repairs and maintenance of existing facilities.

In FY 2006-07, General Assembly approved restoring the \$185,170 General Fund that had been cut, however, by that time a maintenance backlog of approximately \$667,000 had accumulated. The General Assembly approved a one-time increase of \$220,527 General Fund to address about one-third of that backlog, and for FY 2007-08, the General Assembly approved \$194,891 General Fund to address the second one-third of the backlog identified in the previous year. For FY 2008-09, the Department is requesting \$254,419 General Fund to address the remaining third of the maintenance backlog, and to add that amount into the Department's base.

Under cooperative agreements with the federal government, the state is responsible for all maintenance costs on fifteen Colorado National Guard armories and 20 or 25 percent of the maintenance costs on four other facilities. Annual maintenance costs are increasing by approximately \$200,000 per year, due to the age of the armories and the high operations tempo of the Global War on Terror.

The Department requests that this funding be made part of the Department's base for this line. The Department cites the Colorado Construction Cost Index, compiled by CDOT, which has gone from 160 to 280 during the period from 2001 to 2006, which represents an increase of 75% over that period of time. The Department has submitted a list of maintenance requests that are not part of the backlog that totals approximately \$1 million, which would be addressed in future years by granting this request to make the funds part of the base in this line.

Staff Recommendation – Staff recommends approval of the Department's request of \$254,419 General Fund to complete the backlog of maintenance and that this amount be added to the Department's base in this line.

**Decision Item #3 – Facilities Manager**. The Department requests \$4,155 General Fund Operating Expenses for the 0.5 FTE Facilities Manager (See Personal Services for justification narrative).

**Decision Item #4 – Purchasing Agent.** The Department requests \$250 General Fund in Operating Expenses for the 0.5 FTE Purchasing Agent (See Personal Services for justification narrative).

**Decision Item #5 – Budget Analyst.** The Department requests \$250 General Fund in Operating Expenses for the Budget Analyst (See Personal Services for justification narrative).

**Decision Item #8 – Transfer of Utilities Line to Operating Expenses Line.** The Department requests to merge the Utilities line into the Operating Expenses line to give the Department the ability to better manage its utilities expenses. The Department is not requesting an increase in either the (exclusive of Decision Items) Operating Expenses or Utilities lines.

The Department states that it needs flexibility to adjust its spending to cover fluctuations in utility costs for the armories for both general and federal funds. The Department has experienced wide variations in utilities expenses over the last eight years, with a general and pronounce trend upward

as energy costs in particular, have increased over that period of time. The Department's utilities expenses will continue to be shown with the Operating Expenses line (as is currently the case with the Western Slope Veterans Cemetery line and other lines in the Department), providing transparency to the expense.

Of the 21 agencies and departments of State government, only six (including this Department) have a separate Utilities line item in the Executive Director's offices, so this request is not out of line with the practice in most departments in State government. This request will not have an impact on the Department's budget, since both operating expenses and utilities lines are continuation budgets (outside of Decision Items). It will reduce the need for supplemental appropriations as the Department will have more flexibility to manage its utilities expense as part of the operating expenses.

Staff recommends approval of Department Decision Item #8, merging the Utilities line item into the Operating Expenses Line Item. This will have the effect of increasing the Operating Expenses line by \$1,116,859, comprised of \$635,552 General Fund and \$481,037 federal funds, while zeroing out all lines in the Utilities line item.

Staff recommends an appropriation of \$2,333,640, comprised of \$1,458,068 General Fund, 46,000 cash funds from real estate proceeds, and \$829,572 federal funds.

#### INFORMATION TECHNOLOGY ASSET MAINTENANCE

The Department requests a continuation of \$27,372 General Fund.

Staff recommends a continuation appropriation of \$27,372 General Fund.

#### **LEGAL SERVICES FOR 110 HOURS**

The Department requests a continuation of \$7,923 General Fund, and 110 hours of legal services for lawsuits, workers' compensation cases, and contract review.

Staff recommends a continuation of 110 hours for legal services. Staff recommendation for the appropriation is pending Committee common policy.

#### PURCHASE OF SERVICES FROM COMPUTER CENTER

The Department requests \$9,411 General Fund for services from the computer center.

Staff recommendation is pending Committee common policy.

#### **MULTIUSE NETWORK PAYMENTS**

The Department requests \$11,055 General Fund.

Staff recommendation is pending Committee common policy.

#### PAYMENT TO RISK MANAGEMENT AND PROPERTY FUNDS

The Department requests \$172,236 General Fund.

Staff recommendation is pending Committee common policy.

#### VEHICLE LEASE PAYMENTS

The Department requests \$48,618 General Fund.

Staff recommendation is pending Committee common policy.

#### LEASED SPACE

The Department requests \$44,978 General Fund for space leased for the Division of Veterans Affairs offices located at 7465 E. First Avenue in Denver.

Staff recommends continuation funding of \$44,978 General Fund.

# <u>CAPITOL COMPLEX LEASED SPACE</u> (Camp George West)

The Department requests \$89,745, comprised of \$68,120 General Fund and \$21,625 federal funds, for space at Camp George West.

Staff recommendation is pending Committee common policy.

#### **COMMUNICATIONS SERVICES PAYMENTS**

The Department requests \$11,392 General Fund.

Staff recommendation is pending Committee common policy.

#### **UTILITIES** (Decision Item # 8)

The Department is requesting, through Decision Item 8, to merge the Utilities line with the Operating Expenses line, transferring spending authority from this line to the Department's Executive Director's Office, Operating Expenses. (See the Decision Item narrative in the Operating Expenses Line above.)

Staff recommends merging this line with the Operating Expenses line, however if the Committee does not approve of this request, staff recommends a continuation appropriation of \$1,116,591, comprised of \$635,552 General Fund, and \$481,039.

#### LOCAL ARMORY INCENTIVE PLAN

The Department has statutory authority to spend armory rental proceeds for costs of operating armories outside normal hours. The spending authority is needed for costs of increased use of the armories for extended hours due to the Global War on Terror.

The Department requests \$46,610 cash funds from armory rental proceeds.

Staff recommends a continuation appropriation of \$46,610 cash funds from armory rental proceeds.

#### **DISTANCE LEARNING**

The Department requests \$3,000, comprised of \$1,000 cash funds and \$2,000 cash funds exempt from fees on distance learning facilities and equipment, to pay for distance learning programs.

Staff recommends a continuation appropriation of \$3,000 cash funds, from reserves in the Department of Military and Veterans Affairs fund and the Distance Learning Cash Fund.

#### COLORADO NATIONAL GUARD TUITION FUND

The Department requests \$825,803, comprised of \$175,803 General Fund and \$650,000 cash funds exempt from the Department of Higher Education.

The National Guard tuition assistance program reimburses Colorado public institutions of higher education for tuition for eligible National Guard members. H.B. 04-1347 provided additional funding for the program through annual transfers of up to \$650,000 from the Department of Higher Education/Colorado Commission on Higher Education/Financial Aid budget. The Department requests \$825,803, comprised of a continuation General Fund appropriation of \$175,803, plus the maximum transfer allowed of \$650,000 cash funds exempt.

The maximum transfer from Higher Education was not needed in FY 2006-07 due to the number of National Guard members who were activated and not in Colorado to take advantage of the tuition assistance program. Since then, deployments have remained steady while troop strength has increased, and demand for tuition assistance has increased. The Department is now experiencing its highest levels of tuition usage to date and expects continuation of that level next year.

# Staff recommends an appropriation of \$825,803, comprised of \$175,803 General Fund and \$650,000 reappropriated funds from the Department of Higher Education.

# ARMY NATIONAL GUARD COOPERATIVE AGREEMENTS

This line item funds programs that are 100 percent federally funded under the Department's cooperative agreements with the U.S. Department of Defense. The Department requests \$3,461,741 and 51.5 FTE federal funds.

This line item contains both personal services and operating expenses. Staff's recommendation for personal services is \$2,353,004 and include a base reduction of \$23,768, and operating expenses of \$1,083,533, all federal funds.

Staff recommends an appropriation of \$3,436,537 and 51.5 FTE federal funds. This includes a base reduction of \$(23,768).

The U.S. Department of Defense requires the Department to have a Direct Administrative Services Cost Plan, in order to receive funding for eight partially federally funded state FTE. It is a separate line item to track funding changes for those specific staff members.

The Department has requested, through Decision Item # 7, to merge this line with the Personal Services line (See discussion of Decision Item # 7 in the Personal Services section above.)

If the Committee's decision was not to approve this Decision Item, staff recommends a continuation appropriation of \$278,062 and 5.1 FTE, comprised of \$145,221 and 3.3 FTE General Fund, and \$132,841 and 1.8 FTE federal funds. The recommendation includes a personal services base reduction of \$2,809.

#### 2) DIVISION OF VETERANS AFFAIRS

The Division represents veterans in federal benefits claims, provides information and training to county veterans service officers, and maintains the Western Slope Military Veterans' Cemetery in Grand Junction. The State Board of Veterans Affairs makes grants for capital improvements and amenities at state veterans nursing homes, costs of state veterans cemeteries, costs of the Division, and for veterans programs operated by nonprofit veterans organizations from the Colorado State Veterans Trust Fund, which is derived from the tobacco settlement proceeds.

#### **VETERANS SERVICE OPERATIONS**

The Department requests \$591,237 and 8.0 FTE, comprised of \$587,728 and 8.0 FTE General Fund and \$3,509 cash funds exempt from the Veterans Trust Fund. The request is broken out by Personal Services (\$487,421 General Fund), and Operating Expenses (\$103,816 Total, \$100,307 General Fund and \$3,509 Cash Funds Exempt from the Veterans Trust Fund. The \$3,509 request from the Veterans Trust Fund is the cost of administering the fund.

Staff recommends a continuation appropriation of \$590,168 and 8.0 FTE, comprised of \$586,659 and 8.0 FTE General Fund, and \$3,509 reappropriated funds from the Veterans Trust Fund. The recommendation includes a personal services base reduction of \$4,997 and operating expenses of \$75,308.

#### COUNTY VETERANS SERVICE OFFICER PAYMENTS (Decision Item #2)

This line item funds payments to counties for administrative support of county veterans service officers. The payments serve to maintain a formal connection with the county officers. The Department requests \$213,154 General Fund.

**Decision Item #2** – The Department request \$124,354 General Fund for pilot program for increasing payments to counties for county veterans service officers.

The Department request is for pilot program to increase the payment to select Colorado counties for the work provided by County Veterans Service Officers. The State requires each county to have a County Veterans Service Officer. Some counties have full-time CVSOs, others have part-time or volunteer CVSOs, and at least two counties share a CVSO with another county. The State reimburses the counties at the rate of \$200 per month for a full-time CVSO and \$100 per month for a part-time CVSO. These rates have been in effect since 1996. The counties report that they spent \$1,229,223 supporting the program, while the state appropriation is \$88,800.

County Veterans Service Officers assist veterans in claiming earned benefits from the U.S. Department of Veterans Administration (VA), including compensation, pension, health care, vocational rehabilitation and employment, education and training, home loans, life insurance, dependents and survivors benefits, and burial. CVSOs often serve as the first point of contact between a veteran and the VA. They take information and refer the veteran's information to the State Veterans Service Officers, who, with power of attorney, are certified to represent veterans before the VA.

This request is for a pilot program for five counties (Arapahoe, Denver, El Paso, Jefferson and Mesa counties), which, if the pilot is successful, would be expanded statewide in FY 2009-10. The stipulations of the program include (1) maintaining support of the CVSO program and that additional funds be used to increase the effort to register veterans, and (2) the progress of the county expenditures would be reported with the number of newly registered veterans in those counties. According to figures from the VA, approximately one-quarter of the 426,271 veterans in the state have not registered with the VA, and may be losing out on benefits.

If successful in raising the number of veterans registered with the VA, the counties could be reimbursed for up to 25% of their expenditures in support of the program.

Staff recommends approval of Decision Item #2, an increase of \$124,354 to fund the pilot program to increase reimbursement to the counties for their support of the County Veterans Service Officers.

Staff recommends an appropriation of \$213,154 General Fund.

#### COLORADO STATE VETERANS TRUST FUND EXPENDITURES (Decision Item # 6)

The Department requests an appropriation of \$627,500, comprised of \$77,500 cash funds and \$550,000 cash funds exempt from the Veterans Trust Fund.

Under current law, trust fund expenditures in FY 2008-09 are limited to 55 percent of the amount transferred from tobacco settlement proceeds into the fund, plus any accumulated interest. (Section 28-5-709 (3)(b)(I)(B) C.R.S.).

**Decision Item #6:** The Department has requested a decision item to restore \$2,280,900 in funding to the Veterans Trust Fund. In FY 2002-03, the General Assembly took \$2,280,900 from the Veterans Trust Fund to shore up the General Fund during the State's fiscal crisis. The funds have not been repaid and the Department is requesting funding to restore those funds.

There are two bills introduced in the General Assembly to restore the funding. H.B. 08-1078 (Buescher, Morse) has moved through the House Committee on State, Veterans and Military Affairs, amended to restore interest, and is scheduled to be heard in the House Appropriations Committee, so the Department's request has been dealt with by legislation. H.B. 08-1077 (King) has been postponed indefinitely.

Staff recommends that the Committee take no action on this Decision Item at this time. H.B. 08-1078 would accomplish the Decision Items purpose.

Expenditures from the trust fund have been broken out as interest from the prior fiscal year (cash funds) and expenditures from the transferred principal (cash funds exempt). Pursuant to the Committee's policy regarding changes from cash funds exempt to reappropriated funds, these will be considered cash fund expenditures.

Staff recommends an appropriation of \$627,500 cash funds from the Colorado State Veterans Trust Fund. This appropriation includes \$77,500 in interest income from the fund and up to 55 percent of the transfers from the tobacco settlement proceeds (one percent of the total transfer up to a maximum of \$1 million.) The figures in this recommendation are based on OSPB's forecast. A more recent forecast is not available as of this writing, will be presented by the tobacco settlement analyst, at which time these figures may change.

#### OPERATIONS AND MAINTENANCE AGREEMENT FOR BUCKLEY/GREELEY

This line item funds personal services, operating expenses, and utilities for the Buckley Air Force Base. The proportion of General Fund to federal funds is based on the annual cooperative agreement between the Department and the U.S. Department of Defense. The Department requests \$2,072,610 and 26.1 FTE, comprised of \$458,484 and 5.4 FTE General Fund, and \$1,614,126 and 20.7 FTE federal funds.

Staff recommends an appropriation of \$2,059,999 and 26.1 FTE, comprised of \$456,018 and 5.4 FTE General Fund and \$1,603,981 and 20.7 FTE federal funds. The request is broken down in the following table:

#### BUCKLEY COOPERATIVE AGREEMENT

This line funds personal services, operating expenses, and utilities for the Air National Guard that are 100 percent federal funded. The Department requests \$988,949 and 17.5 FTE federal funds.

Staff recommends an appropriation of \$986,664 and 17.5 FTE federal funds. The recommendation includes \$875,758 for personal services, \$12,487 for operating expenses and \$98,419 for utilities.

#### SECURITY FOR SPACE COMMAND FACILITY AT GREELEY

The federal government pays the state to employ five full-time security guards at the Greeley facility. The Department requests \$215,170 and 5.0 FTE federal funds.

Staff recommends an appropriation of \$214,621 and 5.0 FTE federal funds. The recommendation includes \$210,212 for personal services and \$4,409 for operating expenses.

#### (4) FEDERAL FUNDED PROGRAMS

This section is included for information only. It describes funding that is managed by the Department but which is not subject to state appropriation and does not flow through the state accounting system. These programs provide training one weekend per month and two weeks per year for members of the Colorado National Guard. The requested level of federal funding reflects estimates of the federal

appropriation for federal fiscal year 2009, which runs from October 1, 2008 through September 30, 2009

#### PERSONAL SERVICES

Staff recommends the requested amount of 88,685,726 and 1,239.0 FTE federal funds.

#### OPERATING AND MAINTENANCE

Staff recommends the requested amount of \$59,142,560 federal funds.

#### CONSTRUCTION

Staff recommends the requested amount of \$39,100,000 federal funds.

#### SPECIAL PROGRAMS

Staff recommends the requested amount of \$715,700 federal funds.

# (5) DIVISION OF CIVIL AIR PATROL

The Civil Air Patrol is a federally-chartered nonprofit corporation, created in Title 10 of the U.S. Code (10 U.S.C. 9441), as an auxiliary to the U.S. Air Force. It is funded primarily by the U.S. Air Force and user fees. The organization has five statutory purposes, including: encouraging citizens to contribute to developing aviation and maintaining air supremacy; providing aviation education and training; and fostering civil aviation in local communities.

The Colorado Division of Civil Air Patrol was created to support the Civil Air Patrol, Colorado Wing. The mission of the Division of Civil Air Patrol is to provide support for and facilitate the operation of the Civil Air Patrol, Colorado Wing. The state grants funding to the organization, through the Division, for one full-time office position, operating expenses, and aircraft maintenance.
