**Department Request:** The Department submitted a net-zero non-prioritized FY 2012-13 supplemental request to correct two errors made during the original Governor's Office of Information Technology (OIT) staff transfer. The request moves one position from OIT to the Water Resources Division and one position from the Division of Parks and Wildlife to the OIT.

The Department had also previously submitted a November 1, 2012 change request R-10 to implement the same changes starting with FY 2013-14. With this request, the Department is in effect requesting that the position transfers be reflected starting with FY 2012-13.

This request is a part of a larger request submitted by the Governor's OIT. The Governor's request will be presented on January 17, 2013.

**Staff Recommendation:** Staff recommendation for this request is pending Committee approval of the Governor's OIT Supplemental 1 titled *OIT Staff Adjustments*. Staff asks permission to include the corresponding appropriations in the Department's supplemental bill when the Committee takes action on the Governor's OIT supplemental.

**Staff Analysis:** The table below shows the Department request to transfer one position from the Governor's OIT to the Water Resources Division (WRD) and one position from the Division of Parks and Wildlife (DPW) to OIT.

The Department states that this change is necessary because two existing positions were incorrectly identified during the 2010-11 OIT consolidation process.

The Department states that at the time of the 2010-11 OIT transfer, a position in WRD was listed as an IT Professional II and was transferred to OIT. However, the list showing this position as an IT professional was in error; this position was actually a Physical Scientist Researcher III and is responsible for managing the National Hydrography Dataset in Colorado and providing Geographic Information Systems (GIS) analysis support for WRD related to consumptive use analysis, water rights, dam break inundation and interstate compacts. The Department states that the position is currently fulfilling its job duties within WRD, but that WRD does not have spending authority for the position and is effectively absorbing the position's salary. Similarly, the spending authority for this position was transferred to the Purchase of Services from Computer Center line item even though OIT is not currently paying the salary of the employee.

Also, at the time of the transfer to OIT in FY 2010-11, the Department of Parks and Wildlife (DPW) had recently hired an IT Professional II. This position was not included in the overall OIT transfer due to the timing of the hire. Thus, funding for the DPW IT position remains within the appropriation for the DPW.
