SUBJECT Staff Comeback - Personnel and Statewide Compensation Policies, POTS Fund

Splits

At the Department of Personnel figure setting, staff provided a separate memo which identified that fund splits reflected in the Department budget request for personal services lines differed from fund splits reflected in the salary base included in the compensation template. This difference results in POTS appropriations that proportionally include more General Fund than other fund types when compared to the fund splits in the Department-wide personal services request.

Staff recommended that the Committee allow staff to adjust POTS fund splits to match the proportions included in the Department's personal services requests. The Committee tabled staff's recommendation and requested additional information from the Department for an explanation for the variance between the fund splits in the requested personal services lines and the fund splits in the salary base in the compensation template. Additionally, the Committee requested that staff similarly review the same for all departments.

• Based on further review of this issue, staff recommends no change to fund splits generated in the compensation templates at this time.

Staff is concerned that while there are reasons and explanations for variances, some reasons and explanations may not be best practice for budget transparency.

The primary budget element which appears as reappropriated funds in the budget but is considered General Fund appropriations is the use of indirect cost recoveries. The sole purpose of identifying indirect cost recoveries in the budget is to *offset* General Fund. In Department and statewide review of the POTS fund splits issue, staff included the amount identified as indirect cost recoveries as General Fund to adjust for this offset. However, although staff had already adjusted for this in analysis, this reason was a standard first explanation of variances from many departments.

Staff agrees that indirect cost recoveries fluctuate from year to year based on the annual adjustments in the indirect cost plan, and that indirect cost recoveries are intended to offset General Fund, therefore expenses paid for by indirect cost recoveries should properly be considered General Fund expenses.

In some cases, certain cash fund sources might be considered by a department to be cash funds which do not originate from typical program fee-generated sources and which are considered to be *one-time* cash funds and are used to *offset* General Fund.

An example of this are procurement card rebates used in the Division of Accounts and Control in the Department of Personnel. Such funds are used to pay for – or offset General Fund – in the Financial Operations and Reporting subdivision (the State Controller's Office) and the Procurement and Contracts subdivision. The Department views these funds as *bonus* funds used to offset

expenses that would otherwise be paid for with General Fund. However, these funds are included in the budget consistently from year to year. Such funds should perhaps be considered standard, available cash funds (which are spent on programs related to the purpose of their collection) rather than considered as bonus funds for programs that are otherwise General Funded.

Staff believes that cash funds that are used to support staff resources for a given program should similarly be used to pay for the POTS appropriations for those staff.

This may require a rebalancing of available funds which would lead to a similar overall outcome in appropriation. However, (1) given the scale of variance identified in this analysis and (2) given the flexibility provided for the allocation of POTS appropriations across a department, fully allocating cash funds for FTE in personal services appropriations and relying on General Fund for POTS appropriations for those FTE diminishes budget transparency. Tracking actual expenditures becomes more vague for the budget-setting process and the proper consideration of necessary appropriation amounts to support state agency programs from appropriate fund sources.

While at this time, staff does not make a specific recommendation to the Committee regarding this concern, staff will continue to research this issue and may bring recommendations to the Committee next year for addressing this concern.

Additionally, staff identified expenditure items included entirely as or set within personal services lines, which do not support program staff resources and in some cases support no FTE. Such expenditure items might include payments for contract services. Because these variances occur in departments outside of staff's working knowledge, it is difficult for staff to identify whether this is a problem and what solutions might be available.

Again, staff will continue to research this issue and bring recommendations at a future point.

The following tables outline staff's analysis of departments' personal services requests in comparison to their identified salary base in the compensation templates.
