DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT

Department Overview

The Department is comprised of administrative, health and environmental divisions. The primary responsibilities of each division are outlined below.

1) Administration and Support Division

- Provides department wide administrative services;
- Houses the *Health Disparities Program*, which provides grants for health initiatives aimed at reducing and eliminating disparities currently existing in the provision of health services across the state; and
- Houses the *Office of Planning and Partnerships* which oversees the distribution of state funds to local public health agencies.

2) Center for Health and Environmental Information

- Maintains a database of all Colorado births, deaths, marriages, and divorces;
- Provides birth and death certificates;
- Gathers and analyzes health data for use by public and private agencies; and
- Operates the Medical Marijuana Registry.

3) Laboratory Services

• Provides testing, analysis, and results reporting of laboratory tests on specimens and samples submitted by other divisions, departments, and private clients.

4) Air Pollution Control Division

- Performs statewide air monitoring, pollutant analysis, and air emission modeling;
- Researches the causes and effects of pollution from mobile vehicles and implements strategies aimed at reducing emission from mobile sources; and
- Permits, monitors, and inspects factories, power plants, and other commercial air pollutant emitters for compliance with air pollutant emissions standards.

5) Water Quality Control Division

- Issues waste water discharge permits and, if necessary, takes enforcement action to ensure compliance with water quality standards;
- Monitors the pollutant levels in rivers, streams, and other bodies of water;
- Conducts surveillance of public and non-public drinking water sources to ensure compliance federal and state water quality standards; and
- Reviews designs and specifications of new and/or expanding water treatment facilities.

6) Hazardous Materials and Waste Management Division

- Regulates the treatment, storage, and disposal of solid and hazardous waste in Colorado;
- Performs inspections of solid waste facilities;
- Oversees hazardous waste generators, transporters, and storage facilities; and
- Regulates commercial radioactive materials in Colorado.

- 7) Division of Environmental Health and Sustainability
 - Certifies and inspects wholesale food distributors and dairy processors;
 - Oversees restaurant, child care facilities, and school inspections by done local public health departments (with a few exceptions where the state is responsible for these inspections); and
 - Administers four sustainability programs (including the Waste Tire Program and the Recycling Resources Opportunity Program).

8) Disease Control and Environmental Epidemiology Division

- Responsible for identifying, containing, controlling, and tracking the spread of communicable diseases, with a focus on: hepatitis, tuberculosis, sexually transmitted infections, and HIV/AIDS; and
- Assesses the threat risk from environmental contaminants on human health, and when needed, takes action to contain and/or nullifying these threats.

9) Prevention Services Division

- Administers disease prevention programs including: the Tobacco Education, Prevention, and Cessation Program, and the Cancer Cardiovascular Disease, and Chronic Pulmonary Disease Prevention, Early Detection, and Treatment Program;
- Oversees the Nurse Home Visitor Program and Newborn Screening Program;
- Administers injury, suicide and violence prevention programs including the Tony Grampsas Youth Services Program;
- Operates the Primary Care Office and Oral Health Program; and
- Administers the following two federally funded food assistance programs: Women, Infant and Children (WIC) and Child and Adult Care Food Program.

10) Health Facilities and Emergency Medical Services Division

- Enforces, through certification and inspections, operational standards of health care facilities including hospitals and nursing facilities; and
- Inspects and certifies emergency medical and trauma service providers; and
- Contracts with a private provider for operation of the poison control hotline.

11) Emergency Preparedness and Response Division

- Works with local and other state departments to ensure Colorado is prepared for, and able to respond to, a variety of natural and man-made disasters; and
- Coordinates a statewide network of laboratories, local agencies, hospitals, and other resources that can be utilized during disaster response.

Committees of Reference SMART Act Recommendations

House Committee of Public Health Care and Human Services Received January 23, 2013 Recommendation

The House Public Health Care and Human Services Committee recommended the following changes:

- 1. an increase of \$4,266,501 General Fund to the School-based Health Centers line item;
- 2. an increase for the Medicaid Breast and Cervical Cancer Program to include treatment for women who are not initially screened at the Women's Wellness Connection.

The staff recommendation does not include an increase for School-based Health Centers or the Medicaid Breast and Cervical Cancer Program. Additional information is provided at the beginning of the Prevention Services Division.

Senate Committee of Health and Human Services Received January 24, 2013 Recommendation

The Senate Committee of Health and Human Services recommended an increase of \$4,266,501 General Fund to the School-based Health Centers line item. The recommendation does not include an increase for the School-based Health Centers. Additional information is provided at the beginning of the Prevention Services Division.

GENERAL NOTES ABOUT THIS PACKET

Staff Initiated Adjustments to Federal Funds and FTE

This document proposes a number of adjustments to the informational appropriations of federal funds. These appropriations are designed to reflect amounts that are anticipated to be received in FY 2013-14. The Department's November 1 request includes the amount of federal funds received in the two most recent fiscal years. The Department does not adjust the federal funds requests and simply sets the request equal to last year's appropriation. This approach is understandable given the uncertain status of a federal funds appropriation by the General Assembly and the difficulties that the Department faces when trying to forecast federal grant revenue. However, repeatedly setting the request equal to last year's request can create situations in which the federal funds listed in the Long Bill are badly out of date. Throughout this document, staff recommends adjustments to these federal funds amounts that are designed to bring these numbers into closer alignment with the federal funding that the Department has been receiving in recent years. Specifically, the staff recommendation is to set the FY 2013-14 federal funds appropriations equal to actual federal funds received in FY 2011-12, rounded to the nearest hundred. The recommendation to round to the nearest hundred is based on the fact that these are informational funds and trying to indicate down to the dollar the amount in the Long Bill projects a level of certainty staff does not have. Actions that the Committee may take to balance the budget later this session may alter these adjustments, and staff requests permission to make any necessary adjustments to align the informational federal funds appropriations with any committee policies.


This document also proposes a number of adjustments to FTE for line with more than 10.0 FTE, based on the most recent actual years use of FTE (i.e. FY 2011-12). These adjustments are done on a case by case basis and are intended to align the FY 2013-14 Long Bill with the most recent actual use of FTE.

Amendment 35 FY 2013-14 Projections

Amendment 35 was approved by the voters in 2004 and added the following two cigarette and tobacco taxes to Section 21 of Article X of the Colorado Constitution.

- 1. An additional \$0.64 tax on each pack of cigarettes sold in Colorado (a pack equals twenty cigarettes); and
- 2. A statewide tobacco products tax equal to 20.0 percent of the manufacturer's list price, on the sale, use, consumption, handling, or distribution of tobacco products by distributors.

Amendment 35 was added to statute in Section 24-22-117, C.R.S. by H.B. 05-1262 (Boyd / Hagedorn). Section 24-22-117, C.R.S. outlines how revenue from Amendment 35 is distributed to various state agencies including: the Departments of Health Care Policy and Financing, Public Health and Environment, and Human Services. The following graphic illustrates what departments and programs receive Amendment 35 tobacco tax 20.0 percent of the manufacturer's list price dollars.

INITIATIVES AFFECTING MULTIPLE LINE ITEMS

→ R-1: Financial Risk Management

- Request: The Department requests to transfer individuals currently funded with federal funds to reappropriated funds (an increase of \$154,453 reappropriated funds from indirect cost recoveries and 2.0 FTE) to expand the financial risk management process for grant applicants. The request includes an offsetting reduction of \$154,453 federal funds and 2.0 FTE.
- Staff recommends an appropriation of \$144,492 reappropriated funds and 2.0 FTE, which is offset by a reduction of 2.0 FTE to various programs.

Request: The Department requests funding to expand to all divisions the financial risk management process currently in three divisions to all divisions. The request seeks to fund the staff currently funded with federal funds and working on the financial risk management process and therefore limited by federal grant guidelines on which programs they can work with, to be funded with departmental indirects. This change will allow the staff to work with all divisions to implement the financial risk management process as part of the division's grant process. The request seeks an increase of \$154,452 reappropriated funds and 2.0 FTE from indirect cost

recoveries in the Administration division, offset by a reduction of \$154,452 federal funds and 2.0 FTE funded with federal funds from the divisions currently using the financial risk management process.

Recommendation: Staff recommends the personal services line item in the Administration division be increased by \$144,492 reappropriated funds and 2.0 FTE, and a total of 2.0 FTE be reduced from the various line items shown in the table below. The recommendation does include increases to the centrally appropriated lines because the staff are existing employees and the recommendation is intended to shift the employees funding source from federal funds to reappropriated funds. The recommendation differs from the request in two ways:

- the recommendation does not include the operating expenses for the two staff because they are existing, not new staff; and
- the recommendation does not include the reduction of federal funds because the federal funds not spent on personal services will be spent on operating expenses by the programs.

Analysis: The Department is utilizing 1.4 FTE in FY 2012-13 to implement a financial risk management process for contracts with Local Public Health Agencies (LPHAs). There are three divisions which have the majority of contracts with LPHAs: Disease Control and Environmental Epidemiology, Prevention Services Division, and the Office of Emergency Preparedness and Response.

The financial risk management process has enabled divisions issuing grant contracts with LPHAs to reduce or eliminate fiscal monitoring site visits while maintaining compliance with federal

funding requirements. This has saved staff time and enabled programs to standardize the basis for site visits. LPHAs have also benefited because the number of site visits has been reduced, and they are no longer required to submit routine supporting documentation with grant invoices saving time and resources.

Expanding the financial risk management process to all contractors with the department will enable programs to identify those contractors at highest risk of non-compliance with fiscal practices and increase the likelihood that wasteful or inappropriate grant fund expenditures will be quickly identified. The Department is developing, as part of the application process, the ability for program staff to recommend a contractor to the FRM process based on existing or prior performance issues. The current estimate is that approximately 30.0 percent or 400 contracts would be referred to the FRM process.

The reason the request seeks to transition two staff currently funded with federal funds to positions funded with indirect cost recoveries is because the staff are only able to work on the FRM process as it ties to LPHAs pursuant to the terms of the federal funds. Transitioning these staff to indirect cost funded positions will enable the staff to expand the scope of their work to all contractors with the Department.

→ Request R-2 – Lean Resources

- Request: The Department requests an increase of \$300,107 reappropriated funds and 2.0 FTE offset by a reduction of \$300,107 federal funds and 2.0 FTE to enable existing staff to work on Lean projects for all divisions.
- Staff recommends an appropriation of \$183,454 reappropriated funds and 2.0 FTE, partly offset by a reduction of 1.0 FTE to various line items.

Request: The Department seeks to build an internal department structure capable of implementing LEAN process throughout the Department. The request asks to fund 2.0 FTE, currently funded by federal funds, with indirect cost recoveries so the staff can work on projects outside of the scope allowed by the federal contract terms.

Recommendation: Staff recommends the personal services line item in the Administration division be increased by \$211,992 reappropriated funds and 2.0 FTE, and a total reduction of 1.0 FTE from the various line items shown in the table below. The recommendation includes increases to centrally appropriated lines because these are existing employees and the recommendation is intended to shift the employees from a federal funding source to reappropriated funds. The recommendation differs from the request in five ways:

- The personal services and associated centrally appropriated lines are lower for the Director position because staff used the personnel costs equal to those used in the Governor's Office request for Lean resources;
- The health life, and dental amount is equal to the recommendation two financial risk management positions to be consistent across the requests;
- the recommendation does not include the operating expenses for the two staff because the staff are existing not new employees;

- the recommendation includes \$15,000, not the requested \$25,000, for training based on the average training cost in the Governor's Office Lean resources request; and
- the recommendation does not include the reduction of federal funds because the funds not spent on personal services will be spent by the programs on operating expenses.

Analysis:

The request seeks the funding that will enable the Department to integrate Lean methodologies into the Department's operational strategy. The Department provided the following five measurable outcomes from FY 2012-14 Lean projects:

- 1. Reduction in the time citizens must wait to receive services. Example-a reduction from 180 days to 62 days the Concentrated Animal Feeding Operations (CAFO) permit application process required.
- 2. Reduction of permit application back logs. Example the 18 month CAFO permit back was eliminated in FY 2012-13.
- 3. Improvement of customer services by better communication and involvement in department activities. Example the creation of the air permitting stakeholder advisory group to provide a two way conduit of information sharing between the air division and its various stakeholder groups.
- 4. Reduction to the cost of providing services. Example Personnel cost per application in the Medical Marijuana Registry was reduced from \$3.18 per application to \$2.33 per application.
- 5. Increased Cost Savings including: increased staff attrition and reduced need to hire new employees; reductions in contractor costs; and operating expense savings. Example The

Prevention Services Division through multiple Lean projects realized operating savings of \$651,000 in FY11-12 and FY12-13 through the reallocation of 3 positions and the elimination of 4 unneeded positions.

The Governor's Office of State Planning and Budget (OSPB) also submitted a funding request for Lean resources. The primary difference between the requests is that the OSPB is focusing on improving processes related to interdepartmental communications and projects, and this request will expand Lean resources for Department programs. Even though the requests are for similar services, there are significant difference in the personal services and operating components. Since the services are similar staff used the figures in the Governor's request for the differences outlined above. Since the work being done is similar it would make sense that the costs would be similar regardless of which Department is paying for the services and therefore staff used the lower of the two requests.

- The Governor's Office used a base salary of \$90,000 per year. The Department of Public Health and Environment used a base salary of \$136,488 for one employee and \$70,992 for the second employee. The staff recommendation used the \$70,992 and \$90,000 salaries.
- The Governor's Office used a training cost of \$15,000 to \$22,000 for 25 to 30 employees, while the Department of Public Health used a cost of \$25,000 for 15 to 20 employees. The staff recommendation used \$15,000 for training costs because the Department is training fewer people than the Governor's Office and the training will not require travel.

(1) Administration and Support

The Administration and Support Division is comprised of three subdivisions:

- Administration subdivision which provides department wide administrative services;
- The *Health Disparities Program*, which provides grants for health initiatives aimed at reducing and eliminating disparities currently existing in the provision of health services across the state; and
- The *Office of Planning and Partnerships* which oversees the distribution of state funds to local public health agencies.

- An increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures.

Retirements

Description: The Department is required under state personnel rules to pay retiring and terminating employees for unused accrued leave. Pursuant to federal regulations in OMB Circular A-87, the Department cannot directly charge these costs to the federal grants. The Department uses indirect cost recoveries to pay these costs to federally funded employees. Any funds in this line item not required for the payout of federally funded employees is used to pay the leave payouts of General Fund and cash funded employees.

Request: The Department requests an appropriation of \$281,918 reappropriated funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends continuation of the FY 2012-13 supplemental, and recommends an appropriation of \$481,145 reappropriated funds.

Health, Life, and Dental

Description: This line funds the Department's share of the state's group health, life and dental insurance plans for state employees.

Legal Services

Description: This line item is used to reimburse DPA for the Department's share of the state's liability and property insurance.

Request: The Department requests \$99,162 reappropriated funds for this purpose. This request includes the following two changes:

- DPA common policy adjustment; and
- The non-prioritized request for funding for the employee engagement survey.

Recommendation: Staff recommendation is <u>pending</u> the approval of a Committee policy. Once a Committee policy is established, staff requests permission to adjust the line and apply a fund split.

Vehicle Lease Payments

Description: This line item provides funding for annual payments to DPA for the cost of administration, loan repayment, and lease-purchase payments for new and replacement motor vehicles used by the Department.

Request: The Department requests seven vehicles be replaced in FY 2013-14. The table below summarizes the Program which uses the vehicle and the replacement criteria.

The Department also requests, through a late budget amendment four hybrid sedans for temporary oil and gas inspectors.

Recommendation: The staff recommendation has the following three components:

- Staff recommends the replacement of seven vehicles shown in the table above be replaced based on the mileage and high maintenance cost criteria set forth by DPA. The mileage criteria states that non-state patrol vehicles with more than 100,000 miles should be replaced. The high maintenance cost criteria states vehicles with maintenance costs in excess of 100.0 percent of the average costs for that vehicle type should be replaced.
- Staff recommends three vehicles used by the Health Facilities Division for life safety code inspections are transferred to the Department of Public Safety assuming H.B. 13-1155 is passed prior to the Long Bill. If H.B. 13-1155 is not passed prior to Long Bill drafting this line item will need to be adjusted. Since staff will be presenting a comeback to set the line items impacted by H.B. 13-1155, staff will present any adjustments to this line item at that time.
- Staff does not recommended the four requested vehicles for the new FTE requested for the Air Pollution Control Division pursuant to the recommendation to deny the entire request.

The staff recommended dollar amount for this line item is <u>pending</u> the approval of a Committee policy, and staff requests permission, once a Committee policy is set, to adjust the line item and apply a fund split.

Leased Space

Description: The Department has eight leased spaces throughout the state. The "main campus" is located near the intersection of Colorado Boulevard and Cherry Creek Drive in Denver and houses the majority of the Department's programs and staff. There are additional spaces leased throughout the state primarily for the Air Pollution Control Division and Water Quality Control Division.

Request: The Department requests an appropriation of \$6,345,164 total funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: **Staff recommends an appropriation of \$6,250,000 total funds**. Staff's recommendation is based on the information provided in the Department's request and intended to provide the Department with the flexibility, if the actual leased space costs are different than projected. The following table outlines for FY 2013-14 where the Department will have leases and the cost of those leases.

Capitol Complex Leased Space

Description: The Department leases 3,996 square feet of space in the State Services Building in Grand Junction. Staff from the following divisions are housed at this location: Water Quality Control, Hazardous Materials and Waste Management, Disease Control, and Health Facilities.

Request: The Department requests an appropriation of \$34,164 reappropriated funds to cover the expenses of 3,996 square feet. The request includes the following two changes from the FY 2012-13 appropriation:

- DPA common policy increase; and
- Increase for the non-prioritized request for capital complex building repairs, upgrades and replacements.

Recommendation: Staff recommends funding for 3,996 square feet of space, and the reappropriated funds dollar amount is <u>pending</u> the approval of a Committee policy for this line.

<u>Utilities</u>

Description: The primary use of funds in this line item is for utility expenses incurred by the State Laboratory. Additionally the utility expenses incurred by remote monitoring stations used by the Air Pollution Division are funded from this line item. Utility expenses for leased spaces are included in the cost of the lease and appropriated in the leased space line item.

Request: The Department requests an appropriation of \$563,218 total funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$563,651 total funds. The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with the most recent actual expenditures.

Building Maintenance and Repair

Description: This appropriation funds maintenance and repair at the Department's main campus and at the state-owned laboratory building at Lowery.

Request: The Department requests an appropriation of \$271,858 reappropriated funds. The request includes no changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$271,858 reappropriated funds.

Reimbursement for Members of the State Board of Health

Description: This line time funds the \$50 daily per diem for State Board of Health Members when they attend board meetings pursuant to Section 25-1-104, C.R.S. All other approved travel expenses are paid through the operating expenses line item in this subdivision.

Request: The Department requests an appropriation of \$4,500 General Fund. The request includes no changes from the FY 2012-13 appropriation.

Recommendation: Staff recommendations the Department's request for an appropriation of \$4,500 General Fund.

Indirect Cost Assessment

Note this description of indirect cost assessments applies to each indirect cost assessment line item in the Department's section of the Long Bill.

Description: This line item funds the indirect cost assessments paid by the cash- and federallyfunded programs within this Division to cover the costs of the services provided by the Administration and Information Technology subdivisions. Indirect cost recoveries ensure that General Fund dollars are not subsidizing the provision of central services to cash- and federallyfunded programs.

Department's indirect cost assessment methodology:

- Calculation total cost of central services;
- Determination of the total amount of indirect cost assessments from federal funds, which is based on the federally approved federal funds indirect cost plan. This plan outlines the methodology used by the Department to calculate indirect costs, not the actual dollar amount of indirect costs.
- Once the plan is approved the Department calculates the actual dollar amount of federal indirect cost recoveries.
- The cash funds calculation is based on the total cost of central services less the amount of indirect costs from federal funds. The indirect cost assessment on each cash fund is based on a percentage of that specific cash funds total program costs divided by the sum of all cash funds total program costs.

Request: The Department request for this line item is simply a place holder until the FY 2013-14 indirect cost assessment can be calculated.

Recommendation: The dollar amount of staff recommendation is <u>pending</u> the Committee approval of the line item appropriations required to calculate the total cost of central services. Staff requests permission to set this line, and apply a fund split once these appropriations are set.

(B) OFFICE OF HEALTH DISPARITIES

The Office of Health Disparities administers the Health Disparities Grant Program created by H.B. 05-1262 which implemented the voter approved Amendment 35 Tobacco Tax. The mission of the Office is to overcome the differences in the quality of health care and associated health outcomes that current occur in different racial and ethnic groups across Colorado. The Office is primarily funded by 2.4 percent of the Amendment 35 revenue, and a small amount of General Fund.

→ Staff Initiated Change to Office of Health Disparities Funding Source

Request: The Department did not request this change.

Recommendation: Staff recommends the appropriation from the Health Disparities Program Fund to the Office of Health Disparities be changed from reappropriated funds to cash funds.

Analysis: Section 24-22-117 (2) (d) (III), C.R.S. enacted Amendment 35 into statute and requires that 2.4 percent of Amendment 35 revenue be appropriated to the Health Disparities Grant Program Fund for use by the Office of Health Disparities. The current Long Bill format shows the appropriation to the Office of Health Disparities as reappropriated funds from the Health Disparities Program Fund to try and account for the statutorily required appropriation made in the Prevention Services Division from the Prevention, Early Detection and Treatment Fund to the Health Disparities Grant Program Fund pursuant to Section 24-22-117 (2) (d) (II) (D) (III), C.R.S.

The issue with the current Long Bill format is that the reappropriated funds should only be equal to the funds appropriated in the Prevention Services Division. Any appropriation of unspent funds in the Health Disparities Program Fund should be cash funds. This is not the current format of the Long Bill and appropriating a small amount of estimated cash funds would unnecessarily increase the accounting workload of the Office. Since the appropriation in the Prevention Services Division is to the Health Disparities Grant Program Fund and not the Office and any unspent moneys remain in the cash fund to be appropriated in future years, the staff recommendation is to make the entire appropriation a cash funds appropriation from the Health Disparities Program Fund. This will allow the appropriation of unexpended funds as well as the appropriation of Amendment 35 revenue received in the next fiscal year to be a cash funds appropriated to the Office of Health Disparities, and appropriate the cash funds in the Health Disparities Grant Program Fund in a consistent manner.

Personal Services

Description: This line item funds the personnel expenses of the Office of Health Disparities.

Request: The Department requests an appropriation of \$271,569 totals funds, of which \$50,539 is General Fund, and 4.3 FTE. This request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$271,569 total funds, of which \$46,655 is General Fund and \$224,914 is cash funds and 4.3 FTE. The recommendation includes the change from reappropriated funds to cash funds.

Description: This line item funds the Office of Health Disparities operating expenses.

Request: The Department requests an appropriation of \$65,579 total funds, of which \$6,672 is General Fund. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$65,579 total funds, of which \$6,672 is General Fund and \$58,907 is cash funds. The recommendation includes the change from reappropriated funds to cash funds.

Health Disparities Grants

Description: This line item funds the grants awarded by the Office of Health Disparities. The dollar amount available each fiscal year is based on the amount of Amendment 35 tobacco tax revenue and unspent funds from the previous fiscal year.

Request: The Department requests an appropriation of \$2,960,063 reappropriated funds. The request includes a reduction based on the FY 2013-14 projected Amendment 35.

Recommendation: **Staff recommends an appropriation of \$3,699,149 cash funds.** The recommendation includes the following changes from the FY 2012-13 appropriation:

- the change from reappropriated funds to cash funds; and
- reduction based on the projected Amendment 35 revenue forecast offset by an increase to appropriate unspent funds from FY 2012-13.

(C) LOCAL PUBLIC HEALTH PLANNING AND SUPPORT

This subdivision provides Local Public Health Agencies (LPHAs) with planning, technical, and financial support to ensure that local public health agencies are able to effectively deliver health and environmental services. Senate Bill 08-194 made the following three fundamental changes to the structure of local public health services:

- Eliminated local health departments and nursing services, and created local public health agencies;
- Defined the duties of local public health agencies and local boards of health; and,
- Required the State Board of Health to:
 - Establish minimum qualifications for public health directors;
 - Define core public health services and quality standards
 - o Determine the funding formula for public health agencies.

→ R-3 Local Public Health Agency Funding

Request: The Department requests two changes to funding for Local Public Health Agencies:

- Consolidation of the two existing line items into a new line item;
- Increase funding for local public health agencies by \$375,466 General Fund; and

Recommendation: Staff recommends the Environmental Health Services not Provided by Local Health Departments be combined into the Distributions to Local Public Health Agencies line item; and funding for Local Public Health Agencies be increased by \$355,049 General Fund to bring the state contribution to local public health services up to \$1.23 per capita. Staff does <u>not</u> recommend the creation of a new line item.

The following table outlines the cost if Committee wishes to increase the funding by an amount greater than the staff recommendation to close the gap between what the counties are statutorily required to contribute and what the State is contributing.

Analysis:

Line Item Consolidation

The request to consolidate the line items is a result of creating local public health agencies in place of the health departments and nursing services. The Environmental Services Not Provided by Local Health Departments line item under the new structure is provided to smaller LPHAs that do not have the funds to conduct public health inspections like restaurant inspections. Prior to S.B. 08-194 this funding was utilized by smaller local public health departments. Now that local health departments and nursing services have been combined, continuing the existing Long Bill structure would continue the inefficiency of distributing funds to the same LPHA through two separate formulas.


Staff does not recommend the new line item because the change does not add any value to the Long Bill, and does not impact what services will be funded by the line item.

Increased General Fund

Part two of the request is to increase the State per capita funding from the FY 2012-13 level of \$1.18 per capita to \$1.23 per capita. Pursuant to Section 25-1-512 (1) (b) (I), C.R.S. each county must contribute at least \$1.50 per capita for local public health services. The following table shows that more than half of the agencies are contributing significantly more than the required \$1.50.

State funding for the local public health agencies comes from two different sources, General Fund and revenue from the Tobacco Master Settlement. The following table shows the appropriation for local public health agencies over the past five years.



The General Fund appropriations have remained relatively constant, while revenue from the Tobacco Master Settlement has continually declined. With an increase in General Fund dollars, the state's share of support for the provision of local public health services will decline to \$1.16 per capita, while statute requires counties to maintain their level of financial contribution to local public health services.

Staff recommends the Committee increase funding to Local Public Health Agencies by \$355,049 General Fund to bring the state contribution to LPHAs to \$1.23 per capita in FY 2013-14. Since the General Assembly has set minimum contribution requirements for counties, staff believes that the State has a similar responsibility to contribute a commensurate level of funds because without the Local Public Health Agencies, the financial burden on the State would be greater than the current level of state contributions to local public health services. The following tables summarize how the recommendation was calculated. Staff based the population on the State Demographers calendar year 2014 population to ensure that any funding provided for FY 2013-14 would account for the population growth throughout the fiscal year.

Step 1: Staff used information on calendar year populations to estimate what the population would be over the FY 2013-14 fiscal year (shown in table 1),

The additional General Fund dollars of \$355,049 combined with consolidating the line items will enable funds to be distributed to LPHAs in a fair and equitable funding formula that provides support to each local agency to implement legislatively required core services. If additional

moneys are appropriated and distributed through the funding formula LPHAs will be able to further implementation the Public Health Act and improve public health across the state.

Assessment, Planning, and Support Program

Description: This Program provides local public health agencies with planning, technical, and financial assistance in the development, and implementation and service delivery of health and environmental services.

Request: The Department requests an appropriation of \$671,121 total funds, of which \$308,652 General Fund and 8.4 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$666,855 total funds, of which \$308,652 is General Fund and 8.4 FTE. The recommendation includes a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the following table.

Distributions to Local Public Health Agencies

Description: This line item funds the moneys allocated to local public health agencies for provision of required health and environmental services pursuant to Section 25-1-512, C.R.S. These moneys are from the General Fund and 7.0 percent of the tier 2 tobacco-settlement revenues.

Request: The Department requests no appropriation for this line item; the request includes consolidating this line item into the requested Distribution to Local Public Health Agencies for Provisions of Public and Environmental Health Services.

Recommendation: Staff recommends an appropriation of \$8,477,758 total funds, of which \$6,531,478 is General Fund. The recommendation includes the following changes from the FY 2012-13 appropriation:

- An increase of General Fund for the local public health agency funding decision item; and
- Reduction of cash funds for the tobacco master settlement revenue projection.

Staff requests permission to adjust the total funds based on the Committee policy for tobacco master settlement revenue and the status of the two special bills at the time of the Long Bill.

The recommendation is calculated in accordance with Committee policy and outlined in the following table.

Environmental Health Services Not Provided by Local Health Departments

Description: Larger local public health agencies conduct their own environmental health inspections and cover these expenses from a combination of fees and local funds. The smaller agencies have two options: ask the Department to conduct these inspections for them, or conduct the inspections themselves and receive a subsidy from the Department. This line item funds the subsidy in option two for smaller local public health agencies.

Request: The Department requests no appropriation for this line item, and requests this line item be combined with the Distribution to Local Public Health Agencies into a new line item.

Recommendation: Staff recommends the Department's request for no appropriation to this line item.

Request: The Department requests this line item be created in FY 2013-14 and include the funding previously appropriated to the Distributions to Local Public Health Agencies and Environmental Services Not Provided by Local Health Departments line items. The request includes an increase of \$375,466 General Fund to increase funding for Local Public Health Agencies.

Recommendation: Staff does not recommend the creation of this line item pursuant to the recommendation to consolidate the two existing line items into the Distributions to Local Public Health Agencies line item.

Non-Appropriated Federal Funds

Request: The Department has requested, as part of the Lean Resources decision item a reduction to non-appropriated federal funds and FTE.

Recommendation: Since the funds are not appropriated it is not possible to show a negative number in the Long Bill, therefore staff does not recommend the request.

(2) CENTER FOR HEALTH AND ENVIRONMENTAL INFORMATION

This division gathers, analyzes and disseminates health and environmental data, provides birth and death certificates, administers the medical marijuana registry, and manages the Department's HIPAA compliance. This Division also houses funding for the Department information technology services provided by the Governor's Office of Information Technology.

OTHER SUBHEADING(S) TO DISCUSS DIVISION-WIDE ISSUES

→ Amendment 64 Impact on Medical Marijuana Registry

Staff inquired about the impact of Amendment 64 passing and was told that any budget actions would be held until recommendations were made by the Implementation of Amendment 64 Task Force. Executive Order B 2012-004 created the Task Force, which has twenty four members, including: four legislators (Representatives Pabon and Nordberg, and Senators Jahn and Marble), and Chris Urbina, the Executive Director of the Department of Public Health and Environment, and must submit recommendations to the General Assembly, Governor, and Attorney General no later than February 28, 2013. The Department has indicated any budget changes related to the recommendations will be submitted to the Joint Budget Committee after this date.

→ Information Technology Common Policies

The funding for the Departments costs of information technology services provided by the Governor's Office of Information Technology (OIT) are included in subdivision C. The recommendations for the centrally appropriated information technology (IT) line items will be made by Kevin Neimond, on February 21, 2013. The numbers shown in the numbers pages

represent the Department's request and will change based on the Committees policies. The four IT common policy line items are:

Purchase of Services From Computer Center; Multiuse Network Payments; Management and Administration of OIT; and Communication Services

(A) HEALTH STATISTICS AND VITAL RECORDS

The Health Statistics Section collects, analyzes, and disseminates vital event and health survey data, which is used to monitor health trends, identify groups at risk for specific health problems, prioritize health issues, develop programs and policies, and evaluate the effectiveness of health promotion strategies. Data users include the Center for Disease Control, local public health agencies, and epidemiologists.

The Vital Records Section maintains the official records of all the births, deaths, marriages, divorces, adoptions, and name changes the occur in Colorado. The Voluntary Adoption Registry, which facilitates voluntary contact between Colorado-born adoptees 18 years of age and older and their birth parents is maintained by Section.

Personal Services

Description: This line item funds the personnel expenses of this subdivision. Approximately half the records staff is responsible for collecting, modifying and certifying birth and death records. The other half is responsible for the collection, preparation and analysis of health data including: behavioral health data such as the Pregnancy Risk Assessment and Monitoring System and the Behavioral Risk Factor Surveillance System. Funding for the staff who oversees the Medical Marijuana Registry was moved to a separate line item in FY 2012-13.

Request: The Department requests an appropriation of \$3,025,956 total funds and 45.8 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$3,134,304 total funds, of which \$5,887 is Medicaid reappropriated funds (\$2,944 net General Fund) and 49.1 FTE. The recommendation includes an increase of federal funds and FTE to align the FY 2013-14 Long Bill with recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the following table.

Operating Expenses

Description: This line item funds the operating expenses of the Health Statistics and Vital Records Sections.

Request: The Department requests an appropriation of \$758,866 total funds. The request includes a reduction of \$190,000 cash funds for the second year impact of H.B. 12-1041 which created an electronic death registration system in the Department.

Recommendation: **Staff recommends an appropriation of \$835,226 total funds.** The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The following table outlines how the recommendation is calculated.



(B) MEDICAL MARIJUANA REGISTRY

The Department is required to administer the Medical Marijuana Registry pursuant to Section 25-1.5-106 (2) (f), C.R.S. The Registry is the state database for all individuals who have satisfied the medical requirements to use medical marijuana and have paid the Medical Marijuana Registry fee.

→ Medical Marijuana Program Cash Fund Balance

The Medical Marijuana Program Cash Fund (Fund) provides the funding for the direct and indirect costs associated with the administration of the Medical Marijuana Registry. The fee is set by the State Board of Health and the amount of revenue is dependent on the number of people applying for medical marijuana identification card.



As outlined in the above table, the Department was aware of the excess fund balance starting in FY 2010-11 but did not adjust the fee until January 1, 2012, thereby building an excessive reserve. Without accounting for the impact of Amendment 64, the \$35 fee will provide sufficient revenue to cover the direct and indirect costs associated with administration of the Medical Marijuana Registry, but is not low enough to address the excessive reserve.

Constitutional and Statutory Limitations:

Both the Constitution and statute clearly outline the intent of the voters that the fee be sufficient to cover the costs of the Registry. Article XVIII, Section 14, (3) (i) of the Colorado Constitution states: "The state health agency may determine and levy reasonable fees to pay for any direct or indirect administrative costs associated with its role in this program". Section 25-1.5-106 (17) (a), C.R.S. states the moneys in the Fund shall be for the establishment, operations, and maintenance of the Medical Marijuana Program.

Pursuant to Section 24-75-402 (2) (g), C.R.S. the target reserve for the Medical Marijuana Program Cash Fund is 16.5 percent. Section 24-75-402 (3) (c) states

"If the amount of uncommitted reserves of any cash fund at the conclusion of any given fiscal year exceeds the target reserve or an alternative reserve balance otherwise specified for the cash fund in the constitution or by law, each entity that collects one or more of the fees deposited in the cash fund shall by rule or as otherwise provided by law reduce the amount of one or more of said fees to an amount calculated to result in an amount of uncommitted reserve balance otherwise specified for the cash fund in the constitution or by law; each entity that reserves of the cash fund for the current fiscal year that does not exceed the target reserve or the alternative reserve balance otherwise specified for the cash fund in the constitution or by law."

It would appear the requirements outlined on the use of the funds, the slow response by the Board of Health to lower the fee, and the statutory reserve requirements have the Medical Marijuana Fund in a difficult situation because the balance cannot be reduced by transferring

funds out violating statute, but leaving the reserve untouched also violates statute. The General Assembly has four options for addressing the significant excess fund balance, two of which clearly comply with the constitutional language (options 3 and 4) and two of which do not clearly comply with the constitutional language (options 1 and 2):

- 1. Transfer the funds to the GF \$3.0 million was transferred in FY 2010-11;
- 2. Reappropriate funds to substance abuse programs;
- 3. Require the Department to refund individuals who paid the fee
- 4. Do nothing.

The passage of Amendment 64 further complicates the issue of how to address the excess reserve, because it is unknown at this time what impact the passage of Amendment 64 will have on the size and demand for the Registry.

Personal Services

Description: This line item funds the personnel expenses of the Medical Marijuana Registry.

Request: The Department requests \$1,928,192 cash funds and 38.8 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$1,928,192 cash funds and 25.9 FTE, calculated in accordance with Committee policy. The recommendation includes a reduction of FTE to align the FY 2013-14 Long Bill with recent actual FTE use. The Registry converted 20.0 FTE from temporary to permanent in FY 2011-12 based on the desire to ensure there was no backlog of issuing Registry cards. Since the Registry only used 25.9 FTE in the year when the backlog was eliminated, staff believes the 25.9 FTE level is a sufficient level that enables the Registry to issue cards in a timely manner.

Operating Expenses

Description: This line item funds the operating expenses of the Medical Marijuana Registry.

Request: The Department requests an appropriation of \$172,110 cash funds. The request includes a reduction of \$46,800 cash funds for funds reappropriated to the Department of Public Safety for the development of an interface between the Registry, the Department of Revenue and the Colorado Crime Information Center.

Recommendation: Staff recommends the Department's request for an appropriation of \$172,110 cash funds.

Transfer to DORA for Medical Marijuana

Pursuant to Section 25-1.5-106 (7), C.R.S. the Colorado Board of Medical Examiners in the Department of Regulatory Agencies was able to utilize dollars in the Medical Marijuana Program Fund dollars for the costs associated with the investigation and prosecution of medical doctors found to be in violation of the laws governing the doctor-patient relationship for medical marijuana patients. The Board of Medical Examiners is the state board responsible for the

regulation of medical examiners in Colorado. This line item will only appear in the numbers pages pursuant to Section 25-1.5-106 (7) (II), C.R.S. the language allowing Medical Marijuana Program Fund dollars to pay for the expenses incurred by the Board of Medical Examiners was repealed effective July 1, 2012. This line item will not appear in the FY 2013-14 Long Bill and only appears in the numbers pages for historical information.

(C) INFORMATION TECHNOLOGY SERVICES

This subdivision funds the costs of information technology services provided to the Department by OIT, as well as information technology costs not subject to the OIT consolidation.

→ NPI-4: OIT Enterprise Asset Management

Request: The Department requests \$22,432 reappropriated funds to the Department's share of an executive branch request to inventory all state IT assets.

Recommendation: Staff recommendation will be presented by Kevin Neimond on February 21 2013 during the Governor's Office figure setting presentation.

→ BA 1 – COFRS MODERNIZATION

Request: The Department requests a to change the fund sources in this line item as a result of federal rules preventing the use of federal grant funds on capital construction projects.

Recommendation: Staff recommends the Department's request.

Analysis: The federal government prevents any federal grant funds, either directly billed or collected through indirect costs, from being used for capital construction projects. The contract with the vendor does not include directly bill federal funds shown in other Department's COFRS Modernization line items but contract does include all the federal funds collected through this Departments indirects cost collections because they are shown as reappropriated funds in the line item. The request seeks to directly bill all cash funds and add General Fund to replace the dollars initially anticipated to be collected through federal indirect cost assessments. The restriction was not known at the time the appropriation was set for FY 2012-13. Staff does not believe this request violates Section 24-75-1300, C.R.S., which prevents the backfill of federal funds with General Fund because these federal funds were never collected in the first place, meaning that there is nothing to backfill.

Personal Services

Description: This line item funds the personnel expenses associated with the staff who manage the budget and payments to the Governor's Office of Information Technology (OIT) for the provision of information technology services.

Request: The Department requests an appropriation of \$320,931 total funds and 2.8 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$320,931 total funds and 2.8 FTE

Operating Expenses

Description: This line item funds information technology services that cannot be directly allocated to a specific program or division.

Request: The Department requests an appropriation of \$765,146 total funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department request for an appropriation of \$765,146 total funds.

Purchase of Services from Computer Center

Description: This line item is used to reimburse OIT for the Department's share of the state's computer system, and is one of four IT common policy line items.

Request: The Department requests an appropriation of \$5,040,367 total funds, of which \$226,912 is General Fund. This request includes the following changes:

- reduction of \$317,102 total funds, of which \$75,287 is General Fund for the IT common policy adjustment; and
- an increase of \$22,432 reappropriated funds for NP1-4 OIT enterprise asset management request.

Recommendation: Staff's recommendation is <u>pending</u> Committee policy for this line item. Staff requests permission to adjust the line item once Committee policy is established.

Multiuse Network Payments

Description: This line item reimburses OIT for the Department's share of the statewide multiuse network, and is one of four IT common policy line items.

Request: The Department requests an appropriation of \$456,672 reappropriated funds. The request includes a reduction of \$186,204 reappropriated funds for the IT common policy adjustment.

Recommendation: Staff's recommendation is <u>pending</u> Committee policy for this line item. Staff requests permission to adjust the line item once Committee policy is established.

Management and Administration of OIT

Description: This line item is used to pay OIT for the Department's share of costs for the management and administration of OIT, and is one of four IT common policy line items.

Request: The Department requests an appropriation of \$236,406 reappropriated funds. The request includes a reduction of \$229,645 total funds for the IT common policy adjustment.

Recommendation: Staff's recommendation is <u>pending</u> Committee policy for this line item. Staff requests permission to adjust the line item once Committee policy is established.

Communication Services Payment

Description: This line item provides the funds for the Department's share of the state's public safety communications infrastructure, which is maintained by OIT, and is one of four IT common policy line items.

Request: The Department requests an appropriation of \$15,237 reappropriated funds. The request includes a reduction of \$13,036 reappropriated funds for the IT common policy adjustment.

Recommendation: Staff's recommendation is <u>pending</u> Committee policy for this line item. Staff requests permission to adjust the line item once Committee policy is established.

COFRS Modernization

Description: This line item was created in FY 2012-13 and funds the five-phase project to replace the statewide accounting system (COFRS) used by the Office of the State Controller to record all state revenues and expenditures.

Request: Pursuant to the budget amendment, the Department requests an appropriation of \$699,370 total funds, of which \$417,565 is General Fund. The request includes the annualization of the FY 2012-13 supplemental to change the fund sources in this line item as a result of federal rules preventing the use of federal grant funds on capital construction projects.

Recommendation: Staff's recommendation is <u>pending</u> Committee policy for this line item. The recommendation for COFRS funding will be made during the Capital Construction figure setting presentation on March 15, 2013. Staff requests permission to adjust the line item once Committee policy is established.

(D) INDIRECT COST ASSESSMENT

Request: The Department request for this line item is a place holder until the FY 2013-14 indirect cost assessment can be calculated.

Recommendation: The dollar amount of staff recommendation is <u>pending</u> the Committee approval of the line item appropriations required to calculate the total cost of central services. Staff requests permission to set this line, and apply a fund split once these appropriations are set.

(3) LABORATORY SERVICES

The state public health and environmental laboratory conducts over 290 different laboratory tests including water testing, newborn screening, food and milk testing, drug and alcohol techting, rabies testing, bacteria and virus testing, West Nile virus testing, and environmental testing. The Laboratory provides fourteen different services including expert testimony, accredited training for testing professionals, and on-site equipment inspections and certifications.

→ Staff Initiated Long Bill Simplification

Request: The Department did not request this change.

Chemistry and Microbiology Personal Services

*LINE ITEM MOVED FROM (3) (B) FOR FY 2013-14

Description: The Chemistry and Microbiology Section of the Laboratory conducts tests and analysis for a variety of state programs, including the Water Quality Control Division and the Colorado State Patrol, as well as private, non-state clients. This section of the lab analyzes blood, urine, and bodily fluid specimens, performs water and environmental testing, and analysis for disease outbreaks and newborn screenings. This line item funds the personnel expenses of this section of the State Lab.

Request: The Department requests an appropriation of \$4,927,419 total funds, of which \$743,576 is General Fund and 52.3 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$5,202,101 total funds, of which \$743,576 is General Fund and 57.7 FTE. The recommendation includes an increase of \$274,682 federal funds and 5.4 FTE to align the FY 2013-14 Long Bill with recent actual expenditures and FTE use. The recommendation is calculated in accordance with Committee policy and is outlined in the following table.

Air Pollution Control Division Request for Information

Request for Information

Department of Public Health and Environment, Air Pollution Control Division -- The Department is requested to submit a report on CHANGES IN WORKLOAD AND STAFFING NEEDS OF the Air Pollution Control Division FROM THE NEEDS REPORTED TO THE JOINT BUDGET COMMITTEE ON NOVEMBER 1, 2012. This report is requested to include a summary of the Division's current and anticipated workload, including the impact of existing and proposed federal and state program requirements, as well as the associated funding and staffing needs, and the impact of the new resources added in FY 2012-13 on the backlog of permit applications and any additional resources need to completely eliminate the backlog. This report is requested to include information on the upcoming fiscal year and out years. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012 2013.

<u>Comment</u>: The report submitted on November 1, 2012 indicated there was still a need for additional FTE. **Staff recommends the request be modified to report to the General Assembly on the change in FTE need from the prior year.** This will provide a clear picture of what sections of the division have a growing need and which sections do not.

→ Request BA-7 – Air Pollutant Emissions and Dispersion Study

- The Department requests \$590,086 cash funds in FY 2013-14 to conduct a study of air emissions and pollutants in the North Front Range. The request includes the addition of a footnote authorizing roll-forward spending authority of these funds through FY 2015-16.
- Staff recommends the appropriation of \$590,086 cash funds but does <u>not</u> recommended the roll-forward spending authority.

Request: The Department requests funding for an air pollution study of the North Front Range areas. Specifically the request:

- 1. \$590,086 cash funds from the Oil and Gas Conservation and Environmental Response Fund for the first year costs of a contract with Colorado State University to study air pollutant emissions from the oil and gas industry in the North Front Range area;
- 2. Roll-forward spending authority of the appropriation; and
- 3. New line item for this appropriation.

Recommendation: Staff recommends:

- an appropriation of \$590,086 cash funds in FY 2013-14.
- a new line item, Air Quality Dispersion Study, be created for this appropriation.

Staff does <u>not</u> recommend the footnote authorizing roll-forward spending authority because any unspent funds in FY 2013-14 can be included in the figure setting recommendation for FY 2014-15. Staff does recommended

Analysis: There exists a limited amount of data concerning air emissions in the North Front Range area associated with the drilling, completion, production, and processing phases of oil and gas operations. The extensive growth of the oil and gas industry in the North Front Range area compounded by the lack of data on the impacts of this growth makes it difficult to project what, if any, health risks may be related to air pollutants emitted by the oil and gas industry. Additionally, lack of data makes it difficult for the Department to implement effective air emissions regulations on oil and gas operations designed to ensure air quality is not adversely impacted by pollutants emitted by oil and gas operations.

The time of the study is spread over three fiscal years:

Funding for this request is from the Oil and Gas Conservation and Environmental Response Fund which receives a mill levy charged on the market value at the well, of all oil and natural gas produced, saved, and sold or transported from the field. The fee may not exceed 1.7 mills on the dollar. The request indicates that current rate of 0.7 mills is anticipated to be sufficient to fund expenditures in the Department of Natural Resources as well as this request. **Staff recommends, the General Assembly include a request for information indicating that if the existing fee becomes insufficient to fund this request the Department notifies the Joint Budget Committee of the issue prior to adjusting the fee. Additionally Section 34-60-122, C.R.S. requires the Oil and Gas Conservation Commission set the mill levy rate at a level that ensures the two year average Fund balance does not exceed \$4.0 million. The following table illustrates even with this request, the Fund is projected to have a year end fund balance in excees of \$4.0 million.**

Section 34-60-124 (4), C.R.S. authorizes the Fund to be used for the following activities that occur prior to, during, or after oil and gas operations:

- Investigate, prevent, monitor, or mitigate conditions that threaten to cause, or that actually cause, a significant adverse environmental impact on any air, water, soil, or biological resource;
- Gather background or baseline data on any air, water, soil, or biological resource that the commission determines may be so impacted by the conduct of oil and gas operations; and
- Investigate alleged violations of any provision of this article, any rule or order of the commission, or any permit where the alleged violation threatens to cause or actually causes a significant adverse environmental impact

This request falls under the second allowable use to gather data on any resource that may have been impacted by oil and gas industry activities. The second phase of the project will conduct a health risk assessment based on the data collected in the first phase. Funding for the second phase is not included as part of this request. The only concern staff has with not including funding for the health risk assessment is how effective would be it be to collect the data and not conduct the health risk assessment?

→ Request BA-8 – Two-Year Air Fugitives Inventory and Compliance Project

- The Department requests a total of \$1,524,918 General Fund over two years, \$492,776 General Fund and 5.0 FTE in FY 2013-14 to hire five temporary FTE who will use newly purchased infrared cameras while inspecting oil and gas sites.
- Staff does <u>not</u> recommend the request.

Request: The Department requests funding to purchase specialized infrared cameras and hire temporary staff to use the cameras to inspect oil and gas sites. The request includes the following five components:

- 1. \$492,776 General Fund and 5.0 FTE in FY 2013-14 for the Stationary Sources Program for temporary FTE and operating expenses;
- 2. \$66,000 General Fund for a one year extended warranty for each camera and maintenance and calibration costs of \$2,500 per year per camera;
- 3. \$29,440 General Fund to lease four hybrid sedans at a cost of \$4,800 per vehicle and additional mileage costs of \$2,560 per vehicle;
- 4. \$12,000 cash funds for the Department of Natural Resources to purchase additional computer server and storage capacity for data from the cameras; and
- 5. \$567,000 General Fund for a capital construction request to purchase six infrared cameras.

Recommendation: Staff does not recommend any components of the request.

Analysis: Infrared cameras (IR cameras) can "see" infrared light that is otherwise invisible to humans. These cameras have a specialized filter which allows the camera to visualize through light colors the emission of volatile organize compounds which impact air quality by contributing to ground level ozone.

Request Justifications

The request seeks to purchase six IR cameras for use by this Department and by the Department of Natural Resources, and states that increased use of the IR cameras will "allow Colorado to focus on the compliance assistance and enforcement" of emission violations and help inform future regulatory initiatives that can target common leak points. By using the IR cameras for inspections and enforcement, oil and gas operators will have better information to "better design future systems that capture more gas, instead of perpetuating the building of leaking systems that have to be fixed with expensive retrofits".

The request seeks temporary employees and states that while the Department's existing inspectors are being trained on the IR camera the Department currently owns, training the employees on the new cameras is a "process that will take time and is separate from this request."

Justification of the Staff Recommendation

Staff recommends the Committee deny the request for seven reasons which are outlined below.

- 1. The request is a one-time expenditure of a total of \$1.5 million General Fund and does not establish any type of sustainable structure with the Stationary Sources Program once funding is eliminated.\
- 2. It is unclear what would happen with these cameras after the two years of funding ends since the request is not intended to enable existing inspectors to use the cameras but clearly indicates the temporary staff would be trained on and use the cameras.

- 3. The request clearly states that without enforcement the use of the IR cameras would be pointless, but does not provide any funding for all of the additional time existing enforcement staff will have to spend as a result of these new inspectors. The request clearly states, "the new inspectors will do nothing but IR camera surveys". The existing staff within the Division is not sufficient to handle a large influx of enforcement actions. The General Assembly added three enforcement positions in FY 2012-13 because of the Divisions inability to manage the existing workload.
- 4. One end-goal of using the IR cameras is to enable the development of regulations which establish a structure to address the emissions and violations found using the cameras. Staff questions if it is good policy to use an inspection method which can detect violations for which there is no existing regulatory structure and enforcement guidelines.
- 5. Since the Department has also requested funding for an air emissions and disbursement study, it would make sense to wait until the results of the study are known before embarking on an expensive temporary project.
- 6. Staff is concerned that part of the justification for the request is to help the oil and gas industry develop a better business model and questions whether this is an appropriate use of General Fund dollars.
- 7. The request seeks to purchase six cameras, five for the Department of Public health and Environment and one for the Department of Natural Resources, but funding for personnel to use the cameras is only provided to the Department of Public Health and Environment. Since the Department of Natural Resources does not current have a camera or staff with IR camera training, staff is uncertain how the department would implement the use of the camera without additional funding.

Staff is also concerned that the proposed program would treat sites differently because of the use of the IR camera. Is it equitable to the industry if one site is inspected with an IR camera which results in significant enforcement actions, while another site is not inspected with the IR camera, but may have similar violations which are not caught?

Lastly, staff would note there is no reason this budget amendment should have been submitted at such a late date (January 25, 2013) when there is no criteria that would have prevented this request to be submitted with the November 1 request or with other budget amendments on January 1, 2013.

(B) TECHNICAL SERVICES

Technical Services is responsible for measuring Colorado's air quality, compliance with the National Ambient Air Quality Standards, and the issuance of air quality forecasts and advisories. This subdivision houses three distinct programs: Air Quality Monitoring; Modeling and Analysis; and Visibility and Risk Assessment.

- the Air Quality Monitoring Program measures the Front Range air quality, and ensures that the Division is satisfying federal monitoring regulations and requirements. Ensuring compliance with federal monitoring regulations enables the Division to use the gathered data in State Implementation Plans (SIPs) of air pollution regulations, area redesignations, and permit compliance, Colorado must meet federal monitoring regulations
- The Modeling and Analysis Program provides technical support to other division programs for the State Implementation Plan (SIP) and the stationary source permitting program. The

Program is responsible for emission inventory development and air quality modeling that serves as the basis for evaluating the effectiveness of various control strategies and demonstrating that strategies adopted by Colorado will be sufficient to attain the National Ambient Air Quality Standards. The Program also performs ozone modeling related to the front range area's designation as an ozone non-attainment area in 2007.

• The Visibility and Risk Assessment Program houses three distinct programs: the Class I Area Program (national parks and wilderness areas), the urban visibility program, and the smoke management program, including issuing permits for prescribed burns.

(C) MOBILE SOURCES

This subdivision is comprised of two sections: (1) Research and Support, and (2) Inspection and Maintenance.

The Research and Support section is responsible for three different programs:

(1) The High Altitude Testing Program provides data to develop vehicle emissions factors that accurately represent Denver's vehicle population and emissions.

- (2) The Oxygenated Fuel Program is required under the federal 1990 Clean Air Act Amendments; its purpose is to reduce wintertime carbon monoxide emissions from automobiles through the use of cleaner burning gasoline.
- (3) The Clean Fuel Fleet Program is designed to reduce motor vehicle emissions through the introduction of cleaner burning engines and fuels into the marketplace.

The Inspection and Maintenance section works to reduce motor vehicle-related pollution through the inspection and emissions-related repair of motor vehicles. Emissions testing of gas and diesel powered vehicles is required when registering, renewing registrations, or selling vehicles within the program areas along Colorado's Front Range.

Personal Services

Description: This line item funds the Mobile Sources personnel expenses.

Request: The Department requests an appropriation of \$2,512,544 total funds and 29.3 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$2,657,694 total funds and 29.3 FTE. The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the table below.

Diesel Inspection / Maintenance Program

Description: The Diesel Program requires commercial operations with diesel fleets of at least nine vehicles, to self-inspect and certify that the vehicles are in compliance with state emission standards. This line item funds the activities of the Diesel Program including inspector certification and training, data collection, fleet self-certification, and technical assistance.

Request: The Department requests an appropriation of \$642,817 cash funds and 6.6 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$642,817 cash funds and 6.6 FTE.

Mechanic Certification Program

Description: This line item funds the Mechanic Certification Program which certifies independent emission inspectors who can test the emissions from 1981 and older vehicles, and fleet mechanics who have statutory authority to conduct emissions inspections on their fleet vehicles. The funding supports the development of course curricula, training materials, and the training and certification of emission inspectors.

Request: The Department requests an appropriation of \$7,000 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Departments request for an appropriation of \$7,000 cash funds.

Local Grants

Description: This line supports the development and implementation of the inspection and maintenance program in the form of grants to local governments to conduct research on issues pertaining to air quality attainment strategies.

Request: The Department requests an appropriation of \$77,597 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department request for an appropriation of \$77,597 cash funds.

(D) STATIONARY SOURCES

This subdivision is responsible for controlling and reducing air pollutants from stationary sources (i.e., factories, power plants, wood stoves, etc.). The staff permit, monitor, and inspect stationary source air pollution emitters. The subdivision houses the following three programs.

Inventory and Support Services Program is responsible for developing an inventory of pollution emissions from stationary sources, and is responsible for regulation development and maintenance, small business assistance, and permit fee invoicing.

Permits and Compliance Assurance Program is responsible for informing industry, through the permitting process, of which regulations apply to them; helping small businesses understand complex rules; encouraging compliance with air quality regulations by conducting periodic inspections of air pollutant sources; and pursuing enforcement actions, as necessary.

Hazardous and Toxic Control Program implements the federal Clean Air Act Amendments of 1990, which created a new and expanded program to control hazardous air pollutants, and required the control of ozone depleting compounds. This Program develops standards for hazardous air pollutants, trains and certifies asbestos technicians, and controls chlorofluorocarbons (CFCs).

Personal Services

Description: This line item funds the personnel expenses personnel responsible for the inventory and support services, permits and compliance assurance, and hazardous and toxic emissions control.

Request: The Department requests an appropriation of \$7,783,267 total funds, of which \$362,371 is General Fund and 97.3 FTE. The request includes an increase of General Fund and 5.0 FTE for temporary staff to use the infrared cameras on inspections of oil and gas locations.

Recommendation: Staff recommends an appropriation of \$7,429,591 total funds and 92.3 FTE, calculated in accordance with Committee policy. The recommendation <u>does not</u> include the General Fund and 5.0 FTE for the infrared cameras in accordance with the staff recommendation to deny the request. The recommendation does include an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The following table outlines how the recommendation is calculated.

Operating Expenses

Request: The Department requests an appropriation of \$416,540 total funds. The request includes a reduction of \$44,640 cash funds for one-time operating expenses appropriated in FY 2012-13 for the new permitters and inspectors added regulation of the oil and gas industry.

Recommendation: **Staff recommends an appropriation of \$462,347 total funds.** The recommendation <u>does not</u> include the General Fund operating expenses for the 5.0 FTE in accordance with the staff recommendation to deny the request. Preservation of the Ozone Layer

Description: This line item funds the Preservation of the Ozone Layer Program which works to reduce emissions of ozone depleting compounds, chlorofluorocarbons, and hydro-fluorocarbons by regulating the practices and procedures employed by the air conditioning and refrigeration service facilities in both automotive and stationary source industries.

Request: The Department requests an appropriation of \$228,739 cash funds and 2.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$228,739 cash funds and 2.0 FTE.

Air Quality Dispersion Study

*New Recommended Line Item for FY 2013-14

Description: This line item funds the contract costs with the Colorado State University to perform the Air Pollutant Emissions and Dispersion Study of air emissions from oil and gas operations in the North Front Range area from July 2013 to June 2016.

Request: The Department requests an appropriation of \$590,086 cash funds. This appropriation is new for FY 2013-14, and includes the request for roll-forward spending authority.

Recommendation: Staff recommends an appropriation of \$590,086 cash funds in accordance with the recommendation to approve the budget amendment. Staff does <u>not</u> recommend the roll-forward spending authority

(5) WATER QUALITY CONTROL DIVISION

The Water Quality Control Division does the following:

- Issues waste water discharge permits and, if necessary, takes enforcement action to ensure compliance with water quality standards;
- Monitors the pollutant levels in rivers, streams, and other bodies of water;
- Conducts surveillance of public and non-public drinking water sources to ensure compliance federal and state water quality standards; and
- Reviews designs and specifications of new and/or expanding water treatment facilities.

→ Staff Recommendation – Water Quality Control Division Fee Legislation

Recommendation: Staff recommends the Committee appropriate funding for 15.0 FTE for the Water Quality Control Division and sponsor legislation to make the following changes to the funding structure of the Water Quality Control Division:

- 1. Eliminate the Water Quality Control Fund and establish the following five cash funds:
 - a. Public and Private Utilities Clean Water Fund;
 - b. Construction Clean Water Fund;
 - c. Commerce and Industry Clean Water Fund;
 - d. Pesticides Fund; and
 - e. Water Quality Certifications Fund.
- 2. Allows the Water Quality Control Commission the ability to set and adjust the annual and service fees; and
- 3. Adjusts the appropriation for the 15.0 FTE to account for new cash fund revenues.

Analysis

Recommendation for New FTE

The Division is currently in an unwinnable situation, where demand for services is increasing but the Division has no revenue to enable them to hire additional staff to keep up with demand. While the demands on the Division continue to increase as the number of regulations, requirements, applicants, and inspections increase; the number of staff remains unchanged. The Division's inability to conduct inspections at a rate deemed acceptable by the EPA and the Division's ability to establish a presence in the community, process applications in a timely manner to encourage industries to do business in Colorado decreases.

For the last four years the General Assembly has required the Division to submit a response to questions about the work load demands and measures of the Division. The Division has indicated in the response the need for staff is significant and is not going away. Staff believes it is the responsibility of the General Assembly to provide the Division with the ability to charge appropriate fees and properly staff the programs responsible for ensuring the quality of state waters. The following table summarizes the Division's FTE need in FY 2013-14.

During the past four months the Department has worked with staff to prioritize which of the 31.9 FTE are needed in FY 2013-14 and can be hired in FY 2013-14. The recommendation, shown in the table titled Summary of Staff Recommendation for Increased Resources for the Water Quality Control Division on the following page is based on the Division's prioritization.

The recommendation for FTE does include 1.0 FTE funded with General Fund for the Pesticide Permitting Program. The recommendation is based on the requirement the State have a Pesticide Permitting Program. The Department was unable to determine the number of possible permit holders through a stakeholder survey. Uncertainty federal legislation clearly exempting pesticide application from the Clean Water Act, and as shown in the following table, results in a large variation in the estimated number of impacted stakeholders.

The federal requirement that Colorado have a pesticide discharge permitting program coupled with the uncertainty regarding the number of fee payers is the basis for recommending the FTE and that the FTE be funded with General Fund. If the Committee wishes to fund the position with cash funds, the fee based on the data from the Division would range from \$1,248 to \$1,836 per application.

The total increase for the Clean Water Program indicates fee revenue through the recommended legislation would be a mixture of General Fund and cash funds. Without the recommended legislation, and for the purpose of figure setting the Long Bill, staff recommends all 16.0 FTE be funded with General Fund since there are no available cash funds. If the legislation is passed, the appropriation clause would adjust the appropriation. It is estimated that in FY 2013-14, 25.0 percent of the total revenue would be generated from the new fees. The following table shows the estimate of cash fund revenue through FY 2015-16.

In order to demonstrate to stakeholders and industry fee payers that the General Assembly's recognizes the public benefit of clean drinking and non-consumable water, staff recommends the General Fund appropriation as part of the recommendation to add FTE.

The increase in operating dollars for the analysis of water samples by the State Laboratory will result in an increase in the Laboratory Services Division. The increase in operating dollars for the development and implementation of a monitoring program of surface water for pesticide levels will result in an increase of reappropriated funds to the pesticide testing laboratory in the Department of Agriculture.

Water Fee Legislation

Currently the Clean Water Program is funded primarily by a single cash fund, the Water Quality Control Fund. In order to increase the transparency of how funds are used by the Division, staff recommends the creation of five new cash funds for the Clean Water Program. The recommendation includes the elimination of the Water Quality Control Fund and the Industrial Pretreatment Fund, and the creation of the following five new cash funds:

- a. Public and Private Utilities Clean Water Fund;
- b. Construction Clean Water Fund;
- c. Commerce and Industry Clean Water Fund;
- d. Pesticides Fund; and
- e. Water Quality Certifications Fund.

Creating cash funds specific to the existing work structure of the Division will enable better tracking of revenue and expenditures by specific function and impacted stakeholder group. Improved information will assist with improvements to the provision of services, appropriate fees and adequate staffing levels.

The proposed Public and Private Utilities Clean Water Fund, Construction Clean Water Fund, and Commerce and Industry Clean Water Fund represent three existing program areas which

comprise approximately 90.0 percent of the revenue of the existing Clean Water Fund. The recommendation aligns the Division permitting and inspection services with a specific funding sources and combines similar stakeholder groups, based on the types of activities they perform.

Public and Private Utilities Fund

<u>Purpose:</u> This fund will collect fees from permit and compliance obligations associated with the operation of sewage systems/domestic waste water treatment works, municipal separate storm sewer systems (MS4s), public water systems/water treatment facilities, and reclaimed water systems. The recommendation combines the existing Industrial Pretreatment Fund with this fund to streamline the funding for services provided to public and private utilities.

<u>Stakeholders:</u> Primarily municipalities and special districts, but also includes public entities providing services such as rest areas and campgrounds, private entities providing services such as housing (mobile home parks) and recreation (hotels and campground) facilities, and private industrial and commercial entities discharging into a publicly owned treatment works.

Construction Fund

<u>Purpose:</u> Revenue for the Construction Fund will be from fees collected from construction project owners and operators whose activities are subject to Colorado Water Quality Control Act and permit and compliance obligations associated with their projects.

<u>Stakeholders:</u> Home builders, transportation and utility project owners and contractors, and industries such as oil and gas operators who construct access roads and utilities.

Commerce and Industry Fund

<u>Purpose:</u> The Commerce and Industry Fund will receive fees paid by commercial and industrial operations whose activities result in a permitted discharge to waters of the State.

<u>Stakeholders:</u> Private business enterprises with operations in areas such as mining, oil and gas extraction, electrical power generation, food processing, automobile salvage, and timber harvesting. A small portion of the entities are public, and have a permitted discharge resulting from services such as airport operations and fish rearing operations.

Pesticides Fund

<u>Purpose:</u> Staff recommends a separate fund be created for the regulation of pesticides. Due to the newness of the pesticide program and the variety of stakeholders, creating a separate fund will enable the Division to track the needs and revenue associated with the Program.

Water Quality Certifications Fund

<u>Purpose:</u> Water quality certifications impacts water quality from various types of water supply and distribution and other construction projects and may require mitigation and post construction monitoring. The Colorado Governor's Office and Legislature have identified additional water storage and distribution projects as a high priority in response to the continuing drought conditions beginning in the early 2000s.

<u>Stakeholders:</u> There are five large water development projects that will require certification from the Division in the next two to three years. In addition to the five large projects outlined below, there are anticipated to be smaller water development projects requiring certification in the future.

- the Moffat Tunnel Expansion Project,
- Windy Gap Firming Project,
- Reuter Hess Reservoir Expansion,
- Chatfield Reallocation, Northern Integrated Supply Project (NISP), and
- Halligan-Seaman Project.

Biosolids Fund

Staff recommends the existing Biosolids Funds remain unchanged. The Water Quality Control Commission was granted the authority to establish fees within this fund for many years, and the framework has been and is expected to continue to be sustainable, with periodic refinement of the fee ceiling as defined in section 30-20-110.5 C.R.S. The Biosolids Fund contains fees collected from entities that apply biosolids for beneficial reuse.

Drinking Water Cash Fund

There are no recommended changes to the Drinking Water Cash Fund.

Clean Water Fee Type

Currently all fees paid into the Water Quality Control Fund are annual fees. Regardless of the amount of work, the fee remains the same for each year, which can result in a compounding resource shortage. Additionally if an application is submitted, reviewed, and then withdrawn, the Division has no mechanism to charge the applicant for the time devoted to the application. The recommendation includes a change to the existing statutory fee structure, to enable the division to continue charging annual fees, and to add fees, set by the Water Quality Control Commission, for the Division's time spent at inspections and application review. The structure would replace the initial annual fee an applicant pays with an application fee.

Permitting and certification services are provided at the request of the applicant. The Division issues a permit or application which enables the applicant to conduct their business operations consistent with federal and state regulations. Requested services for clean water include all permit actions except terminations, preliminary (anticipated) effluent limitations for new or expanded domestic wastewater treatment facilities, site application ELs, site application and design reviews, and certifications to discharge into navigable waters (401 certification). Based on the information gathered from a time tracking study in 2010, it is estimated that if broken out to an hourly rate, the application fee would be approximately \$70 per hour. The following table shows how this estimated fee compares to other hourly fees charged for other environmental divisions.

This new fee for service framework is projected to generate an adequate level of revenue to fund technical, administrative, and management staff currently providing permitting and certification services for the Division plus recommended additional FTE. As stated above, the Division estimates that fee revenue will take up to three years to generate the full amount due to the need to conduct stakeholder outreach and schedule a Rulemaking Hearing for the Water Quality Control Commission to set fees.

REQUESTS FOR INFORMATION

Water Quality Control Division Staff Needs Request

Department of Public Health and Environment, Water Quality Control Division -- The Department is requested to submit a report on CHANGES IN WORKLOAD AND STAFFING NEEDS OF the Water Quality Control Division FROM THE STAFFING NEEDS REPORTED TO THE JOINT BUDGET COMMITTEE ON NOVEMBER 1, 2012. This report is requested to include a summary of the Division's current and anticipated workload levels, including the impact of existing and proposed federal and state program requirements, as well as the associated funding and staffing needs based on the workload levels. This report is requested to include information on the upcoming fiscal year and out-years. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012.

<u>Comment</u>: The report submitted on November 1, 2012 indicated a significant need for additional FTE. **Staff recommends the request be modified to report to the General Assembly on the change in FTE need from the prior year.** The recommendation will provide a clear picture of what sections of the division continue to have a growing need and which sections are properly staffed based on the recommendation to add FTE in FY 2013-14.

Pesticide Permitting Program Request

Department of Public Health and Environment, Water Quality Control Division -- The Department is requested to submit a report on the National Pollutant Discharge Elimination System pesticide permit program. This report is requested to include a summary of the Water Quality Division's work, in collaboration with the Department of Agriculture, on establishing a pesticide permit. The report is requested to include a description of the permit options explored, funding options, staffing needs, and associated workload numbers for the upcoming fiscal year and out-years. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012.

Comment: **Staff recommends this request for information be discontinued** since any new information and change in staffing needs will be included in the request for information on staff needs of the Water Quality Control Division.

→ Staff initiated Recommendation: Eliminate Administration Subdivision

Recommendation: Staff recommends the funds shown in the Administration subdivision for personal services and operating expenses be moved into the Clean Water Program personal

services and operating expenses because the funding and staff in the existing Administration subdivision are solely for the Clean Water Program.

Analysis: The dollars in the Administration subdivision are solely used by the Clean Water Program. All administrative costs for the Drinking Water Program are appropriated directly to the Drinking Water Program. The previous staff recommendation to create more transparent cash funds will ensure the General Assembly is aware of how the funds are being spent, and the existing Long Bill structure merely adds additional unnecessary accounting steps.

(A) ADMINISTRATION

*Recommended to be Discontinued for FY 2013-14

This subdivision provides management and support staff for the Clean Water Program, and maintains a centralized records system for the Division. This subdivision is responsible for training and certifying the operators of all water and wastewater treatment facilities in the State.

Personal Services

Description: This line item funds the personnel-related costs for the Administration subdivision.

Request: The Department requests an appropriation of \$898,729 total funds, of which \$569,411 is General Fund and 11.6 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends no appropriation in accordance with the recommendation to move these funds and FTE to the Clean Water Program. The recommendation is calculated in accordance with Committee policy and outlined in the following table.

(A) CLEAN WATER PROGRAM

*RENUMBER TO (5) (A) FOR FY 2013-14

This subdivision is comprised of the Permits Section, Compliance and Enforcement Section, Watershed Unit and the Operations Program.

- The Permits Section issues discharge permits, and monitoring compliance with those permits;
- The Compliance and Enforcement Section conducts inspections, provides technical assistance, and as necessary, purses enforcement actions of regulated entities;

- The Watershed Unit conducts surface water sampling and assessment for the development and implementation of surface water standards through the Water Quality Control Commission.
- The Operations Program supports the entire Water Quality Control Division by providing administrative, fiscal, information management system support and financial outreach and coordination services for eligible municipalities for water and wastewater infrastructure projects.

Personal Services

Description: This line item funds the personnel expenses of the Clean Water and Operations Programs.

Request: The Department requests an appropriation of \$6,791,023 total funds, of which \$538,406 is General Fund and 78.5 FTE. The request includes a reduction of \$8,530 cash funds and 0.1 FTE for the second year impact of H.B. 12-1126 which modernized and simplified statutory regulations of onsite waste water treatment systems.

Recommendation: Staff recommends an appropriation of \$8,846,521 total funds, of which \$1,860,793 is General Fund and 103.6 FTE. The recommendation includes the following three changes from the FY 2012-13 appropriation:

- transfer of the personal services component of the administration subdivision to align the Long Bill structure with the operational structure of the Division and to eliminate unnecessary administrative burden;
- additional of 14.5 FTE funded with General Fund for additional resources;
- Adjustment to the informational federal funds adjustment.

Note if the Committee approves the staff recommendation to sponsor legislation modifying the funding structure of the Division, 10.0 FTE of the 14.5 FTE would be funded with revenue from the new cash fund fees. The appropriation clause of the proposed legislation would adjust the Long Bill appropriation to reflect the increased cash fund revenue generated by new fees that will be used to fund these FTE (reduce General Fund appropriation by \$196,224). If the Committee does not accept staff recommendation for legislative changes, all 14.5 FTE would be funded with General Fund due to insufficient cash fund revenue. Operating Expenses

Water Quality Improvement

Description: The Water Quality Improvement Program began in FY 2006-07 as a result of the passage of H.B. 06-1337, Water Quality Improvement Fund Penalties (Butcher/Entz). Statute specifies the factors used to base penalties for violations of water quality control provisions. The Program is required to spend the collected civil penalties on improving the water quality in impacted communities by awarding grants for water quality improvement projects, stormwater management training and best practices training to prevent or reduce the pollution of state waters and is allowed to use up to 5.0 percent of penalties for administrative costs.

Request: The Department requests an appropriation of \$167,196 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department request for an appropriation of \$167,196 cash funds.

The Drinking Water Program is established under the federal Safe Drinking Water Act, and implements measures to ensure Colorado's public water systems provide safe drinking water for Colorado citizens.

Request for Information

Department of Public Health and Environment, Hazardous Materials and Waste Management Division, Contaminated Site Cleanups and Remediation Programs -- The Department is requested to submit a report on its CERCLA program. This report is requested to include detailed expenditures for the program, including out-year estimates by project and associated project financing. The report should also include an analysis of long-term funding needs of the State in responding to, litigating, and cleaning up CERCLA sites, including estimated long-term maintenance costs for these sites. The report should also provide information on the Hazardous Substance Response Fund balance and out-year fiscal estimates. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012.

Comment: The report provides information on future state costs related to the oversight of superfund sites in the State. Since these costs do not change significant year to year, staff recommends the request be sent every other year. Therefore for FY 2013-14 staff recommends the request for information not be sent.

Request: The Department requests an appropriation of \$295,938 total funds and 3.4 FTE. The request includes a decrease of \$25,000 cash funds to eliminate the one-time funds provided in H.B. 12-1099 for the industrial hemp pilot program.

Recommendation: Staff recommends an appropriation of \$294,753 cash funds and 3.4 FTE calculated in accordance with Committee policy. The recommendation includes a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual federal expenditures. The following table outlines how the recommendation is calculated.

Legal Services

Description: This line item is used to pay the Department of Law for the provision of legal services for this division.

Request: The Department requests an appropriation of 2,222 hours. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends 5,232 hours of services, and the dollar amount is <u>pending</u> the Committee policy of the hourly rate for FY 2013-14 legal services. The recommendation includes the continuation of the increase of 3,010 hours approved for FY 2012-13 through the supplemental process.

Indirect Cost Assessment

Request: The Department request for this line item is a place holder until the FY 2013-14 indirect cost assessment can be calculated.

Recommendation: The dollar amount of staff recommendation is <u>pending</u> the Committee approval of the line item appropriations required to calculate the total cost of central

services. Staff requests permission to set this line, and apply a fund split once these appropriations are set.

(B) HAZARDOUS WASTE CONTROL PROGRAM

This Program is responsible for four primary program activities: permitting, compliance assurance, corrective action, and compliance assistance. This program monitors compliance and enforces hazardous waste regulation of over 100 large-quantity hazardous waste generators, 650 small quantity hazardous waste generators, hazardous waste transporters, over 3,000 very small quantity hazardous waste generators, about 100 hazardous waste transporters and over 50 hazardous waste treatment, storage and disposal facilities.

Personal Services

Description: This line item funds personnel-related costs for this Program.

Request: The Department requests an appropriation of \$4,131,343 total funds and 31.5 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: **Staff recommends an appropriation of \$4,355,769 and 31.5 FTE.** The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with the recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the table below.

(C) SOLID WASTE CONTROL PROGRAM

This program is responsible for the regulation of all solid waste management facilities in Colorado, including landfills, composting facilities, recycling facilities, transfer facilities, certain types of waste surface impoundments, asbestos waste facilities, solid waste incinerators, medical waste facilities, and scrap tire haulers and disposal facilities.

Program Costs

Description: This line item funds personal services and operating expenses for the Solid Waste Control Program.

Request: The Department requests an appropriation of \$2,765,749 cash funds and 23.8 FTE. This request includes a reduction of \$25,840 cash funds for the elimination of one-time operating expenses appropriated in FY 2012-13 for the additional staff added as part of the FY 2012-13 Solid Waste Program staffing increase.

Recommendation: Staff recommends the Department's request for an appropriation of \$2,765,749 cash funds and 23.8 FTE.

Waste Tire Management Program

Description: This line item funds the personal services and operating expenses for the Waste Tire Management Program, which was consolidated within the Department by H.B. 10-1018. The Department has established a comprehensive "cradle-to-grave" management system to track tires from the moment they are removed from a vehicle until they are appropriately disposed of or recycled. The Program is responsible for the following:

- Regulation of waste tire haulers and facilities that generate, collect, store, process and/or use waste tires;
- Awarding grants to local agencies for equipment, training and other activities related to prevention and response to waste tire fires;
- Developing initiatives designed to encourage the disposal, recycling or reuse of illegally dumped tires and the recycling or reuse of waste tires.

Request: The Department requests an appropriation of \$1,013,621 cash funds and 2.1 FTE. This request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$1,013,621 cash funds and 2.1 FTE.

(D) CONTAMINATED SITE CLEANUPS AND REMEDIATION PROGRAMS

Funding in this subdivision is for four programs that to oversee the cleanup and remediation of Superfund sites in Colorado.

- 1. Contaminated Sites Operations and Maintenance Program funds the long-term operation and maintenance at Superfund sites. For Superfund sites with no responsible party to assume the costs, the state assumes responsibility for sites upon completion of remedies.
- 2. Funding is provided to the Department of Law for the oversight of contracts for contaminated sites cleanup under the federal Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA).
- 3. Uranium Mill Tailings Remedial Action Program works to assure the proper cleanup of uranium mill sites that are under the primary responsibility of the United States Department of Energy. In addition, the state has the lead role in assisting local governments in the management of tailings that were not cleaned up under this Program, either because they were not detected, or because the contamination is located in areas where significant risk is not encountered until future development and repair activities are performed.
- 4. Rocky Flats Program is responsible for monitoring long-term operations and maintenance of continuing remedy components (i.e., ground water cleanups, landfill caps), and closing out the administrative aspects of the regulatory process for site remediation.

Personal Services

Description: This line item funds personnel-related costs for Contaminated Sites Operations and Maintenance Program

Request: The Department requests an appropriation of \$3,892,269 total funds and 21.4 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$6,131,427 total funds and 21.7 FTE. The recommendation includes an increase of \$2,239,158 federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the following table.

Transfer to the Department of Law for CERCLA-Related Costs

Description: This line item provides funding to the Department of Law (Law) for Law's oversight of contaminated site cleanup contracts under the federal Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA). Pursuant to CERCLA, Law has specific authority over ten sites around the state as a result of litigation.

Request: The Department requests an appropriation of \$972,542 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: The staff recommendation is <u>pending</u> the Department of Law figure setting (February 13, 2013). Staff requests permission to adjust the line based on the Committee action for the associated line item in the Department of Law.

Transfer to Law for Natural Resource Damage Claims at Rocky Mountain Arsenal

Description: This line item provides funding the Department of Law for an outside contractor who works on the revitalization of contaminated lands at the Rocky Mountain Arsenal.

Request: The Department requests an appropriation of \$50,000 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: The staff recommendation is <u>pending</u> the Department of Law figure setting (February 13, 2013). Staff requests permission to adjust the line based on the Committee action for the associated line item in the Department of Law.

Uranium Mill Tailings Remedial Action Program

Description: This line item funds personal services and operating expenses for the Uranium Mill Tailings Remedial Action Program. From 1991 to 1998, the Program provided for radioactive waste cleanup of nine uranium mill sites. Since 1998 the Program assists local governments in managing mill tailings that were not removed but which are disturbed during road work or other renewal or building activities. Reappropriated funds are from the Local Government Severance Tax Fund in the Department of Local Affairs.

Request: The Department requests an appropriation of \$219,656 total funds and 3.1 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$217,805 total funds and 3.1 FTE. The recommendation includes a reduction of \$1,851 federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the following table.

Rocky Flats Program Costs

Description: Prior to 2006, these funds were used to pay for oversight of the cleanup at the Rocky Flats Environmental Technology Site (formerly the Rocky Flats Plant). All physical remedial activities at Rocky Flats were completed in October of 2005, and the Comprehensive Risk Assessment and Remediation Feasibility Study was completed and approved on July 5, 2006. All hazardous waste units (tanks, storage pads, etc.) were closed and the Hazardous Waste Permit was terminated on July 26, 2006. The Record of Decision (ROD) was signed by EPA, Department of Energy, and CDPHE on September 29, 2006, and required no further remedial action. The post-closure agreement implementing the requirements of the ROD is the Rocky Flats Legacy Management Agreement (RFLMA).

The ROD identified two main areas on the site: one is completely clean and will be managed by U.S. Fish and Wildlife Service as a Wildlife Refuge, the other will be retained by the Department of Energy and managed by its Office of Legacy Management. The Division continues to have a regulatory oversight role in the implementation of the RFLMA and in coordination with local communities and the EPA. The Division is responsible for monitoring long-term operations and maintenance of continuing remedy components (i.e., ground water cleanups, landfill caps), and closing out the administrative aspects of the regulatory process for site remediation. This line item funds personal services and operating expenses for the RFLMA.

Request: The Department requests an appropriation of \$150,769 federal funds and 2.3 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$141,700 federal funds and 2.3 FTE, calculated in accordance with Committee policy. The recommendation includes a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The following table outlines how the recommendation is calculated.

Rocky Flats Legal Services

Description: This line item funds the cost of legal services related to the Rocky Flats Agreement. These funds are reappropriated to the Department of Law for the provision of legal services.

Request: The Department requests an appropriation for 139 hours of legal services. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of 139 hours, and the dollar amount is <u>pending</u> the Committee policy for the rate of legal service hours. Staff requests permission to adjust the line item once the Committee policy is established.

(E) RADIATION MANAGEMENT

The Radiation Management Program provides regulatory services for radioactive materials through the review of license applications and inspections of facilities; administration of contract services with local public health agencies for indoor radon testing, prevention, and education; and the monitoring low-level radioactive waste producers by ensuring proper and economically sound disposal.

→ Staff Initiated Adjustment for Regulation of Uranium Mill Projects

Request: The Department did not request this change, but is supportive of the staff recommendation.

Recommendation: Staff recommends the Personal Services line item within this subdivision be increased by \$120,000 cash funds to pay for the costs of regulating the two uranium mill projects. The increased cost is due to a delay in both projects during FY 2012-13.

Analysis: The Radiation Program approved the Energy Fuels applications for a new uranium mill in 2011. Funds were appropriated by the General Assembly for the work associated with construction plan review and construction oversight starting in FY 2011-12 as the first of a three

year appropriation. A lawsuit brought by the lead plaintiff, Sheep Mountain Alliance, has resulted in the license being voided and funds appropriated for construction review and oversight to be unspent. The lawsuit resulted in a delay of twelve months of the work associated with the Energy Fuels mill, resulting in a reduction of costs in FY 2012-13 and an increase of costs in FY 2013-14.

The Cotter Corporation Canon City uranium mill has not milled uranium since 2007, and the official decision by Cotter Corporation to fully decommission the mill was made in 2011. Funds appropriated in FY 2011-12 to expedite work associated with decommissioning the mill were not used due to work pause issued by the Department. The work pause was lifted in January 2013 and the Department has resumed decommissioning oversight of the mill. The result of the work stop was a one year delay of work.

The following table summarizes the current appropriation for the regulation of the uranium mills, and the revised need for spending authority based on the two issues discussed above. Note all costs shown in the table below are contract costs not state employee expenses.

→ Waste Tire Program Recommendation

During the staff presentation for the Department's FY 2012-13 supplemental requests, the Committee request staff present during figure setting a recommendation on changes to the Waste Tire Program. On March 1, 2013 Tetra Tech will be releasing a report on Colorado's waste tire program and include any recommended changes to the Program. **Staff will present recommended Waste Tire Program changes to the Committee during comebacks on March 15, 2013** to allow staff the time to analyze the recommendations made in the Tetra Tech study and meet with stakeholders.

Personal Services

- The Dairy Inspection Program inspects dairy farms; milk haulers, tankers and receivers; milk cooperatives; milk processing plants; and manufactured dairy product plants.
- The Retail Food Service Inspection Program inspects restaurants, grocery stores, school cafeterias, and food programs for the elderly.

- The Wholesale Food Manufacturing and Storage Program inspects food storage and warehouse facilities, food manufacturers, and shellfish dealers.
- The Insect/Vector Control Program monitors diseases that are spread by insects and rodents, such as encephalitis, the plague, and West Nile Virus.
- The Environmental Institutions Program inspects child care centers, summer camps, public and private schools, and private correctional facilities.
- The Health Fraud Program prepares and disseminates information related to potentially harmful and/or recalled products.
- The Drug/Medical Device Program inspects body art facilities, drug manufacturers, and medical device manufacturers.
- Other regulatory responsibilities, such as inspecting tanning facilities and responding to complaints about hotels, motels, mobile home park operators, and camp ground operators.

Request: The Department requests an appropriation of \$2,390,782 total funds, of which \$1,124,900 is General Fund and 26.9 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$2,392,319 total funds, of which \$1,124,900 is General Fund and 26.9 FTE. The recommendation the following two changes from the FY 2012-13 appropriation:

- a decrease of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures; and
- an increase of reappropriated funds from the Department of Corrections due to increased inspection workload for Department of Corrections facilities.

The recommendation is calculated in accordance with Committee policy and outlined in the following table.

Sustainability Programs

Description: This line item supports programs aimed at reducing environmental waste and pollution by conserving natural resources in State Government operations and recognizing businesses that go above and beyond environmental requirements. Specific programs funded in by this line include:

- 1. Environmental Leadership Program which provides financial incentives for companies that demonstrate a commitment to the use of pollution prevention strategies and compliance with environmental regulations.
- 2. Pollution Prevention Program issues grants to entities attempting to reduce pollution created by hazardous substances, operates a technical library, provides consumer education on pollution prevention for schools and industry, and offers a variety of training programs for both state and local inspectors.
- 3. Pharmaceutical Take-back Program provides citizens with a place to dispose of unwanted medications in a safe manner.

Request: The Department requests an appropriation of \$1,494,556 total funds and 10.1 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$1,362,536 total funds and 10.1 FTE, calculated in accordance with Committee policy. The recommendation includes a reduction of federal funds to align the FY 2013-14 Long Bill with actual. The following table outlines how the recommendation is calculated.

Animal Feeding Operations (AFO) Program

Description: This line item supports the Department's regulatory programs affecting animal feeding operations, including the Housed Commercial Swine Feeding Operations Program, which was created by the passage of S.B. 06-117 (Kester/Gardner). Senate Bill 06-117 allowed wastewater vessels and impoundments used in a housed commercial swine operation to be operated with technologies or practices to minimize the emission of odorous gases so long as those technologies are at least as effective as covers. In FY 2010-11, the General Assembly combined the HCSFO and CAFO programs within this line item to consolidate swine feeding operations monitoring and confined feeding operations permits and assistance work into a single program.

Request: The Department requests an appropriation of \$470,288 total funds, of which \$99,538 is General Fund and 3.5 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$470,288 total funds, of which \$99,538 is General Fund and 3.5 FTE.

Recycling Resources Economic Opportunity Program

Description: This Program is administered by the Pollution Prevention Advisory Board and is aimed at enhancing pollution prevention efforts involving multiple Department divisions and across a variety of media (air, water, and waste). Initially created by H.B. 07-1288 (Solano/Shaffer), the program was funded with by an increase on existing solid waste disposal and waste tire fees. The waste tire fee funding for this Program was eliminated by H.B. 10-1018 beginning in FY 2011-12.

Request: The Department requests an appropriation of \$1,854,479 cash funds and 1.6 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$1,854,479 cash funds and 1.6 FTE.

Oil and Gas Consultation Program Costs

Description: This line item funds the personal services and operating expenses associated with the Department's consultation work with the Oil and Gas Conservation Commission (OGCC) within the Department of Natural Resources.

Request: The Department requests an appropriation of \$120,693 cash funds and 1.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$120,693 cash funds and 1.0 FTE.

Waste Tire Program

Description: This line item funds the following Waste Tire Program activities and programs:

- The Waste Tire Incentives Program which awards grants for projects that reuse waste tires in applications such as building new artificial turf fields and new playground surfaces.
- The Illegal Waste Tire Grant Program awards grants to assist in the clean-up of waste tires that have been illegally dumped on county-owned properties.
- Distribution of rebates to companies in Colorado for processing waste tires or using waste tires in an end use.
- Encourage the development of markets for waste tires based on a market development plan created by the Waste Tire Advisory Committee.

Request: The Department requests an appropriation of \$5,134,982 cash funds and 1.0 FTE. The request does not include any changes from FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$5,917,428 cash funds and 1.0 FTE, calculated in accordance with Committee policy. The recommendation includes the following changes from the FY 2012-13 appropriation:

- Reduction of one-time funds appropriated in the supplemental bill;
- Increase of \$582,446 cash fund reserves not appropriated in FY 2012-13; and
- Increase of \$200,000 for the FY 2013-14 revenue adjustment.

→ Request R-4 – Preventive Health Funding

- The Department requests an increase of General Fund to certain programs within this Division to backfill federal funds. The requested increase in General Fund is offset by a reduction of General Fund to two programs.
- Staff does not recommend the request because it violates statute.

Request: The Department requests a General Fund increase to the Environmental Epidemiology and Communicable Disease Program to offset lost federal funds. The request also seeks a reduction of General Fund appropriated to the Ryan White Aids Drug Assistance Program and the Immunization Program to offset the increase.

Recommendation: Staff recommends the Committee sponsor legislation specifically authorizing the use of General Fund for these programs because without legislation the request violates Section 24-75-1305, C.R.S. Staff also recommends the reductions to the Ryan White Aids Drug Assistance Program and the Immunization Program not be taken.

Alternative Option: The Committee could sponsor legislation repealing Section 24-75-1305, C.R.S. in which case the staff recommendation for legislation would not be needed, and staff recommendation to increase General Fund for the two programs could be included in the Long Bill.

Analysis:

Section 24-75-1305, C.R.S.

Staff requested an opinion from the Office of Legislative Legal Services about whether this request violated Section 24-75-1305 (1), C.R.S. which states:

Except as otherwise provided in subsection (3) of this section, beginning January 1, 2011, the general assembly shall not make an appropriation of moneys from the general fund or from any other source of state moneys to fund a program, service, study, or other function of state government that was previously funded through grant moneys and that has not received adequate grant moneys to support the program, service, study, or other function of state government for the applicable fiscal year.

The Office determined that since the two programs have historically been funded with federal funds, simply appropriated General Fund would violate the above statute. The recommendation to sponsor legislation is based on the opinion of legal services which derives from Section 24-75-1305 (3) which states:

The general assembly may adopt legislation to reauthorize any program, service, study, or other function of state government that was previously funded through grant moneys and, if such legislation includes an appropriation from the general fund or any other source of state moneys and becomes law, may make an appropriation from the general fund or from any other source of state moneys to a state agency to oversee the program, service, study, or other function of state government.

The Preventive Health Services Block Grant is a discretionary federal grant which was eliminated in the President's FFY 2012-13 budget. Preventive Health Services Block Grant dollars are flexible funds intended to enable states to address their own unique health needs. Colorado has utilized these funds for a variety of programs including: communicable disease investigation and control, sexual assault prevent, and teen pregnancy reduction efforts.

The request above only continues funding for three of twelve programs currently funded with Preventive Health Service Block Grant. The three programs are:

Sexually Transmitted Infection (STI) Medication Program

The STI Medication Program purchases antibiotics and other medications to treat lowincome clients who have sexually transmitted infection (STIs). Without this program these low- income patients would not receive necessary and appropriate medication to treat and prevent the spread of STIs.

Environmental Epidemiology Program

Environmental Epidemiology Program analyzes the health impacts of exposure to environmental pollutants, educates stakeholders on the presence or absence of health risks, and provides advisories, such as recommendations to avoid eating fish from contaminated sources, or recommending against drinking water that has been identified as possibly harmful to human health; and responds to concerns related to possible cancer clusters as well as concerns related to oil and gas drilling activity.

Communicable Disease Program

This Program conducts surveillance, investigation, response, consultation and training in order to prevent and control the spread of communicable diseases such as food-brone and waterborne illness. The Program maintains a state-wide communicable disease reporting system, monitors disease reports to identify clusters and outbreaks; investigates possible outbreaks; and takes appropriate action as warranted. Examples include the 2011 multi-state outbreak of Listeria associated with cantaloupes, community-wide Alamosa Salmonella outbreak in 2008 and Colorado's investigation of a cluster of E. coli cases that was linked to ground bison meat and led to a nationwide recall of this product.

Staff is recommending the increased funding because the possible long-term fiscal impacts of not funding these programs would be significant. It is less expensive to prevent the spread of communicable diseases through these programs, than it is to treat an illness with medical providers. The following table outlines what the funds would be used for and the impacts of not funding the request.

(A) ADMINISTRATION, GENERAL DISEASE CONTROL AND SURVEILLANCE

This subdivision houses the administrative section of the division, the Communicable Disease Epidemiology and Hepatitis Programs which address disease prevention and control specifically in those areas not served by the Special Purpose Disease Control Programs, and the Immunization Program.

The immunization program consists of the following components

- The Immunization Outreach Program which provides free immunization clinics around the state.
- The Colorado Immunization Information System collects and stores a child's immunization records, which enables health care providers to easily check a child's immunization status during a health-care visit. This helps to ensure that a child is up-to-date on their immunizations, and are not over-immunized. The system can also send reminders to parents of children who are not up-to-date on their immunizations.
- Grants to local public health agencies for the operation of immunization clinics.

Personal Services

Description: This line item funds the personnel expenses of the administration and disease surveillance staff.

Request: The Department requests an appropriation of \$889,599 total funds, of which \$761,620 is General Fund and 12.5 FTE. The request includes an increase of General Fund, offset by a reduction of federal funds and 2.4 FTE for the Preventive Health Funding decision item.

Recommendation: Staff recommends an appropriation of \$889,599 total funds, of which \$545,620 is General Fund, and 10.1 FTE. The recommendation <u>does not</u> include funding for the decision item pursuant to the staff recommendation to sponsor legislation. The recommendation was calculated in accordance with Committee policy and is outlined in the following table.

Immunization Operating Expenses

Description: This line item funds the operating expenses of the Immunization Program.

Request: The Department requests an appropriation of \$4,860,303 total funds, of which \$613,272 is General Fund and \$441,600 is General Fund Exempt. The request includes the following changes from the FY 2012-13 appropriation:

- Reduction of federal funds for the financial risk management decision item; and
- Reduction of General Fund for the preventive health funding decision item.

Recommendation: Staff recommends an appropriation of \$50,328,861 total funds, of which \$684,272 is General Fund and \$438,300 is General Fund Exempt. The recommendation includes the following changes from the FY 2012-13 appropriations:

- Adjustment for Amendment 35 revenue projection;
- Adjustment for the Tobacco Master Settlement revenue projection;
- Adjustment of federal funds to reflect non-program grants expenditures for the purchase of vaccines by local public health agencies.

The recommendation <u>does not</u> include funding for the financial risk management decision and the preventive health funding decision item.

Diversion to HCPF for cervical cancer vaccination

Starting in FY 2007-08 a portion of the moneys that the Colorado Immunization Fund receives each year have been appropriated to the Department of Health Care Policy and Financing (HCPF) rather than to this Department (CDPHE), for cervical cancer vaccinations (also known as human papillomavirus vaccinations or HPV vaccinations) for Children's Basic Health Plan participants. This diversion was established in the appropriation clause of H.B. 07-1301 Cervical Cancer Immunizations, but is not required by statute. The issue during the FY 2012-13 staff figure setting process that the transfer was not based on a calculation of the actual costs.

In response to this issue, staff recommended and the Committee approved the staff recommendation to make the transfer to HCPF equal to 19.5 percent of the tobacco settlement revenue diverted to Immunizations based on the intent of the General Assembly in H.B. 07-1301. Based on the Committee approved tobacco settlement allocation to Immunizations, the following table outlines how much would be diverted to HCPF in FY 2013-14.

Appropriation from the Tobacco Tax Fund to the General Fund

Description: Pursuant to 24-22-117, C.R.S., 0.6 percent of the Amendment 35 revenue deposited into the Tobacco Tax Cash Fund must be appropriated to the General Fund, then reappropriated for health-related purposes. This 0.6 percent must go into the exempt account of the General Fund because it derives from a voter-approved tax increase thus making these dollars exempt from TABOR. The exempt status is derived from Amendment 35 and not from

Referendum C. This is the only part of Amendment 35 revenue that is appropriated to the General Fund, because it is required by the language of Amendment 35.

Request: The Department requests an appropriation of \$441,600 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

(B) SPECIAL PURPOSE DISEASE CONTROL PROGRAMS

Sexually Transmitted Infections, HIV and AIDS Personal Services

Description: The prevention, treatment of sexually transmitted infections, HIV and AIDS are funded through this line item. Prevention services include ensuring those at high risk for an STI or HIV receive test results, and have access to risk-reduction counseling and partner notification services. Division staff are also responsible for tracking and maintaining a record of the number of STI and HIV infections. Division staff also review disease reports in order to identify outbreaks and coordinate the Departments, local public health agencies and health care providers response.

Since FY 2006-07 immunization staff have administered the Colorado HIV and AIDS Prevention Grant Program (CHAPP), established in Section 25-4-1413, C.R.S. This Program receives 2.0 of tobacco master settlement dollars, with a cap of \$2.0 million, and provides competitive grants to organizations that focus on addressing local community needs of medically accurate HIV and AIDS prevention and education.

Request: The Department requests an appropriation of \$3,763,175 total funds and 44.7 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: **Staff recommends an appropriation of \$3,641,052 total funds and 44.7 FTE,** calculated in accordance with Committee policy. The recommendation includes a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures and FTE use. Sexually Transmitted Infections, HIV and AIDS Operating Expenses

Description: This line item funds the operating expenses of the Division prevention and treatment services for STIs and HIV and AIDS, and the maintenance of data and records related to infection rates. Approximately 80.0 percent of the federal funds are used for grants to county and local governments and to non-profit organizations to conduct STI monitoring, prevention and education efforts

Request: The Department requests an appropriation of \$5,226,101 total funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: **Staff recommends an appropriation of \$4,524,119 total funds.** The recommendation includes the following changes from the FY 2012-13 appropriation:

- A decrease of funds to align the FY 2013-14 Long Bill with recent actual expenditures; and
- A reduction of cash funds based on the tobacco master settlement revenue projections.

Ryan White Act Personal Services

Description: This line item funds the staff who administers the federal grants received under the federal Ryan White Comprehensive AIDS Resources Emergency (CARE) Act, and the AIDS Drug Assistance Program (ADAP), which is funded by a combination of tobacco master settlement dollars and federal funds. ADAP provides AIDS/HIV treatment related drugs and opportunistic infection fighting drugs to individuals who are not covered by private insurance, are not Medicaid eligible, and have incomes at or below 400.0 percent of the federal poverty level. ADAP provides provide drug cost assistance to individuals who can no longer the drugs under private insurance and meet the other eligibility conditions.

Federal funds from the federal Ryan White CARE Act fund primary care and support services for individuals living with HIV and AIDS who lack health insurance and financial resources to pay for their care. Drug assistance, ambulatory health care, and support services are the primary focus of the program, but training and technical assistance for providers is also funded. Services include primary care, dental care, mental health care, substance abuse counseling, transportation, hospice care, emergency services, drug assistance, food bank, respite care assistance, adoption and foster care, and nutrition counseling. There is a maintenance of effort requirement is meet by maintaining the prior year's level of funding for AIDS programs throughout state government, not just through spending by the Department of Public Health and Environment.

Request: The Department requests an appropriation of \$958,577 total funds, of which \$21,621 is General Fund and 11.3 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$988,121 total funds, of which \$21,621 is General Fund, and 11.3 FTE. The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the following table.

(C) ENVIRONMENTAL EPIDEMIOLOGY

Birth Defects Monitoring and Prevention Program Costs

Description: This line item would funds the personnel and operating expenses of the Birth Defects Monitoring and Prevention Program. Program staff work on the monitoring and prevention program for children, newborn to age three, who have birth defects, developmental disabilities, or risks of developmental delay. Once a child is identified as eligible for the program, they are referred to a community provider of early intervention services. The goal of this program is to reduce and/or prevent secondary disabilities. Approximately 9,000 children are identified each year, and approximately half are referred to service providers for additional services. Division staff also administer a federally funded birth defects registry, which is used for epidemiological surveillance to learn about the occurrence of birth defects and developmental disabilities.

Request: Department requests an appropriation of \$418,437 total funds, of which \$117,656 is General Fund and 4.7 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$412,545 total funds and 4.7 FTE, of which \$117,656 is General Fund. The recommendation includes a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The recommendation is calculated in accordance with Committee policy and outlined in the table below.

LEGISLATIVE AUDIT COMMITTEE REQUEST RELATED TO THE TOBACCO PROGRAMS

Legislative Audit Committee Request: The Audit Committee requires the addition of a request for information related to the Tobacco Education, Prevention and Cessation Programs. The request for information should include the following information: the types of grants and accurate and complete accounting of funds award for each grant.

The intent of this request is to increase transparency and accountability for the use of grant funds, and provide the General Assembly with greater control and knowledge about the types of grants the Department is funding with Amendment 35 revenues. Additionally the request is

intended to provide the JBC and Audit Committees with information on whether or not the Department is spending grant funds on policy areas in violation of statute.

Recommendation: Staff recommends the following request for information be sent to the Department:

Department of Public Health and Environment, Prevention Services Division, Tobacco Education Tobacco Education, Prevention, and Cessation Grants -- The Department is requested to submit a report on the types of grants award by the Tobacco Education, Prevention and Cessation Committee in FY 2012-13 and FY 2013-14. The request is requested to include the purpose of the grant, the amount of the grant, the recipient, and a report on how the funds were actually used. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2013.

Analysis: The request from the Audit Committee stemmed from the August 2012 audit of the Tobacco Education Prevention and Cessation Grant Program within the Department of Public Health and Environment. The audit question the use of grants to fund policy initiatives which helped pass local government laws, including initiatives that extend smoking restrictions beyond those in the Colorado Clean Indoor Air Act.

The audit recommended the Department seek an opinion from the Attorney General Office on the use of these funds for policy initiatives. The Department disagreed with the recommendation, and the Audit Committee asked the Office of Legislative Legal Services (OLLS) for an opinion. The opinion from OLLS confirmed that the State Constitution and statute did not allow the Department to fund grants for policy initiatives.

The Department was unable to provide specific data on how much of the grants award for policy initiates was specifically used for activities which, according to OLLS violated statute. The reason the Department was unable to provide this data is a lack of electronic grant tracking and monitoring system. The inability of the Department to provide the information to the audits stems from the sixth audit recommendation which stated the need for the Department to improve the tracking of grant data by using an electronic tracking system. The Department agreed with the recommendation, noted that work was being done to implement an automated end-to-end process flow solution, and an electronic system that will track all applications, awards, contract amounts, and progress reporting would be in place by July 2013.

When JBC staff inquired in as to the status of the grants management system, the Department responded that there was no system in place for these Programs. This contradicted what the Department had said in the audit, so staff asked the audit staff who worked on this audit, what the implication of not having a computer system in place was on the ability of the Programs to implement the agreed to recommendation. The response from the audit staff was, without the grants management system, the issues identified in the audit would most likely continue. Staff is working with the Department and the Governor's Office of Information Technology to identify the cost of implementing and maintain the computer system. **Staff will make a recommendation on funding for implementation of the grants management system during**

comebacks. Staff is concerned that without a grants system the Department will be unable to respond to the request for information and issues identified in the audit will continue.

SMART Act Letter from the House Public Health and Human Services Committee

Request: The House Public Health Care and Human Services Committee SMART Act letter recommended the Joint Budget Committee "explore the costs of expanding Medicaid Breast and Cervical Cancer Program to include treating women who are not initially diagnosed at a Women's Wellness Connection site but who otherwise meet the eligibility criteria for the Program." The recommendation request any expansion in services be funded with General Fund.

Recommendation: The staff recommendation does include increased funding for either the screening or treatment components of the Breast and Cervical Cancer Program.

Note: The recommendation was made to the Department of Health Care Policy and Financing, but since the funding and half of the Program resides in the Department of Public Health and Environment, the recommendation is addressed in this document.

Analysis: There are two parts to the Breast and Cervical Cancer Program:

- The screening program with this Department, which provides free breast and cervical cancer screenings through the Women's Wellness Connection run by this Department; and
- The treatment program run by the Department of Health Care Policy and Financing for women who are screen and found to have breast or cervical cancer

The Women's Wellness Connection provides free breast and cervical cancer screening and diagnostic services to low income (less than 250.0 percent of the federal poverty level) women age 40 and older at over 100 sites statewide through contracts with 44 local health and community agencies. Local community coordinators, coalition volunteers, and outreach workers provide education to women about the importance of regular screening and early detection of breast and cervical cancer. The program also conducts education and recruitment activities for eligible health professionals.

If the Committee wishes to increase funding for the treatment component of the Breast and Cervical Cancer Program there are a couple of options staff would recommended the Committee consider:

- 1. Increase screening to include a lower age group. Treatment for cancers diagnosed through this expansion would be required, but may be less costly than treatment for older clients; and/or
- 2. Divide the increased funding between the screening and treatment program so that both aspects of the Program are able to handle the increased workload.

The following table shows based on average cost of services of screening and treatment how many more women would be served if additional dollars are added to the Program. Since the

treatment dollars are spent in the Department of Health Care Policy and Financing the dollars are eligible for the federal Medicaid match.

SMART ACT LETTER ON SCHOOL BASED HEALTH CENTERS

Request: Both the House Public Health Care and Human Services Committee and the Senate Health and Human Services Committee request the Joint Budget Committee increase funding for the School-based Health Centers Grant Program to a total of \$5,260,817 General Fund.

Recommendation: The staff recommendation does not include increased funding for the School-based Health Centers Grant Program.

Analysis: The recommendation from the two Committees is based on an analysis by the Colorado Association for School-Based Health Care (CASBHC) which analyzed data and determined that existing school based health centers are serving approximately 41.0 percent of the eligible student population. Therefore CASBHC estimated that in FY 2013-14 to continue serving the existing population, assuming no new non-state funds, the School-based Health Center Grant Program would require an additional \$1,162,635 General Fund. The request would enable the existing School-based Health Centers to serve the entire eligible student population. The following table, provided by CASBHA, shows how much additional funding would be required to increase the number of students served by School-based Health Centers.

Request: The Department did not request this change, but is supportive of the staff recommendation.

Recommendation: Staff recommends H.B. 12-1326 be amended to indicate that any General Fund dollars not expended in FY 2012-13 will remain available for expenditure in FY 2013-14 in order to enable the Program to maintain a continuum of care as the first year of funding concludes.

Analysis: The General Assembly passed H.B. 12-1326 which appropriated \$3,022,800 and 1.0 FTE to the Department of Public Health and Environment to expand the Dental Assistance Program (Program). The Program provides grants to dental providers for services to individuals who are 60 years or older, and eligible for the Old Age Pension program <u>or</u> Medicaid, but not receiving long-term care services through Medicaid. The Program is overseen by the Dental Advisory Committee.

Due to the General Fund shortfall in FY 2010-11 the General Assembly eliminated all funding for the Dental Assistance Program, saving \$397,531 General Fund. Since the Program was not funded for three years, all appointments to the Committee were set to expire in July 1, 2012. The funding provided in H.B. 12-1326 required reactivation of the Committee. By September 2012 the Committee put forth proposed rules to the State Board of Health for approval. At the September 19 State Board of Health meeting the rules were approved, and became final on October 30, 2012 after the requirement waiting period.

In order to keep the process moving, the Dental Advisory Committee sent out the request for grant applications on September 12, conducted a webinar to provide potential grantees with information in late September, and set October 15, 2012 as the application deadline. The Committee received 20 applications, and on November 1, 2012 granted out the full \$2,935,234 to nineteen grantees.

The main roadblock to actually expending all the funds is the reimbursement levels specified in the rules. The current rules for the Program include fees that were set back before funding for the Program was eliminated. The reason the rules adopted in September did not include a fee change was because it would have taken an additional 3-6 months for a rules change request and input from local governments pursuant to Executive Order D 2011-005. Emergency rules were issued which increased the reimbursement rates effective January 2013. Despite issuing emergency rules, the Program does not anticipate expending all the funds in FY 2012-13 because a majority of the appointments in FY 2012-13 will be initial appointments which do not involve the more expensive treatment procedures. In order to maintain a continuum of care, and ensure that eligible clients are able to access services without a delay due to funding, **staff recommends the Committee allow the FY 2012-13 General Fund appropriation the authority to roll forward into FY 2013-14.** Staff spoke with the Department and Governor's Office and did not receive any opposition to this recommendation. This recommendation will not impact the FY 2013-14 appropriation or amount of General Fund available in FY 2013-14.

Family Planning Footnote

The following footnote should be continued if the Committee feels it is appropriate to reiterate existing language in the State Constitution. If the Committee feels that it is not appropriate to reiterate Constitutional language, the footnote should be discontinued. The language in the footnote is redundant of the prohibition located in Section 50 of Article 5 of the State Constitution and in Section 26-4-512, C.R.S. The Colorado State Constitution trumps any footnote language in the Long Bill and the footnote does not provide any additional direction to the Department.

Department of Public Health and Environment, Prevention Services Division, Women's Health -- Pursuant to Article V, Section 50, of the Colorado Constitution, no public funds shall be used by the State of Colorado, its agencies or political subdivisions to pay or otherwise reimburse, either directly or indirectly, any person, agency or facility for the performance of any induced abortion, provided however, that the General Assembly, by specific bill, may authorize and appropriate funds to be used for those medical services necessary to prevent the death of either a pregnant woman or her unborn child under circumstances where every reasonable effort is made to preserve the life of each.

Staff Recommended Footnote on the Transfer to Health Disparities Program Fund Line

Request: The Department did not request this footnote, but is support of the recommendation.

Recommendation: Staff recommends the following footnote be added to the Transfer to the Health Disparities Grant Program Fund. Staff requests permission to adjust the line as necessary based on input from the Office of Legislative Legal Services.

Department of Public Health and Environment, Prevention Services Division, Chronic Disease Prevention Programs, Transfer to Health Disparities Program Fund – It is the intent of the General Assembly that if actual Amendment 35 revenues are higher than the appropriation, the transfer to the Health Disparities Program Fund of 3.2 percent of Amendment 35 revenue be increased by a like amount.

Analysis: Staff recommends the Committee include a footnote on the Transfer to the Health Disparities Program Fund line item to enable the transfer of 3.2 percent of Amendment 35 revenue to the Health Disparities Program Fund regardless of the Long Bill appropriation. Statute requires the transfer to equal 3.2 percent of Amendment 35 revenue and without the flexibility to increase the transfer if revenue is higher than the appropriation the Department would either violate the constitution by not transferring 3.2 percent or the Long Bill by exceeding the appropriation

2013 Legislation Impacting Programs in the Prevention Services Division

If the following two bills are passed prior to the passage of the Long Bill, the Long Bill will reflect the changes. If the bills are not passed prior to the Long Bill, the bills will need to carry appropriation clauses making the necessary adjustments.

House Bill 13-1181

House Bill 13-1181 impacts the funding from the Tobacco Master Settlement revenues for the Tony Grampsas Youth Services and Nurse Home Visitor Program in two ways:

- creates the Youth Services Program Fund for which this Program's portion of revenue from the tobacco master settlement are deposited and subsequently appropriated;
- allows the Youth Services Program Fund to retain up to 5.0 percent of the lesser of unexpended and unencumbered moneys in the fund or the appropriation.

House Bill 13-1117

House Bill 13-1117 transfers the following programs from this Department to the Department of Human Services new Office of Early Childhood:

- Nurse Home Visitor Program;
- Tony Grampsas Youth Services Program; and
- Children's Trust Fund and Family Resource Centers

(A) ADMINISTRATION

Administration

Description: This line item funds the staff responsible for general oversight of the prevention programs within this Division.

Request: The Department requests an appropriation of \$117,233 General Fund and 2.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request of \$117,233 General Fund and 2.0 FTE.

Indirect Cost Assessment

Request: The Department request for this line item is simply a place holder until the FY 2013-14 indirect cost assessment can be calculated.

Recommendation: The dollar amount of staff recommendation is <u>pending</u> the Committee approval of the line item appropriations required to calculate the total cost of central services. Staff requests permission to set this line, and apply a fund split once these appropriations are set.

(B) CHRONIC DISEASE PREVENTION PROGRAMS

Cancer Registry

Description: This line item funds the personnel expenses associated with the operation of the Cancer Registry. The Registry provides population-based data on cancer treatment, incidence, death, and survival. The Registry uses the dollars from a federal grant from the National

Program for Cancer Registries for system enhancements, data quality improvements, increased timeliness of reporting and processing of cancer-related data. These dollars are also used to encourage the use of data by researchers in reporting cancer incidence rates and trends to the public. The federal grant includes a maintenance of effort requirement which is satisfied by the General Fund appropriation.

Request: The Department requests an appropriation of \$1,104,227 total funds, of which \$221,498 is General Fund and 11.6 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$1,345,798 total funds, of which \$221,498 is general Fund and 11.6 FTE. The recommendation includes an increase of \$241,571 federal funds to align the FY 2013-14 Long Bill with recent actual The recommendation is calculated in accordance with Committee policy and the following table shows how the recommendation was calculated.

Recommendation: Staff recommends an appropriation of \$3,506,400 cash funds in accordance with the recommended distribution of Amendment 35 revenues. The following table shows how the recommendation was calculated, and staff requests permission to adjust the line based on the March 2013 Legislative Council Amendment 35 revenue forecast.

<u>Transfer to the Department of Health Care Policy and Financing for Breast and Cervical</u> <u>Cancer Treatment</u>

Description: This line item provides the Division with spending authority to transfer Amendment 35 dollars to the Department of Health Care Policy and Financing. The transfer amount is based on the needs of HCPF's Breast and Cervical Cancer Treatment Program, and the cash funds are from the Prevention, Early Detection, and Treatment Fund.

Request: The Department requests an appropriation of \$936,892 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request of an appropriation of \$936,892 cash funds.

Chronic Disease and Cancer Prevention Grants Program

Description: The grants issued by the cancer prevention grants program focus on the research and treatment of the six most common forms of cancer: breast, cervical, colon, lung, prostate, and skin. Chronic disease prevention programs implement activities in accordance with guidance from the federal Centers for Disease Control. Both programs have statewide strategic plans, develop a disease report, and partner with coalitions or advisory groups to extend the reach of the programs.

Request: The Department requests an appropriation of \$4,167,925 total funds and 23.9 FTE. The request includes two changes:

- Reduction of \$21,503 federal funds and 0.3 FTE for the financial risk management decision item; and
- Reduction of \$50,819 federal funds and 0.3 FTE for the Lean resources decision item.

Recommendation: Staff recommends an appropriation of \$5,016,256 total funds and 36.7 FTE, calculated in accordance with Committee policy. The recommendation includes the following changes:

- a increase of federal funds and FTE to align the FY 2013-14 appropriation with recent actual expenditures and FTE use;
- a reduction of FTE and net zero change in federal funds for funding for the expansion of the financial risk management decision item;
- a reduction of FTE and net zero change in federal funds for funding for the LEAN resources decision item.

Tobacco Education, Prevention, and Cessation Program Costs

This line item funds State Tobacco Education and Prevention Program (STEPP) grants awarded by the Tobacco Education, Prevention, and Cessation Review Committee for the for programs aimed at reducing the use of tobacco by youth, promoting cessation among youth and adults who already use tobacco, and reducing exposure to second-hand smoke.

Grants made through the Department's Tobacco Education, Prevention, and Cessation Program are awarded to governmental and non-governmental agencies, and as required by Section 25-3.5-805, C.R.S., at least 15.0 percent of these grants are used for the reduction of health disparities among minority and high risk populations, and up to 15.0 percent of the grants go to Tony Grampsas Youth Services Program grantees.

Request: The Department requests an appropriation of \$23,426,095 total funds. The request includes an adjustment of the amount of funds used to pull down federal Medicaid matching funds for the Colorado Quitline.

Recommendation: **Staff recommends an appropriation of \$26,584,735 total funds.** The recommendation includes the following changes:

- A cash fund reduction to reflect the FY 2013-14 projected Amendment 35 revenue distribution for Tobacco Education, Prevention and Cessation Grants;
- An increase in cash funds to appropriate unspent fund from FY 2012-13; and
- A reduction of reappropriated funds for services provided through the Quitline to Medicaid eligible clients.

Oral Health Programs

Description: This line item funds the costs of the following three Oral Health Programs which work to increase the availability of oral health services in Colorado:

- 1. The Dental Loan Repayment Program is available to dentists and dental hygienists who agree to serve for two years in medically under served populations in rural or urban settings, and receives \$200,000 from tobacco settlement dollars. Dentists are eligible for up to \$25,000 in loan repayment funds and dental hygienists are eligible for up to \$6,000 in loan repayment funds.
- 2. The Dental House Calls Program is run by the Dental Lifeline Network, and provides dental services to homebound elderly and handicapped; and
- 3. The Dental Assistance Program provides grants to dental providers for services to individuals who are 60 years or older, and eligible for the Old Age Pension program or Medicaid, but not receiving long-term care services through Medicaid. The General Assembly passed H.B. 12-1326 which appropriated General Fund to the Department to reinstate the Dental Assistance Program in FY 2012-13.

Request: The Department requests an appropriation of \$4,551,342 total funds, of which \$3,202,743 is General Fund and 6.3 FTE. The request includes the following changes from the FY 2012-13 appropriation:

- Reduction of federal funds and FTE for the financial risk management decision item and
- a reduction of federal funds and FTE for the Lean resources request.

Recommendation: Staff recommends an appropriation of \$4,283,041 total funds, of which \$3,202,743 is General Fund and 6.3 FTE. The recommendation the following changes from the FY 2012-13 appropriation:

- reduction of FTE for the financial risk management decision item;
- reduction of FTE for the LEAN resources request;

• a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures.

(C) PRIMARY CARE OFFICE

(1) WOMEN'S HEALTH

Family Planning Program Administration

Description: This line item funds the personnel and operating expenses associated with the administration of the Family Planning Program, the Prenatal Program, and the Prenatal Plus. The Family Planning Program provides a range of preventive health services for approximately 55,000 teens and women whose income is at or below 185.0 percent of the federal poverty level each year. Services include physical examinations, pregnancy testing, screening for sexually transmitted infections, counseling and education, and referrals to other health and social services. The federal Title X dollars fund contracts between the Division, local family providers, and local health facilities and non-profit clinics, who are often the primary health care provider for non-Medicaid eligible, low income women. Neither Title X nor General Fund dollars support abortion activities, per federal Title X requirements and per the state constitution. Note that Title X is not an entitlement program, does not have an associated match or maintenance of effort requirements, but does require a cost share from the state.

The Prenatal Program encourages Medicaid-eligible, high risk pregnant women to utilize early prenatal care to reduce the risk of maternal and newborn illness or complications. The goal of this Program is to assistant eligible women have healthy babies and have access to postpartum family planning services. The Prenatal Plus Program is designed to complement the medical component of prenatal care by providing comprehensive risk assessments, case management, home visits, nutrition consultation, and psycho-social counseling to high risk, Medicaid-eligible pregnant women.

Request: The Department requests an appropriation of \$991,704 total funds, of which \$395,998 is General Fund, and 12.0 FTE. The request includes the following changes from the FY 2012-13 appropriation:

- a reduction of funds and FTE for the financial risk management decision item.; and
- a reduction of federal funds and FTE for the Lean Resources decision item.

Recommendation: Staff recommends an appropriation of \$1,050,698 total funds, of which \$395,998 is General Fund and 12.0 FTE. The recommendation the following changes from the FY 2012-13 appropriation:

- reduction of FTE for the financial risk management decision item;
- reduction of federal funds and FTE for the Lean resources request;
- a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures.

Adult Stem Cells Cure Fund

Description: This line item provides the Division with spending authority for revenue collected through the voluntary Adult Stem Cells Cure Fund tax checkoff added to the state income tax form for years 2008 through 2016.. The Fund provides dollars used to advance umbilical cord blood collection for public blood banks, and the Department contracts with entities that are involved in umbilical cord blood donation activities. Adult stem cells are obtained from tissues that have already undergone some degree of development, thus stem cells obtained from umbilical cord blood are classified as "adult" stem cells even though they come from newborns. Donated stem cells are used for treatment of diseases such as leukemia and lymphoma, and for research into cures for other serious illnesses. Pursuant to Section 25-40-104, C.R.S., 5.0 percent of moneys in the Fund can be used for administrative costs, 25.0 can be used for public awareness activities, and 70.0 percent must be used to increase cord blood collection.

Request: The Department requests an appropriation of \$140,000 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$140,000 cash funds.

Maternal and Child Health Administration

Description: This line item funds the personnel and operating expenses of staff responsible for coordination of maternal and child health programs and services. The office is funded primarily through federal funds provided by the Maternal and Child Health Grant.

Request: The Department requests an appropriation of \$3,638,614 federal funds and 13.7 FTE. The request includes the following changes from the FY 2012-13 appropriation:

- a reduction of federal funds and FTE for the financial risk management decision item; and
- a reduction of federal funds and FTE for the Lean resources decision item.

Recommendation: Staff recommends an appropriation of \$4,659,400 federal funds and 12.4 FTE, calculated in accordance with Committee policy. The recommendation includes an increase of federal funds and a reduction of FTE to align the FY 2013-14 Long Bill with recent actual expenditures and FTE use. Nurse Home Visitor Program

Description: The Nurse Home Visitor Program was established by S.B. 00-071, and utilizes specially trained nurse home visitors to provide health education and counseling to low-income (incomes up to 200.0 percent of the federal poverty level), first time mothers beginning when the mother is pregnant and continuing through the child's second birthday. The Program has served

approximately 12,000 mothers and children, and is monitored by the National Center for Children, Families and Communities at the CU Health Sciences Center.

The Program receives 19.0 percent of tobacco settlement revenue. Providers who serve non-Medicaid clients bill the Department directly. Since a large number of clients served by this Program are Medicaid eligible, the providers who work with the Program revenue Medicaid reimbursements. For providers who serve Medicaid eligible clients, they bill the Department of Health Care Policy and Financing (HCPF). HCPF then asks the Department of Public Health and Environment (CDPHE) to transfer funds to HCPF who applied for the federal match. The provider is then reimbursed by HCPF.

Request: The Department requests an appropriation of \$16,324,606 total funds and 3.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$13,729,550 total funds and 3.0 FTE, calculated in accordance with Committee policy. The recommendation includes the following changes from the FY 2012-13 appropriation:

- a reduction of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures; and
- adjustment of cash funds based on the Tobacco Master Settlement revenue projection.

School-Based Health Centers

SBHCs provide medical and behavioral care to school child during the school day, and are run by the school districts in cooperation with other health service providers such as hospitals, medical providers, and community health centers.

Request: The Department requests an appropriation of \$994,316 General Fund and 0.7 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of **\$994,316 General Fund and 0.7 FTE,** calculated in accordance with Committee policy.

Interagency Prevention Programs Coordination

Description: This line item provides funding for support and coordination services for youth prevention programs in the Departments of Education, Human Services, Public Health and Environment, Public Safety, and Transportation. The Programs focus on reducing duplication and creating efficiencies by sharing resources across programs and agencies, and are required to comply with eight statutory requirements. The eight requirements are:

- a. develop a state plan for delivery of prevention, intervention and treatment services to children and youth throughout the state,
- b. identify performance indicators for prevention, intervention, and treatment programs,
- c. act as a liaison with communities throughout the state, assisting them in their efforts to assess their needs and to secure funding and provide technical assistance in the implementation of appropriate prevention, intervention and treatment programs,
- d. operate prevention and intervention programs for children and youth,
- e. review federal funding guidelines and seeking waivers to promote the greatest flexibility in awarding combined program funding to community-based prevention, intervention and treatment programs,
- f. develop a website with information on existing programs and potential funding sources,

- g. develop uniform minimum standards for the operations of prevention/intervention programs and
- h. conduct an annual review of programs.

Request: The Department requests an appropriation of \$133,284 General Fund and 2.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$133,284 General Fund and 2.0 FTE.

Children and Youth Health Federal Grants

Description: This line item reflects federal grants received by the Division for programs and activities relating to children and youth health. The largest grants include \$132,000 for Early Childhood Development, \$250,000 for Promoting Integration of State Health Systems, and \$200,000 for Early Hearing Detection and Intervention Tracking.

Request: The Department requests an appropriation of \$2,553,351 federal funds and 9.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$1,108,700 federal funds and 9.0 FTE. The request includes a reduction of federal funds and FTE to align FY 2013-14 Long Bill with recent actual expenditures and FTE use.

(3) INJURY, SUICIDE, AND VIOLENCE PREVENTION

Colorado Children's Trust Fund Personal Services

Description: This line item funds the personnel expenses of the administration of the Colorado Children's Trust Fund Grant Program. The Program is supported by a \$15 fee on petitioners for the dissolution of marriage, legal separation, or the declaration of legal invalidity of marriage. Grants are awarded to local prevention and education programs that work with child abuse and neglect cases. The Colorado Children's Trust Fund Board is responsible for grant decisions.

Statute allows for the Fund to build up a balance of \$5.0 million, at which point the fee would be eliminated and the grants would subsist on the interest earned on the Fund balance.

Request: The Department requests an appropriation of \$148,122 total funds and 1.5 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$196,577 total funds and 1.5 FTE, calculated in accordance with Committee policy. The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The following table outlines how the recommendation was calculated.

Tony Grampsas Youth Services Prevention Program

Description: This line item funds the personnel expenses, operating expenses, and grants of the Tony Grampsas Youth Services Program (TGYSP). The TGYSP awards grants to community-based programs that target youth for intervention services in an effort to reduce incidents of youth crime and violence. TGYSP is funded by 4.0 percent of the tobacco master settlement dollars, up to a maximum of \$5.0 million.

Request: The Department requests an appropriation of \$3,575,764 cash funds and 3.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$3,546,151 total funds and 3.0 FTE, calculated in accordance with Committee policy. The recommendation includes an adjustment based on the Tobacco Master Settlement revenue forecast. The following table outlines how the recommendation was calculated.

Suicide Prevention

Description: The Suicide Prevention Program was created by H.B. 00-1432 and is responsible for coordinating suicide prevention programs throughout the state. There are three components to the Program: a statewide public information campaign, training on the recognition and response to suicide, and development of local suicide prevention and education services. Colorado has the sixth highest rate of suicides in 2011, with a suicide rate two and a half times higher than the rates in New York and New Jersey, the two lowest states. In 2010, there were 867 suicides, second only to 2009 when there were 940 suicides.

Request: The Department requests an appropriation of \$384,348 General Fund and 2.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$384,348 General Fund and 2.0 FTE.

Injury Prevention

Description: This line item funds the personnel and operating expenses of the Division's activities associated with overseeing the state injury prevention strategic plan and provides leadership and technical assistance for local communities regarding the planning,

implementation, and evaluation of evidence-based prevention strategies to reduce injuries and deaths.

Request: The Department requests an appropriation of \$2,212,751 federal funds and 20.2 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation \$1,971,500 federal funds and 11.4 FTE, calculated in accordance with Committee policy. The recommendation includes a reduction of federal funds and FTE to align the FY 2013-14 Long Bill with recent actual expenditures and FTE use. The following table outlines how the recommendation was calculated.

(E) NUTRITION SERVICES

Women, Infants and Children Supplemental Food Grant

Description: The Women, Infants and Children (WIC) Nutrition Program provides a monthly check to low-income (185.0 percent of the federal poverty level) women and children who are atrisk of poor nutritional options because of the lack of income. Clients are able to use these funds for purchasing designated food items at approved food retailers. Local public health agencies provide clients with nutrition education and referrals to additional health services.

Request: The Department requests an appropriation of \$93,670,878 federal funds and 17.4 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$95,870,000 federal funds and 17.4 FTE, calculated in accordance with Committee policy. The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The following table outlines how the recommendation was calculated.

Child and Adult Food Care Program

Each year the program serves approximately 42,500 children and adults in more than 500 care centers and nearly 5,000 family day care homes.

Request: The Department requests an appropriation of \$24,229,230 federal funds and 8.0 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$24,534,900 federal funds and 8.0 FTE, calculated in accordance with Committee policy. The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The following table outlines how the recommendation was calculated.

→ 2013 Legislation Impacting Health Facilities Programs

House Bill 13-1155

House Bill 13-1155 makes the transfer of staff responsible for the life safety code inspections of health facilitates contained in H.B. 12-1268 contingent upon approval from the Secretary of the federal Department of Health and Human Services (Secretary). Staff will be transferred from the Department of Public Health and Environment (DPHE) to the Department of Public Safety (DPS). If H.B. 13-1155 is passed prior to the Long Bill, the fiscal impact of the transfer will be included in the Long Bill. If H.B. 13-1155 is not passed prior to the Long Bill, an appropriation clause will be required.

(A) LICENSURE

This Division licenses, certifies and inspects a variety of different types of health facilities in an effort to assure that patients and residents receive quality care, by focusing on education, inspection, investigation of complaints, and enforcement. The Division is responsible for establishing and enforcing standards for emergency medical services.

Health Facilities General Licensure Program

Description: The Health Facilities General Licensure Program licenses and regulates eleven types of medical facilities including: hospitals, nursing homes, hospices, ambulatory surgical care centers, community clinics, and mental health centers. Licensing activities conducted by the division include performing fitness reviews, conducting fire safety inspections, investigating complaints and conducting enforcement activities. General Fund is required pursuant to Section 25-3-103, C.R.S., so that fees paid by non-government owned facilities do not subsidize the regulation of government-owned facilities.

Request: The Department \$3,350,779 total funds, of which \$193,512 is General Fund and 32.9 FTE. The request includes the following three changes from the FY 2012-13 appropriation:

- reduction of cash funds and FTE for the onetime costs associated with developing the schedule for the extended surveys, developing and implementing the tiered inspection system, promulgating rules, and evaluating accrediting standards as required by H.B. 12-1294;
- reduction of General Fund and cash funds associated with the transfer of the life safety code inspections over to the Department of Public Safety pursuant to H.B. 12-1268;
- Increase in cash funds and FTE for rules modifications, coordination of the receipt of certificates of compliance from the Department of Public Safety, and the coordination of survey scheduling.

Recommendation: Staff recommendation is <u>pending</u> additional information regarding the transfer of personnel and funds to the Department of Public Safety pursuant to H.B. 12-1268.

Medicaid/Medicare Certification Program

Description: This Program certifies nursing homes and hospitals so they are qualified to receive federal Medicaid and Medicare payments. Medicaid reappropriated funds pay for certification of facilities caring for Medicaid patients and originated in the Department of Health Care Policy and Financing. The federal Medicare funds pay for certification of facilities caring for Medicare for Medicaid certification funds varies, depending upon the type of activity the certification program is engaged and averages a 35.0 percent to 65.0 percent state to federal split.

Request: The Department requests an appropriation of \$7,746,194 total funds, of which \$1,254,643 is net General Fund and 87.4 FTE. The request includes the reduction of FTE and Medicaid reappropriated and Medicare federal funds pursuant to the transfer of the life safety code inspection functions to the Department of Public Safety.

Recommendation: Staff recommendation is <u>pending</u> additional information regarding the transfer of personnel and funds to the Department of Public Safety pursuant to H.B. 12-1268.

(B) EMERGENCY MEDICAL SERVICES

State EMS Coordination, Planning and Certification Program

Description: This Program oversees Colorado's Emergency Medical and Trauma Services System, which does the following:

- certifies of emergency medical technicans (EMTs);
- Provides technical assistance to local and regional emergency medical services providers and trauma centers;
- Operates the State Emergency Medical Services Advisory Council which makes recommendations to the department regarding emergency medical services and trauma system rules and allocation of funds;
- Assists the State Emergency Medical Practice Advisory Council which advises the department regarding the scope of practice for EMTs, supports the regional coordination of emergency medical and trauma care, and administers the grants program.

This program also includes the air ambulance licensure program, which licenses fixed-wing and rotor-wing ambulance services and EMS/Trauma Telecommunication Support, through which the Department transfers funding to DPA to fund a communications engineer who assists EMS agencies statewide with communications issues.

Request: The Department requests an appropriation of \$1,463,157 cash funds and 15.0 FTE.

Recommendation: Staff recommends the Department's request for an appropriation of \$1,463,157 cash funds and 15.0 FTE. The recommendation is calculated in accordance with Committee policy.

Distributions to Regional Emergency Medical and Trauma Councils

Description: This line item funds the distribution of funds to the state's eleven Regional Emergency Medical and Trauma Advisory Councils (RETACs), as required by statute. RETACs are formed by the governing bodies of four or more counties having geographic proximity, and each is responsible for developing and implementing a system plan for coordinated delivery of emergency medical and trauma care within its region.. Under the provisions of that assess regional needs and conduct emergency services and trauma planning. This line item provides funding for distributions to RETACs. Each RETAC has, since 2002, annually received \$75,000 plus \$15,000 for each county within the RETAC.

Request: The Department requests an appropriation of \$1,785,000 cash funds. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department request for an appropriation of \$1,785,000 cash funds.

Emergency Medical Services Provider Grants

Description: This line item funds emergency medical service grants to local agencies for training, medical, and telecommunications equipment such as defibrillators, communications

equipment, data collection equipment, and new vehicles. New emergency vehicles typically accounting for more that half of the dollars granted. Grants are evaluated based on need, with priority given to replacement of old systems and equipment, and applicants must provide a 50.0 percent match unless they can demonstrate financial hardship.

Request: The Department requests an appropriation of 6,793,896 cash funds. This request does not include any changes from the FY 2011-12 appropriation.

Recommendation: Staff recommends the Department's request of \$6,793,896 cash funds.

Trauma Facility Designation Program

Description: The State Board of Health and this Division have oversight of the state's trauma care system, and health care facilities have the choice of becoming a designated trauma center. . Trauma Centers are designated as Level I through Level V, with Level I centers providing the most complex care. Designation level reflects the amount and type of resources available to care for a severely injured patient.

Health care facilities that choose to be "non-designated" agree to not keep trauma patients with complex injuries, or may agree to care for trauma patients, in which case they will receive site reviews and be designated by the state as Level I (highest) through Level V trauma centers. Fees charged to trauma care facilities, are set by the State Board of Health, to cover the cost of trauma facility designation, but cannot cover related costs, such as attorney fees, ongoing monitoring, provision of technical assistance, and rule making.

Request: The Department requests an appropriation of \$383,237 cash funds and 2.1 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for an appropriation of \$383,237 cash funds and 2.1 FTE.

Federal Grants

Description: This line reflects federal grants received by the Division for various activities and programs.

Request: The Department requests an appropriation of \$182,217 federal funds and 1.5 FTE. The request does not include any changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends an appropriation of \$199,400 federal funds and 1.5 FTE, calculated in accordance with Committee policy. The recommendation includes an increase of federal funds to align the FY 2013-14 Long Bill with recent actual expenditures. The following table outlines how the recommendation was calculated.

Poison Control

Description: Under the authority of the Poison Control Act (Title 25, Article 32, C.R.S.), the Department contracts with the Rocky Mountain Poison and Drug Center, an affiliate of Denver Health, to provide a 24-hour-a-day, toll free phone number that Colorado citizens can call to obtain poison information. The hotline handles over 70,000 cases per year with the average case involving 3 or 4 calls. The phones are staffed by nurses, pharmacists and "poison-information providers." Board-certified medical toxicologists are also on call. The Center is part of the state's response plan for chemical and biological terrorism, and a nationwide monitoring system that looks for unusual patterns that could be the first sign of such an event. In addition, the Center provides statewide training for professionals and the public on prevention and proper treatment of poisonings.

Request: The Department requests an appropriation of \$1,414,876 General Fund. The request includes no changes from the FY 2012-13 appropriation.

Recommendation: Staff recommends the Department's request for \$1,414,876 General Fund.

(C) INDIRECT COST ASSESSMENT

Request: The Department request for this line item is simply a place holder until the FY 2013-14 indirects can be calculated based on the appropriation to all non-indirect cost assessment line items.

Recommendation: The dollar amount of staff recommendation is <u>pending</u> the Committee approval of the appropriations for all non-indirect cost assessment line items. Staff requests permission to set the line item, and apply a fund split once appropriations are approved for all non-indirect cost line items.

(11) OFFICE OF EMERGENCY PREPAREDNESS AND RESPONSE

The Office develops and implements emergency response plans to enable the Department to ensure the protection of health and the medical response for victims when an emergency occurs in Colorado. The Office works to ensure the Department, local public health, and medical agencies have plans for responding to emergency events and administering medication in mass quantities to all citizens in Colorado. Additional responsibilities of the Office include:

- 1. Training of health and medical professionals on the latest and improved response protocols, including the National Incident Management System;
- 2. Ensuring that public health and medical programs are integrated with law enforcement, the Division of Emergency Management and other state departments critical to the state's response;
- 3. Providing emergency preparedness education and training to Department employees, medical and public health partners;
- 4. Ensuring the rapid receipt, storage and distribution of the Strategic National Stockpile (SNS) supplies and medication during an emergency;
- 5. Activation of the Department Emergency Operations Center (DOC) during emergency situations;
- 6. Coordinate and enhance the capacity of the Emergency System for Advance Registration of Volunteer Health Professionals, which enables the Colorado Hospital Preparedness Program to expand and integrate the Colorado Medical Reserve Corps to enable the preparation of volunteers for an all-hazards response;
- 7. Fulfill responsibilities as the state lead agency for Behavioral Health during, and after an emergency event to assist individuals and communities recovering from the challenging effects of natural and human-caused disasters through the provision of community-based outreach and psycho educational services.

The amount of federal dollars this Division receives is driven by formulas that are based in part on state population, and if the state accepts the federal funds, the state must provide the required match amount.

→ Division Name Change

Staff recommends a technical change to the name of the Division to Office of Emergency Prepared and Response. This change would align the Long Bill with the operational name of the Division.

Emergency Preparedness and Response Program

Description: This line item funds the personnel and operating expenses of the Division.

Request: The Department requests an appropriation of \$18,593,181 total funds, of which \$1,619,139 is General Fund and 35.6 FTE. The request includes a reduction of \$35,332 federal funds and 0.5 FTE.

Recommendation: Staff recommends an appropriation of \$14,838,779, of which \$1,600,079 is General Fund and 35.6 FTE. The recommendation includes the two following changes:

- Reduction of federal funds for the financial risk management decision item; and
- Adjustment to the informational federal funds.

The recommendation is calculated in accordance with Committee policy and outlined in the following table.

Recommendation: The dollar amount of staff recommendation is <u>pending</u> the Committee approval of the appropriations for all non-indirect cost assessment line items. Staff requests permission to set the line item, and apply a fund split once appropriations are approved for all non-indirect cost line items.

Long Bill Footnotes and Requests for Information

LONG BILL FOOTNOTES

Staff recommends the following footnotes be **added**:

- XX Department of Public Health and Environment, Prevention Services Division, Chronic Disease Prevention Programs, Transfer to Health Disparities Program Fund It is the intent of the General Assembly that if actual Amendment 35 revenues are higher than the appropriation, the transfer to the Health Disparities Program Fund of 3.2 percent of Amendment 35 revenue be increased by a like amount.
- <u>Comment</u>: Staff recommends the Committee include this footnote to enable the transfer of 3.2 percent of Amendment 35 revenue to the Health Disparities Program Fund regardless of the Long Bill appropriation. Statute requires the transfer to equal 3.2 percent of Amendment 35 revenue and without the flexibility to increase the transfer if revenue is higher than the appropriation the Department would either violate the constitution by not transferring 3.2 percent or the Long Bill by exceeding the appropriation.

The following footnote should be continued if the Committee feels it is appropriate to reiterate existing language in the State Constitution. If the Committee feels that it is not appropriate to reiterate Constitutional language, the footnote should be discontinued. :

XX **Department of Public Health and Environment, Prevention Services Division, Women's Health --** Pursuant to Article V, Section 50, of the Colorado Constitution, no public funds shall be used by the State of Colorado, its agencies or political subdivisions to pay or otherwise reimburse, either directly or indirectly, any person, agency or facility for the performance of any induced abortion, provided however, that the General Assembly, by specific bill, may authorize and appropriate funds to be used for those medical services necessary to prevent the death of either a pregnant woman or her unborn child under circumstances where every reasonable effort is made to preserve the life of each.

- Comment: Staff is recommending this request for information be added to ensure that the Joint Budget Committee is aware of any mill levy increases that may result from funding the Air Pollutant Emissions and Dispersions Study.

- 1. **Department of Public Health and Environment, Water Quality Control** Division --The Department is requested to submit a report on CHANGES IN WORKLOAD AND STAFFING NEEDS OF the Water Quality Control Division FROM THE STAFFING NEEDS REPORTED TO THE JOINT BUDGET COMMITTEE ON NOVEMBER 1, 2012. This report is requested to include a summary of the Division's current and anticipated workload levels, including the impact of existing and proposed federal and state program requirements, as well as the associated funding and staffing needs based on the workload levels. This report is requested to include information on the upcoming fiscal year and out years. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012 2013.
- <u>Comment</u>: The report submitted on November 1, 2012 indicated a significant need for additional FTE. **Staff recommends the request be modified to report to the General Assembly on the change in FTE need from the prior year.** The recommendation will provide a clear picture of what sections of the division continue to have a growing need and which sections are properly staffed based on the recommendation to add FTE in FY 2013-14.
- 2. Department of Public Health and Environment, Air Pollution Control Division --The Department is requested to submit a report on CHANGES IN WORKLOAD AND STAFFING NEEDS OF the Air Pollution Control Division FROM THE NEEDS REPORTED TO THE JOINT BUDGET COMMITTEE ON NOVEMBER 1, 2012. This report is requested to include a summary of the Division's current and anticipated workload, including the impact of existing and proposed federal and state program requirements, as well as the associated funding and staffing needs, and the impact of the new resources added in FY 2012-13 on the backlog of permit applications and any additional resources need to completely eliminate the backlog. This report is requested to include information on the upcoming fiscal year and out-years. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012 2013.
- <u>Comment</u>: The report submitted on November 1, 2012 indicated there was still a need for additional FTE. **Staff recommends the request be modified to report to the General Assembly on the change in FTE need from the prior year.** This will provide a clear picture of what sections of the division have a growing need and which sections do not.
- 3. Department of Public Health and Environment, Hazardous Materials and Waste Management Division, Contaminated Site Cleanups and Remediation Programs --The Department is requested to submit a report on its CERCLA program. This report is requested to include detailed expenditures for the program, including out-year estimates by project and associated project financing. The report should also include an analysis of long-term funding needs of the State in responding to, litigating, and cleaning up CERCLA sites, including estimated long-term maintenance costs for these sites. The report should also provide information on the Hazardous Substance Response Fund

balance and out-year fiscal estimates. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012.

- Comment: The report provides information on future state costs related to the oversight of superfund sites in the State. Since these costs do not change significant year to year, staff recommends the request be sent every other year. Therefore for FY 2013-14 staff recommends the request for information not be sent.
- 4. Department of Public Health and Environment, Water Quality Control Division --- The Department is requested to submit a report on the National Pollutant Discharge Elimination System pesticide permit program. This report is requested to include a summary of the Water Quality Division's work, in collaboration with the Department of Agriculture, on establishing a pesticide permit. The report is requested to include a description of the permit options explored, funding options, staffing needs, and associated workload numbers for the upcoming fiscal year and out-years. The Department is requested to submit this report to the Joint Budget Committee by November 1, 2012.
- Comment: **Staff recommends this request for information be discontinued** since any new information and change in staffing needs will be included in the request for information on staff needs of the Water Quality Control Division.
