<u>Decision Item #5 – Operation and Maintenance of the Argo Tunnel Water Treatment</u> [see Environmental Divisions' briefing document issue pp. 14-16]

8. Please provide some additional information on the State's long term liability related to the Superfund program, including projects with long term operating and maintenance needs similar to those of the Argo Tunnel Water Treatment Plant. What is the State's ultimate annual potential responsibility for Superfund sites? Please discuss the other sites where the

- Department knows that EPA's payment of costs will end and result in similar increases in state costs.
- 9. Please provide additional detail on ASARCO's financial situation and the potential impacts on the State and the solvency of the Hazardous Substance Response Fund. Is the bankruptcy related to the company's potential Superfund liabilities?
- 10. Please provide additional detail on the heavy metals being removed by the Argo Tunnel Water Treatment Plant. What are they? Could we offset some of the plant's costs by recovering the heavy metals? Given the potential long term costs of operating the plant, would it be possible to simply seal the tunnel and contain the contaminants?

<u>Decision Item #7 – Solid Waste Program Additional FTE</u> [see Environmental Divisions' briefing document pg. 9]

11. The request asks for 3.4 additional cash funded FTE for the solid waste program, and the decision item specifically mentions large increases in the number of solid waste impoundment facilities subject to oversight by the solid waste program. Please discuss what is driving the program's increased workload related to impoundment facilities. What has changed at the existing waste water facilities to drive an increase in program oversight that will require additional FTE?

<u>Decision Item #8 – Radiation Control Program Uranium Licensing and Inspection</u> [see Environmental Divisions' briefing document pg. 9]

12. The request asks for 2.0 additional FTE for the uranium licensing and inspection program, based on the department's anticipation of two new uranium mill license applications. Please provide additional detail about the uranium licensing and inspection program. How many FTE does the program have now? Where are the new uranium milling operations supposed to be and when do you anticipate them opening?

<u>Decision Item #14 – Oil and Gas Conservation Commission</u> [see Environmental Divisions' briefing document pg. 10]

13. The request is for \$25,375 to maintain two software systems approved in an interim supplemental in September 2008. Did the department anticipate the need for this amount of resources to maintain the software systems when it proposed the interim supplemental? If not, why not? Why does maintenance cost this much relative to the supplemental?

[Background Information: The briefing document recommends cash funding the milk and dairy program through increased fees on the dairy industry, including increased fees for processing plants, haulers, and samplers, as well as new fees on dairy farms. The program is currently funded with General Fund.]

- 14. According to the Dairy Farmers of America (DFA), DFA operates the only certified milk testing lab in Colorado. Please discuss the reasoning behind the degree of inspections and testing performed by the dairy program when DFA is already testing the milk and milk that does not pass the test cannot go to market.
- 15. Please discuss the Department of Corrections' dairy operation. Does that dairy pay fees? Does it receive any exemptions from the department?
- 16. At the briefing, staff discussed breakage of seals on pasteurizers as one driver of the program's workload and slow response times to such breakages as a potential complaint by the processors. Please explain what would cause a seal to break.

Please discuss the sources of the Water Quality Control Division's increased workload. How much of the increased cost is due to anticipated new development? Do the department's calculations account for a reduction in new development going forward as a result of the economic climate? Please discuss how new developments would impact the program's workload; for example, do new streets and parking lots drive an increase in workload?
- 18. If the State does not hire the FTE discussed in the Water Quality Control Division report, will we be out of compliance with federal law?
- 19. Please provide information on the Water Quality Control Division's current ability to comply with both state and federal law. What is the downside to the U.S. EPA assuming responsibility for these programs if the State is out of compliance?

Could animal- or insect-borne disease testing, such as testing for rabies and plague, be done at lower cost on a contract basis by (1) state laboratories located in other states, (2) university laboratories within the state, where the testing might be done by graduate students, (3) private laboratories, or (4) local public health department laboratories such as those operated by the Weld County Department of Public Health and Environment.
- 27. Could serological testing, i.e. testing of human blood samples, be done at lower cost on a contract basis by (1) state laboratories located in other states, (2) university laboratories within the state, (3) private laboratories, or (4) local public health department laboratories.
- 28. This decision item includes \$150,000 to support the Lab's radiochemistry testing program. Is this program still needed given the closure of Rocky Flats in 2006 and the elimination of Federal support for the State's radiochemistry program following that closure? Do other states operate similar programs?
