- 2. Please explain why the Department does not anticipate cost savings associated with increased efficiencies realized from a realignment of the EDO.
- 3. Please clarify which, if any, administrative functions will remain at the division level. If any functions will remain at the division level, please explain why.
- 4. Will staff transferring to the Executive Director's Office (EDO) be physically moving, or will they remain located within division offices, but under the direction of the EDO?
- 5. The staff briefing noted 3.0 vacant FTE in the EDO that could offset part of the FTE increase.
  - a. Why are these 3.0 FTE not currently funded?
  - b. What is the current impact of these 3.0 FTE vacancies not being funded/filled?

c. Please explain why these 3.0 FTE are not currently funded. Seemingly, at some point, there was adequate funding to fill these vacancies. Please explain how funding shifted from these 3.0 FTE and where that funding is currently being used.

## 10:40-11:20 ADDITIONAL E-470 TROOPERS

## E-470 Contract and Payment

- 6. Was it the intent of the original Authority agreement that a portion of revenue would go toward increased safety and patrolling of the road, as provided by the Colorado State Patrol (CSP)?
- 7. When the CSP provides services for E-470, what portion is funded by the Authority? Are prorated costs of vehicles, vehicle maintenance, and equipment charged to the Authority?
- 8. The table included by CSP in the request indicated that troopers are logging more hours than the contracted amount. Additionally, the Department indicated that some hours billed to the Authority may be from troopers traveling through the corridor, but who are not necessarily assigned to the corridor for specific enforcement activities.
  - a. Please describe how E-470 payments are structured. For instance, is the Authority billed for actual hours, or is an annual payment made for the amount included in the contract?
  - b. How does the contract, CSP, and the Authority determine which trooper hours are billable to the Authority?
  - c. What happens if we do not use as many hours as the contract requires?
  - d. If additional funding is provided for the request, does the rest of the system gain back the hours provided by troopers that were over the contracted amount?
  - e. How did CSP and E-470 determine the number of needed hours (both in the current contract and in the requested increase) for the corridor?

## Statewide Staffing and Safety Data

- 9. Please provide the following information for the past five years by troop (including the E-470 corridor), and for the state as a whole. When possible, please provide a corresponding map.
  - a. A description of how the Patrol determines how many troopers are needed in each troop, and what that allocation has been;
  - b. Actual number of troopers;
  - c. Total crashes:
  - d. DUI/DUID crashes;
  - e. Fatal crashes.
- 10. Is there a difference in safety on toll roads versus other types of public roads? If so, please explain the differences.

- 11. When looking at E-470 safety and troop levels as compared to the rest of the state, does E-470 receive more safety and service than the other roads in the state? Is the trend toward tolling going to lead to those that can pay getting more safety and service than can be afforded on other public roads?
- 12. Does the E-470 troop participate in DUI enforcement campaigns paid for and conducted by the State? If so, does it operate differently from other campaigns?
- 13. How have the legalization of marijuana and the new felony DUI law impacted the need for troopers?
- 14. What level of maintenance does the Department provide for fleet vehicles? What is the role of the Department of Personnel in maintenance of Public Safety vehicles? How is maintenance for the Department's fleet vehicles funded?

# **Background**

- 15. Please provide history about the fire safety grant program, including the following:
  - a. What is the history of the state providing this type of funding and equipment to local governments?
  - b. Were Federal Mineral Lease (FML) moneys transferred from DOLA with H.B. 12-1283?
