Thank you for your recommendation letter dated January 24, 2013, which contained your committee's recommendations concerning the Department of Corrections budget request.

Your committee requested that the Joint Budget Committee expand the membership of the State Board of Parole, preferably to double its current size. Your committee further requested that the JBC fund this increase in membership from savings that occur as the result of more paroles.

Dear Senator Aguilar,

Thank you for your recommendation letter dated January 24, 2013 regarding the Committee's recommendations on the Department of Health Care Policy and Financing's FY 2013-14 budget request. You requested that the Joint Budget Committee, "encourage the Department of Health Care Policy and Financing to offer Behavioral Health Organization contracts to Regional Care Collaborative Organizations when possible." The Department is working to include requirement regarding the integration of mental and physical health into the 2014 rebid of the Behavioral Health Organization contracts and the 2015 rebid of the Regional Care Collaborative Organizations contracts. In addition, the Department reported that it received a \$2 million federal planning grant to apply for a larger grant to integrate mental health and physical health. Other states have received funds of between \$30 and \$50 million form this grant program.

Dear Representative Primavera,

Thank you for your recommendation letter dated January 23, 2013 regarding the Committee's recommendations on the Department of Health Care Policy and Financing's FY 2013-14 budget request. You requested that the Joint Budget Committee, "explore the costs of expanding the Medicaid Breast and Cervical Cancer Program to include treating women who are not initially diagnosed at a Women's Wellness Connection site but who otherwise meet the eligibility criteria for the Program." The Committee determined there were two options for how to increase funding for the treatment component of the Breast and Cervical Cancer Program including:

- 1. Increase screening to include a lower age group. Treatment for cancers diagnosed through this expansion would be required, but may be less costly than treatment for older clients; and/or
- 2. Divide the increased funding between the screening and treatment program so that both aspects of the Program are able to handle the increased workload.

The following table shows based on average cost of services of screening and treatment how many more women would be served if additional dollars are added to the Program. Since the treatment dollars are spent in the Department of Health Care Policy and Financing the dollars are eligible for the federal Medicaid match.

Thank you for your recommendation letter dated January 24, 2013 regarding the Committee's recommendations on the Department of Human Services FY 2013-14 budget request. The recommendations you provided included:

- Funding a statewide child abuse reporting hotline with savings from the Division of Youth Corrections;
- Funding restorative justice programs with saving from the Division of Youth Corrections;
- Fully funding the Behavioral Health Transformation Council; and
- Increasing respite family care for people with developmental disabilities by \$100,000.

The Joint Budget Committee approved the following appropriations:

- \$200,000 placeholder related to H.B. 13-1271, which would authorize a statewide child abuse reporting hotline. The placeholder is meant to fund the purchase of consulting services to assist the statewide child abuse hotline steering committee as it develops an implementation plan for the hotline system.
- There was no additional funding provided for restorative justice programs.
- \$20.0 million placeholder for behavioral health crisis services, \$4.3 million for increased community behavioral health capacity, \$2.1 million for a jail-based restoration to competency program, and \$1.2 million for additional school-based mental health services; and
- \$100,000 increase for respite family care for people with developmental disabilities by increasing the Family Support Services line item by \$100,000 General Fund.

Thank you for your letter dated January 25, 2013 regarding the Committee's recommendations on the Department of Natural Resources FY 2013-14 budget request. The Committee provided several recommendations. Below is a summary of Joint Budget Committee actions related to the specific recommendations pursuant to Section 2-7-204 (5) (a) (II), C.R.S.

- The Joint Budget Committee approved 14.4 additional compliance-related FTE for the Oil and Gas Conservation Commission (9.4 FTE above the Governor's request). The approval includes a total of \$1.5 million cash funds from the Oil and Gas Conservation and Environmental Response Fund.
- The Joint Budget Committee approved a total increase of \$335,924 cash funds and 3.0 FTE for the State Board of Land Commissioners, including the requested 1.0 FTE minerals field coordinator (as recommended by the Agriculture Committee) and the 2.0 FTE for strategic business initiatives.
- The Joint Budget Committee approved the Water Resources Division request to consolidate its budget from 12 line items to 8 line items.
- The Joint Budget Committee approved the Water Resources Division request to increase by \$100,000 cash funds (Satellite Monitoring System Cash Fund) funding for maintenance, technological improvements, and possibly an expansion of the Satellite Monitoring System.
- The Joint Budget Committee approved the Governor's request to temporarily reallocate approximately \$100,000 cash funds from the Operational Account of the Severance Tax Trust Fund to support the development of an electronic permitting system for the Division of Reclamation, Mining, and Safety's Minerals Program.
- The Joint Budget Committee did not take specific action on the Agriculture Committee's recommendation to have the Oil and Gas Conservation Commission provide prioritized inspection schedule for oil and gas wells.

Thank you for your letter dated January 29, 2013 regarding the Committee's recommendations on the Department of Natural Resources FY 2013-14 budget request. The Committee provided several recommendations. Below is a summary of Joint Budget Committee actions related to the specific recommendations pursuant to Section 2-7-204 (5) (a) (II), C.R.S.

- The Joint Budget Committee approved 14.4 additional compliance-related FTE for the Oil and Gas Conservation Commission (9.4 FTE above the Governor's request). The approval includes a total of \$1.5 million cash funds from the Oil and Gas Conservation and Environmental Response Fund.
- The Joint Budget Committee restored \$300,000 and 2.5 FTE to the Colorado Geological Survey, which is now located in the Colorado School of Mines. Because of ongoing revenue shortfalls in the Operational Account of the Severance Tax Trust Fund, the Committee elected to provide General Fund for this recommendation rather than severance tax funds.
- The Joint Budget Committee did not take specific action on the Agriculture Committee's recommendation to have the Oil and Gas Conservation Commission provide prioritized inspection schedule for oil and gas wells.
