## **Miscellaneous Questions**

Joint Budget Committee staff has proposed eliminating the current "Cash Funds Exempt" column in the Long Bill and replacing it with a new column entitled "Transfers" effective with the **FY 2008-09 Long Bill.** The Joint Budget Committee has not formally voted on this issue. For details of the proposed change, please read the Joint Budget Committee staff memo from November 15, 2006, entitled "Proposed Long Bill Format Change." To help departments understand the new format, our staff has prepared an example of the Department of Revenue FY 2006-07 Long Bill in the proposed new format. Please provide the Joint Budget Committee with a summary of any potential concerns that your department may have regarding the proposed change to the Long Bill format. Please highlight potential issues such as: implementation challenges, workload issues, and other related concerns.

- 22. Will the Department of State be responsible for implementing Amendment 41? If so, what will the responsibilities be?
- 23. What is the status of the Department of State's cash funds and the process of spending them down to get within statutory requirements?
- 24. How does the Secretary of State go about making rules? Under what statutory authority does the Secretary of State make rules? Does the Secretary of State have to consult the Legislature, or any other group, prior to implementing new rules?
- 25. Who uses the MNT other than state agencies?
- 26. Is there a firm schedule for making the Code of Colorado Regulations and the Colorado Register available online? If there is not a firm schedule, what additional resources would be required to establish a firm schedule for putting these resources online?
- 27. At the present time, expenses for operating the disaster recovery facility (e-FOR<sup>3</sup>T) are scattered over several existing line items in the Long Bill. Would it be more appropriate to separate out funding for this program into its own line item?
