## Proposal to Eliminate "Cash Funds Exempt" in the Long Bill

**Background.** Joint Budget Committee staff has proposed eliminating the current "Cash Funds Exempt" column in the Long Bill and replacing it with a new column entitled "Transfers" effective with the **FY 2008-09 Long Bill.** The Joint Budget Committee has not formally voted on this issue.
