Dear Chairwoman Hamner and the Members of the Committee,

The Network of Care was initially funded by the State of California through a grant from the Department of Aging in the fall of 2000. This was part of the "Aging with Dignity" Initiative to expand the availability of alternatives to nursing-home care and assist those with disabilities to remain in their own homes and communities. The Network of Care was created by Trilogy and developed as a partnership between the State of California, county governments and Trilogy to provide a broad array of social services online to persons with disabilities, the elderly, and to their families and caregivers. The project was first implemented in Alameda and Sacramento counties and quickly spread to another 15 California counties.

The Network of Care concept began to grow to other areas, leading the state Department of Mental Health to commission Trilogy to construct a site for the mental-health community that would be first launched in San Diego County in 2003. The Network of Care is now found in more 700 regions nationwide in 27 states, covering more than 40 percent of the nation's population. This represents the largest repository of local, state and national resources in the nation.

The Network of Care is publically funded, free to the public, with no ads. Enhancements to the site developed by one customer or agency are made available to everyone when applicable, making the NOC a best-practices magnet with more than 17 years of development and millions of dollars of investment.

The Network of Care has found great success in Colorado, starting almost 10 years ago in Boulder. Here are some facts about the Network of Care in the State of Colorado:

- Started with Seniors site in Boulder County in 2008
- Currently 8 Colorado regional sites – 6 Seniors, 1 Veterans, 1 Public Health
 - DRCOG, Pikes Peak, Larimer, Boulder, NWCOG, SJAAA
- Current Network of Care sites serve almost 4 million Coloradans
- Almost one million annual site visits statewide, 440,000 service provider page views

But we at Trilogy Integrated Resources would like to do more for the State of Colorado and its citizens. Similar to statewide projects Trilogy has completed in other states, we would like to expand all Network of Care services to the entire State of Colorado. The Peak Military Care Network (PMCN) is pleased to recommend the Network of Care as a resource that would benefit service members, veterans and their families across Colorado.

PMCN, first as a program under the Pikes Peak Area Council of Governments and now as a 501(C)(3) nonprofit organization, has been utilizing the Network of Care as a resource for the military and veteran community in the Pikes Peak region since 2011. The site's additional features, including a place for service members, veterans and family members to securely store military and veteran records, legal documents, caregiver information, etc. serve as valuable tools, as well. We have also customized the site to provide more benefit to our military and veteran community, including the ability to connect with us through an on-line form for more personal assistance, and we utilize the Network of Care's back-end call center database to track information on services needed and resources provided to individuals we assist so that we can track trends in service needs and gaps in our community to meet needs more effectively.

The Network of Care not only supports PMCN and our partners, but also those seeking assistance, with a multitude of resources in one location. Our Network of Care has more than 8,000 visits per month, and usage has grown significantly over the last two years. Having the Network of Care's capabilities across the entire state would benefit the state's more than 400,000 veterans and their families.



Dear Kathy,

I'm writing to express my support for Colorado's Joint Budget Committee to consider adopting Network of Care's public health platform for use by all Colorado counties. We have been using it here in Larimer County for the past several years as a reliable source of local health data, including health indicators both from the federal Health Data Warehouse as well as from our own locally collected data.

When states adopt this tool for all their counties, it allows legislators and the public to quickly compare health indicators statewide in a format that is easy to view. It can also be used to track the status of state and county health improvement plans and their results.

This tool also has many additional features which we have not tapped into because of our interest in focusing primarily on health statistics. Our county's Office on Aging uses Network of Care to provide health information and sources of local assistance programs to our county's senior population, as well as to track data about calls and requests for services that are required for their federal funding.

I hope that the JBC will seriously consider the advantages of making this system available for all Colorado citizens to be able to get information on local health resources, local health data, and how they compare to other counties in Colorado. For smaller counties and those with limited resources, this information can be very valuable for prioritizing services and writing grant proposals.
