HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB21-1067 be amended as follows:

1 Amend printed bill, page 3, strike lines 20 through 27.

2 Page 4, strike lines 1 through 3 and substitute:

3 "(10.5) (a) (I) ON OR BEFORE JUNE 30, 2023, AND ON OR BEFORE  
4 JUNE 30 EACH YEAR THEREAFTER, THE DEPARTMENT OF EDUCATION SHALL  
5 PUBLISH AN ANNUAL REPORT INCLUDING:

6 (A) WHICH STATE-SUPPORTED BACCALAUREATE AND GRADUATE  
7 INSTITUTIONS OF HIGHER EDUCATION REQUIRED, AND WHICH INSTITUTIONS  
8 DID NOT REQUIRE, A NATIONAL ASSESSMENT TEST SCORE AS AN  
9 ELIGIBILITY CRITERION FOR THE PREVIOUS ACADEMIC YEAR'S FIRST-TIME  
10 FRESHMAN COHORT;

11 (B) THE PERCENTAGE OF FIRST-TIME FRESHMEN STUDENTS, BOTH  
12 STATEWIDE AND BY INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A  
13 NATIONAL ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE,  
14 ETHNICITY, AND GENDER;

15 (C) THE PERCENTAGE OF FIRST-TIME FRESHMEN STUDENTS, BOTH  
16 STATEWIDE AND BY INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A  
17 NATIONAL ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE,  
18 ETHNICITY, AND GENDER, AND ENROLLED IN AN INSTITUTION;

19 (D) THE PERCENTAGE OF STUDENTS, BOTH STATEWIDE AND BY  
20 INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A NATIONAL  
21 ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE, ETHNICITY, AND  
22 GENDER, WHO ENROLLED IN THE INSTITUTION IN A SUBSEQUENT ACADEMIC  
23 YEAR;

24 (E) THE PERCENTAGE OF STUDENTS, BOTH STATEWIDE AND BY  
25 INSTITUTION, WHO SUBMITTED OR DID NOT SUBMIT A NATIONAL  
26 ASSESSMENT TEST SCORE, DISAGGREGATED BY RACE, ETHNICITY, AND  
27 GENDER, WHO GRADUATED FROM THE INSTITUTION;"

28 Reletter succeeding sub-subparagraphs accordingly.

29 Page 4, line 9, strike "CURRENT" and substitute "PREVIOUS".

30 Page 4, line 10, strike "INSTITUTION" and substitute "DEPARTMENT OF  
31 EDUCATION".

32 Page 4, line 20, strike "MARCH 1, 2022, AND ON OR BEFORE MARCH 1"  
33 and substitute "JUNE 30, 2023, AND ON OR BEFORE JUNE 30".

34 Page 4, line 24, strike "SECTION" and substitute "SECTION."

35 Page 4, strike line 25.
