## SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.SB20-019 be amended as follows:

- 1 Amend printed bill, page 3, strike lines 20 and 21.
- 2 Page 3, line 26, strike "SIX" and substitute "TEN".
- 3 Page 3, line 27, after "SENATORS" insert "AND ONE NONLEGISLATIVE
- 4 MEMBER FROM A STATEWIDE ORGANIZATION REPRESENTING COLORADO
- 5 COUNTIES".
- 6 Page 4, line 2, after "SENATOR" insert "AND ONE NONLEGISLATIVE
- 7 MEMBER FROM A STATEWIDE ORGANIZATION REPRESENTING COLORADO
- 8 MUNICIPALITIES, CITIES, OR TOWNS".
- 9 Page 4, line 4, after "REPRESENTATIVES" insert "AND ONE
- 10 NONLEGISLATIVE MEMBER FROM A STATEWIDE ORGANIZATION
- 11 REPRESENTING COLORADO SPECIAL DISTRICTS".
- 12 Page 4, line 6, after "REPRESENTATIVE" insert "AND ONE NONLEGISLATIVE
- 13 MEMBER FROM A STATEWIDE ORGANIZATION REPRESENTING SCHOOL
- 14 DISTRICT LEADERSHIP IN THE STATE".
- 15 Page 4, strike lines 7 through 9 and substitute:
  - 16 "(c) (I) THE NONLEGISLATIVE MEMBERS SHALL SERVE AS NON-
  - 17 VOTING MEMBERS OF THE COMMITTEE.
  - 18 (II) APPOINTEES TO THE COMMITTEE MUST HAVE EXPERIENCE WITH
  - 19 OR INTEREST IN THE STUDY AREAS OF THE COMMITTEE."
- 20 Renumber succeeding subparagraph accordingly.
- 21 Page 5, strike lines 9 through 11 and substitute "NECESSARY FOR THE
- 22 OPERATION OF THE COMMITTEE."
- 23 Page 5, line 12, strike "MEMBERS" and substitute "LEGISLATIVE
- 24 MEMBERS".
- 25 Page 5, line 18, strike "THEY DEEM" and substitute "EACH DEEMS".
- 26 Page 5, line 19, strike "(I)".
- 27 Page 5, strike lines 21 through 25.

1 Page 5, line 26, strike "(I)".

2 Page 6, strike lines 2 and 3 and substitute:

3 "(c) THE COMMITTEE SHALL STUDY TAX POLICY AND MAY DEVELOP  
4 ANY MODIFICATIONS TO THE CURRENT SYSTEM OF STATE AND LOCAL  
5 TAXATION.

6 (d) UPON REQUEST BY A LEGISLATOR OR A LEGISLATIVE MEMBER  
7 OF THE COMMITTEE, THE COMMITTEE SHALL PROVIDE EVIDENCE-BASED  
8 FEEDBACK ON THE POTENTIAL BENEFITS OR CONSEQUENCES OF A  
9 LEGISLATIVE OR OTHER POLICY PROPOSAL NOT DIRECTLY AFFILIATED WITH  
10 OR GENERATED BY THE COMMITTEE, INCLUDING ANY BILL OR RESOLUTION  
11 INTRODUCED BY THE GENERAL ASSEMBLY THAT AFFECTS TAX POLICY. THE  
12 FEEDBACK MUST BE PROVIDED WITHIN TWO WEEKS OF THE REQUEST AND  
13 REMAIN AS CONCISE AS POSSIBLE WHILE CAPTURING ANY AVAILABLE  
14 EVIDENCE. IF THE COMMITTEE CANNOT IDENTIFY EVIDENCE TO  
15 EFFECTIVELY INFORM A RESPONSE, THE FEEDBACK WILL INDICATE A LACK  
16 OF EVIDENCE.

17 (e) THE COMMITTEE MAY WORK WITH AND DEVELOP  
18 RELATIONSHIPS WITH OTHER STATE AGENCIES, GROUPS, INTERIM  
19 LEGISLATIVE COMMITTEES, TASK FORCES, ORGANIZATIONS, OR STATEWIDE  
20 INITIATIVES THAT ARE PURSUING ISSUES AND POLICY INITIATIVES SIMILAR  
21 TO THOSE ADDRESSED IN THIS SUBSECTION (2) IN ORDER TO LEVERAGE  
22 EFFICIENT POLICY-MAKING OPPORTUNITIES THROUGH COLLABORATIVE  
23 EFFORTS."

24 Reletter succeeding paragraphs accordingly.

25 Page 6, line 12 strike "AND THE TASK FORCE".

26 Page 6, strike lines 17 through 27.

27 Strike pages 7 through 11.

28 Page 12, strike lines 1 through 3.

29 Renumber succeeding C.R.S. section number accordingly.
