HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Rural Affairs & Agriculture.

HB19-1029 be amended as follows:

1 Amend corrected printed bill, page 2, line 20, strike "(1)" and substitute
2 "(1), (2),".

3 Page 3, strike lines 7 and 8 and substitute "CHEYENNE, and Logan shall
4 each appoint one director. ~~who shall be a resident of the respective~~
5 ~~county.~~ One member of the board shall be".

6 Page 3, strike lines 14 through 21 and substitute:

7 "(b) (I) Each director ~~shall~~ MUST be, at the time of the director's
8 appointment:

9 (A) A resident OF THE STATE OF COLORADO;

10 (B) A RESIDENT OF A COUNTY THAT IS, IN WHOLE OR IN PART,
11 WITHIN THE BOUNDARIES OF THE DISTRICT; AND

12 (C) ~~and~~ AN owner of real property THAT IS within the ~~county or~~
13 ~~ground water management~~ BOUNDARIES OF THE district from which ~~he or~~
14 ~~she~~ THE DIRECTOR is appointed, ~~or, if only a part of~~ AS WELL AS WITHIN
15 the county or ground water management district ~~is included within the~~
16 ~~boundaries of the district,~~ a resident and owner of real property within
17 ~~such included part.~~ The director appointed by the Colorado ground water
18 ~~commission shall, at the time of appointment, reside within the district~~
19 FROM WHICH THE DIRECTOR IS APPOINTED.

20 (II) Each director shall be appointed".

21 Page 4, after line 12 insert:

22 "(2) The office of a director ~~shall become~~ BECOMES vacant when
23 the director ceases to reside in the ~~county or ground water management~~
24 ~~district from which the director was appointed,~~ or in the case of
25 COLORADO OR WITHIN A COUNTY THAT IS, IN WHOLE OR IN PART, WITHIN
26 THE BOUNDARIES OF THE DISTRICT, OR WHEN THE DIRECTOR NO LONGER
27 OWNS REAL PROPERTY THAT IS WITHIN THE BOUNDARIES OF THE DISTRICT
28 AND WITHIN THE COUNTY OR GROUND WATER MANAGEMENT DISTRICT
29 FROM WHICH THE DIRECTOR IS APPOINTED. The OFFICE OF A director
30 appointed by the Colorado ground water commission BECOMES VACANT
31 when the director ~~ceases to reside in the district or~~ is no longer a member
32 of the Colorado ground water commission or when declared vacant by a
33 majority vote of all of the members of the board when a director has
34 failed to attend two consecutive regular meetings without having been
35 excused from attendance by the president. If a vacancy occurs in the
36 office by reason of death, resignation, removal, or otherwise, it shall be
37 filled for the remainder of the unexpired term by the board of county
38 commissioners of the county, or the ground water management district
39 from which the director was originally appointed. Each director shall take
40 an oath or affirmation in accordance with section 24-12-101."
