HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public Health Care & Human Services.

HB18-1094 be amended as follows:

1 Amend printed bill, page 13, lines 8 and 9, strike "standards. THE" and
2 substitute "standards - advisory board. (1) THE".

3 Page 13, line 9, strike "SECTION 27-65-131" and substitute "SUBSECTION
4 (2) OF THIS SECTION".

5 Page 13, strike lines 13 through 27.

6 Page 14, strike lines 1 through 23 and substitute:

7 "(2) AN ADVISORY BOARD TO THE STATE DEPARTMENT IS
8 ESTABLISHED FOR THE PURPOSE OF ASSISTING AND ADVISING THE
9 EXECUTIVE DIRECTOR IN ACCORDANCE WITH THIS SECTION IN THE
10 DEVELOPMENT OF SERVICE STANDARDS AND RULES. THE ADVISORY BOARD
11 CONSISTS OF NOT LESS THAN ELEVEN NOR MORE THAN FIFTEEN MEMBERS
12 APPOINTED BY THE STATE DEPARTMENT AS FOLLOWS:

13 (a) ONE REPRESENTATIVE EACH FROM THE OFFICE OF BEHAVIORAL
14 HEALTH; THE OFFICE OF CHILDREN, YOUTH, AND FAMILIES; THE
15 DEPARTMENT OF HEALTH CARE POLICY AND FINANCING; AND A LEADING
16 PROFESSIONAL ASSOCIATION OF PSYCHIATRISTS IN THIS STATE;

17 (b) ONE MEMBER REPRESENTING NONPROFIT HEALTH CARE
18 FACILITIES;

19 (c) ONE MEMBER REPRESENTING CHILDREN OR YOUTH CONSUMERS
20 OF SERVICES FOR PERSONS WITH MENTAL HEALTH DISORDERS;

21 (d) ONE MEMBER REPRESENTING FAMILIES OF PERSONS WITH
22 MENTAL HEALTH DISORDERS;

23 (e) ONE MEMBER REPRESENTING CHILDREN'S HEALTH CARE
24 FACILITIES;

25 (f) ONE MEMBER REPRESENTING A COMMUNITY MENTAL HEALTH
26 CENTER THAT PERFORMS EVALUATIONS PURSUANT TO THIS ARTICLE 67;

27 (g) ONE MEMBER REPRESENTING A COUNTY HUMAN OR SOCIAL
28 SERVICES AGENCY;

29 (h) ONE MEMBER REPRESENTING INDIVIDUALS WITH INTELLECTUAL
30 AND DEVELOPMENTAL DISABILITIES; AND

31 (i) OTHER PERSONS FROM BOTH THE PRIVATE AND THE PUBLIC
32 SECTORS WHO ARE RECOGNIZED OR KNOWN TO BE INTERESTED AND
33 INFORMED IN THE AREA OF THE ADVISORY BOARD'S PURPOSE AND
34 FUNCTION.

35 (3) IN MAKING APPOINTMENTS TO THE ADVISORY BOARD, THE
36 STATE DEPARTMENT MUST INCLUDE REPRESENTATION BY AT LEAST ONE
37 MEMBER WHO IS A PERSON WITH A DISABILITY, AS DEFINED IN SECTION
38 24-45.5-102 (2); A FAMILY MEMBER OF A PERSON WITH A DISABILITY; OR
39 A MEMBER OF AN ADVOCACY GROUP FOR PERSONS WITH DISABILITIES,
40 PROVIDED THAT THE OTHER REQUIREMENTS OF SUBSECTION (2) OF THIS
41 SECTION ARE MET."
