HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB18-1092 be amended as follows:

- 1 Amend printed bill, page 3, line 23, strike "MUNICIPALITIES." and  
2 substitute "MUNICIPALITIES, AND THE MEMORANDUM OF UNDERSTANDING  
3 MUST INCLUDE AN AGREEMENT ON REVENUE SHARING, INCLUDING A  
4 REQUIREMENT THAT THE POINT OF TAXATION IS AT THE STORE."
- 5 Page 4, line 8, strike "licenses." and substitute "licenses - repeal."
- 6 Page 4, strike line 15 and substitute:

- 15 Page 5, line 4, strike "TO DELIVER MEDICAL MARIJUANA AND" and  
16 substitute "NOTWITHSTANDING THE PROVISIONS OF SECTION 12-43.3-901  
17 (4)(h), TO DELIVER MEDICAL MARIJUANA,".
- 18 Page 5, line 5, strike "PRODUCTS" and substitute "PRODUCTS, AND  
19 MEDICAL MARIJUANA CONCENTRATE".
- 20 Page 5, line 8, strike "ADDRESS;" and substitute "ADDRESS IN THE  
21 JURISDICTION THAT IS OTHERWISE LICENSED TO SELL AND DELIVER  
22 MARIJUANA;".
- 23 Page 5, line 9, strike "MARIJUANA AND" and substitute "MARIJUANA,".
- 24 Page 5, line 10, strike "PRODUCTS" and substitute "PRODUCTS, AND RETAIL  
25 MARIJUANA CONCENTRATE".
- 26 Page 5, line 11, strike "ADDRESS." and substitute "ADDRESS IN THE  
27 JURISDICTION THAT IS OTHERWISE LICENSED TO SELL AND DELIVER  
28 MARIJUANA.".
- 29 Page 6, line 3, strike "MARIJUANA AND" and substitute "MARIJUANA,".
- 30 Page 6, line 4, strike "PRODUCTS" and substitute "PRODUCTS, AND

- 1 MEDICAL MARIJUANA CONCENTRATE".
- 2 Page 6, line 11, strike "MARIJUANA OR" and substitute "MARIJUANA,".
- 3 Page 6, line 12, strike "PRODUCTS" and substitute "PRODUCTS, OR  
4 MEDICAL MARIJUANA CONCENTRATE".
- 5 Page 6, line 19, strike "RETAIL MARIJUANA AND RETAIL MARIJUANA  
6 PRODUCTS" and substitute "RETAIL MARIJUANA, RETAIL MARIJUANA  
7 PRODUCTS, AND RETAIL MARIJUANA CONCENTRATE".
- 8 Page 6, line 24, strike "MARIJUANA OR" and substitute "MARIJUANA,".
- 9 Page 6, line 25, strike "PRODUCTS" and substitute "PRODUCTS, AND RETAIL  
10 MARIJUANA CONCENTRATE".
- 11 Page 7, line 5, strike "SEPTEMBER 1, 2018." and substitute "JANUARY 1,  
12 2019.".
- 13 Page 7, line 6, strike "JULY 1," and substitute "DECEMBER 31,".
- 14 Page 7, after line 6 insert:  
15 "SECTION 5. In Colorado Revised Statutes, add 12-43.4-106 as  
16 follows:  
17 **12-43.4-106. Marijuana delivery - repeal.**  
18 (1) NOTWITHSTANDING ANY PROVISION OF THIS ARTICLE 43.4 TO THE  
19 CONTRARY, A PERSON LICENSED PURSUANT TO SECTION 12-43.3-409 MAY  
20 DELIVER RETAIL MARIJUANA, RETAIL MARIJUANA PRODUCTS, AND RETAIL  
21 MARIJUANA CONCENTRATE PURSUANT TO THE PROVISIONS OF SECTION  
22 12-43.3-409 AND ANY RULES ADOPTED PURSUANT TO SECTION  
23 12-43.3-202 (2)(a)(XXIII).  
24 (2) THIS SECTION IS REPEALED, EFFECTIVE DECEMBER 31, 2020.".
- 25 Renumber succeeding section accordingly.
- 26 After "PRODUCTS," add "MEDICAL MARIJUANA CONCENTRATE," on: **Page**  
27 **2**, line 14; and **Page 3**, lines 3, 7, and 16.
- 28 Strike "AND" on: **Page 2**, line 14; and **Page 3**, lines 3, 7, and 17.
- 29 Strike "PRODUCTS" and substitute "PRODUCTS, AND RETAIL MARIJUANA  
30 CONCENTRATE" on: **Page 2**, line 15; and **Page 3**, lines 4, 8, and 17.
