HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public Health Care & Human Services.

HB18-1187 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and
2 substitute:

3 "SECTION 1. In Colorado Revised Statutes, 18-18-102, **amend**
4 the introductory portion and (18) as follows:

5 **18-18-102. Definitions.** As used in this ~~article~~ ARTICLE 18:

6 (18) (a) "Marijuana" means all parts of the plant *cannabis sativa*
7 L., whether growing or not, the seeds thereof, the resin extracted from any
8 part of the plant, and every compound, manufacture, salt, derivative,
9 mixture, or preparation of the plant, its seeds, or its resin. It does not
10 include fiber produced from the stalks, oil, or cake made from the seeds
11 of the plant, or sterilized seed of the plant which is incapable of
12 germination if these items exist apart from any other item defined as
13 "marijuana" in this subsection (18). "Marijuana" does not include
14 marijuana concentrate as defined in subsection (19) of this section OR
15 PRESCRIPTION DRUG PRODUCTS APPROVED BY THE FEDERAL FOOD AND
16 DRUG ADMINISTRATION AND DISTRIBUTED BY A PHARMACY OR
17 PRESCRIPTION DRUG OUTLET REGISTERED BY THE STATE OF COLORADO.

18 (b) NOTHING IN THIS SUBSECTION (18) OR ANY OTHER PROVISION
19 OF LAW SHALL RESTRICT OR OTHERWISE AFFECT REGULATION OF OR
20 ACCESS TO:

21 (I) MARIJUANA THAT IS AUTHORIZED UNDER SECTIONS 14 AND 16
22 OF ARTICLE XVIII OF THE COLORADO CONSTITUTION AND ARTICLES 43.3
23 AND 43.4 OF TITLE 12; OR

24 (II) INDUSTRIAL HEMP AND DERIVATIVES THEREFROM, AS
25 AUTHORIZED BY SECTION 16 OF ARTICLE XVIII OF THE COLORADO
26 CONSTITUTION AND ARTICLE 61 OF TITLE 35.

27 **SECTION 2. Act subject to petition - effective date.** This act
28 takes effect at 12:01 a.m. on the day following the expiration of the
29 ninety-day period after final adjournment of the general assembly (August
30 8, 2018, if adjournment sine die is on May 9, 2018); except that, if a
31 referendum petition is filed pursuant to section 1 (3) of article V of the
32 state constitution against this act or an item, section, or part of this act
33 within such period, then the act, item, section, or part will not take effect
34 unless approved by the people at the general election to be held in
35 November 2018 and, in such case, will take effect on the date of the
36 official declaration of the vote thereon by the governor."
