County Salary Reclassification

Sponsors: Reps. K. Becker & Valdez/Sen. Crowder

In 2015, the Colorado General Assembly passed SB15-288, enacting pay raises for all county and state elected offices. For county elected officials, those pay raises will finally go into effect when these county elected officials (commissioners, sheriffs, clerks & recorders, treasurers, etc.) are sworn in for a new term, beginning January of 2019.

At the request of CCI, SB15-288 also established new subcategories within the existing county salary structure to provide flexibility in case certain counties could not afford the pay raises. These subcategories were created in direct response to concerns from some counties about their local ability to accommodate a salary raise from a budgetary standpoint.

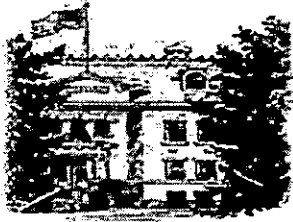
In 2016, a number of counties requested a move downward to the lowest subcategory (which featured no pay raise at all) because of budgetary concerns. Economic conditions have improved in some of these counties since that time, and they are now in a financial position to request a move up in subcategory in order to award their elected officials the raise that was approved back in 2015.

HB 1242 will move four counties up to the following subcategories: Grand: Category III-B (20% increase), Jackson: Category VI-C (10% raise), Rio Grande: Category IV-C (10% increase) and Saguache: Category V-B (20%). These counties respectfully ask that the General Assembly reset their subcategory classification so they can give their sheriffs, clerks, treasurers, coroners, surveyors and commissioners the raise that was approved by the legislature in 2015.





Thank you so much for your continued time and support to Grand County and, in particular, to help our county achieve these salary increases for our elected officials.



Over the past 10 years there has not been a salary increase for any elected official in Rio Grande County. Due to the increase of our assessed valuation, the lack of salary increases to coincide with the increase in the cost of living expenses, we feel it is time for us to move from a Category IV-D to a Category IV-C classification.

This decision was not made lightly. We have had a lot of discussion among the Elected Officials who are committed to the financial health of Rio Grande County. However, as leaders of our communities, we realize it is important to attract and keep Elected Officials who are committed to the growth and sustainability of our County. Our present salaries are not competitive with the private sector. The working Elected Officials often supervise staff that are making as much or more than they do. 

Members of the General Assembly:


As you are aware HB18-1242 has been introduced. We would like to thank you for your support of this bill.

Jackson County's assessed valuation for 2006 was \$31,191,220, and has seen significant increases \$45,978,060 in 2016 and \$55,697,949 in 2017. Gas and oil energy has had an impact on our revenues. We are confident that moving from a Category VI-D to a VI-C will not present a financial burden on our County.

The Board approved 5% cost of living increases for all County employees in 2017 and 2018; 3% increases have been approved every year since 2006.
