SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB17-136 be amended as follows:

- 1 Amend printed bill, page 10, strike lines 24 through 27 and substitute:
- 2 **"16-13-306.5. Limitations on receipt of payments from federal**
- 3 **government.** (1) A SEIZING AGENCY OR PARTICIPANT IN ANY JOINT TASK
- 4 FORCE OR OTHER MULTIJURISDICTIONAL COLLABORATION SHALL ONLY
- 5 ACCEPT PAYMENT OR DISTRIBUTION OF FORFEITURE PROCEEDS FROM THE
- 6 FEDERAL GOVERNMENT RESULTING FROM ADOPTION OR A JOINT TASK
- 7 FORCE OR OTHER MULTIJURISDICTIONAL COLLABORATION IF THE
- 8 FORFEITURE INVOLVES A SEIZURE OF PROPERTY WHICH RESULTS IN
- 9 PROCEEDS OF FIFTY THOUSAND DOLLARS OR LESS AND A FORFEITURE
- 10 ACTION IS COMMENCED IN FEDERAL COURT UNDER 21 U.S.C. SEC. 853."

- 11 Page 11, strike lines 1 through 12.

- 12 Renumber succeeding subsection accordingly.

- 13 Page 11, line 13, strike "SUBSECTIONS (1) AND (2)" and substitute
- 14 "SUBSECTION (1)".

- 15 Page 11, strike lines 20 through 27 and substitute:
- 16 **"16-13-504.5. Limitations on receipt of payments from federal**
- 17 **government.** (1) A SEIZING AGENCY OR PARTICIPANT IN ANY JOINT TASK
- 18 FORCE OR OTHER MULTIJURISDICTIONAL COLLABORATION SHALL ONLY
- 19 ACCEPT PAYMENT OR DISTRIBUTION OF FORFEITURE PROCEEDS FROM THE
- 20 FEDERAL GOVERNMENT RESULTING FROM ADOPTION OR A JOINT TASK
- 21 FORCE OR OTHER MULTIJURISDICTIONAL COLLABORATION IF THE
- 22 FORFEITURE INVOLVES A SEIZURE OF PROPERTY WHICH RESULTS IN
- 23 PROCEEDS OF FIFTY THOUSAND DOLLARS OR LESS AND A FORFEITURE
- 24 ACTION IS COMMENCED IN FEDERAL COURT UNDER 21 U.S.C. SEC. 853."

- 25 Page 12, strike lines 1 through 8.

- 26 Renumber succeeding subsection accordingly.

- 27 Page 12, line 9, strike "SUBSECTIONS (1) AND (2)" and substitute
- 28 "SUBSECTION (1)".
