SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.SB17-192 be amended as follows:

1 Amend the Business, Labor, & Technology Committee Report, dated
2 March 8, 2017, page 1, line 3, after "**amend**" insert "(1)(a),".

3 Page 1, strike line 7 and substitute:

4 "**rules.** (1) The state licensing authority shall:

5 (a) Grant or refuse state licenses for the cultivation, manufacture,
6 distribution, and sale of medical marijuana as provided by law; suspend,
7 fine, restrict, or revoke such licenses, WHETHER ACTIVE, EXPIRED, OR
8 SURRENDERED, upon a violation of this ~~article~~ ARTICLE 43.3, or a rule
9 promulgated pursuant to this ~~article~~ ARTICLE 43.3; and impose any penalty
10 authorized by this ~~article~~ ARTICLE 43.3 or any rule promulgated pursuant
11 to this ~~article~~ ARTICLE 43.3. The state licensing authority may take any
12 action with respect to a registration pursuant to this ~~article~~ ARTICLE 43.3
13 as it may with respect to a license pursuant to this ~~article~~ ARTICLE 43.3,
14 in accordance with the procedures established pursuant to this ~~article~~
15 ARTICLE 43.3.

16 (2) (a) Rules promulgated pursuant to ~~paragraph (b) of~~
17 ~~subsection~~".

18 Page 7, line 26, after "**amend**" insert "(2)(a),".

19 Page 7, strike line 30 and substitute:

20 "**rules.** (2) The state licensing authority has the authority to:

21 (a) Grant or refuse state licenses for the cultivation, manufacture,
22 distribution, sale, and testing of retail marijuana and retail marijuana
23 products as provided by law; suspend, fine, restrict, or revoke such
24 licenses, WHETHER ACTIVE, EXPIRED, OR SURRENDERED, upon a violation
25 of this ~~article~~ ARTICLE 43.4 or any rule promulgated pursuant to this
26 ~~article~~ ARTICLE 43.4; and impose any penalty authorized by this ~~article~~
27 ARTICLE 43.4 or any rule promulgated pursuant to this ~~article~~ ARTICLE
28 43.4. The state licensing authority may take any action with respect to a
29 registration pursuant to this ~~article~~ ARTICLE 43.4 as it may with respect to
30 a license pursuant to this ~~article~~ ARTICLE 43.4, in accordance with the
31 procedures established pursuant to this ~~article~~ ARTICLE 43.4.
