HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.HB17-1251 be amended as follows:

- 1 Amend printed bill, page 3, line 17, strike "report - repeal." and
- 2 substitute "report."
- 3 Page 3, line 24, strike "(I)".
- 4 Page 4, line 1, after "plan," insert "NOTWITHSTANDING SECTION 24-1-136
- 5 (11)(a)(I),".
- 6 Page 4, strike lines 8 and 9.
- 7 Page 5, strike lines 24 through 27.
- 8 Strike page 6.
- 9 Page 7, strike lines 1 through 18 and substitute:

10 "SECTION 7. In Colorado Revised Statutes, 23-5-129, amend

11 (5)(a) and (5)(b) as follows:

12 **23-5-129. Governing boards - performance contract -**

13 **authorization - operations - reports - definitions.**

14 (5) (a) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), beginning

15 January 2006, and each January thereafter, the department of higher

16 education shall report to the members of the education committees of the

17 senate and the house of representatives and the members of the joint

18 budget committee of the general assembly the financial effect of the

19 provisions of each performance contract with regard to funding for the

20 affected governing board of a state institution of higher education and

21 overall funding for the statewide system of higher education and a review

22 of each state or private institution's operations under the institution's

23 performance contract. The term of a performance contract may be up to

24 ten years. The department of higher education may renew a performance

25 contract at its discretion, with the agreement of the governing board.

26 (b) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), beginning

27 January 2006, and each January thereafter, data collected and used to

28 measure a state or private institution of higher education's progress

29 towards the goals set forth in the institution's performance contract with

30 the department of higher education shall be made available to the

31 members of the education committees of the house of representatives and



1 the senate, members of the joint budget committee, each governing board,
2 and each institution of higher education covered by a performance
3 contract. The department of higher education shall also provide copies of
4 the data to other members of the general assembly and members of the
5 public on request.

6 **SECTION 8.** In Colorado Revised Statutes, 23-8-104, **amend** (2)
7 introductory portion as follows:

8 **23-8-104. Reports.** (2) NOTWITHSTANDING SECTION 24-1-136
9 (11)(a)(I), on or before February 28, 2009, and on or before February 28
10 each year thereafter, the board shall submit a report to the joint budget
11 committee and to the education committees of the house of
12 representatives and the senate, or any successor committees, on the
13 implementation and results of programs funded pursuant to this article
14 ARTICLE 8, including:".

17 Page 10, strike lines 1 through 22 and substitute:

18 "SECTION 10. In Colorado Revised Statutes, 23-20-119, **repeal**
19 (2) as follows:

20 **23-20-119. Corporate stock in name of nominee authorized.**
21 (2) ~~A report shall be made by the regents of the university of Colorado,~~
22 ~~to the general assembly at each regular session, of the investments made~~
23 ~~and the interest derived therefrom under the provisions of this section and~~
24 ~~section 23-20-118.~~

25 **SECTION 11.** In Colorado Revised Statutes, **repeal** 23-21-521
26 as follows:

27 **23-21-521. Annual report.** ~~The authority shall submit to the~~
28 ~~governor and the joint budget committee within six months after the end~~
29 ~~of the fiscal year a report which shall set forth a complete and detailed~~
30 ~~operating and financial statement of the authority during such year. Also~~
31 ~~included in the report shall be any recommendations with reference to~~
32 ~~additional legislation or other action that may be necessary to carry out~~
33 ~~the purposes of the authority.~~

34 **SECTION 12.** In Colorado Revised Statutes, 23-30-122, **repeal**
35 (3) as follows:

36 **23-30-122. Corporate stock in nominee authorized.** (3) ~~The~~
37 ~~board shall report to the joint budget committee of the general assembly~~

1 at each regular session regarding the investments made and the earnings
2 or losses derived therefrom under the provisions of this section and
3 section 23-30-121. The report shall include information indicating the
4 extent to which the investment managers hired by the board have
5 achieved or failed to achieve the performance benchmarks established
6 pursuant to section 23-30-123 (1)(b).

7 **SECTION 13.** In Colorado Revised Statutes, 23-30-123, amend
8 (3) as follows:

9 **23-30-123. Investment policy - fiduciary responsibility -**
10 **annual financial statements.** (3) If the board of governors votes to
11 invest assets of the Colorado state university system pursuant to sections
12 23-30-121 and 23-30-122, NOTWITHSTANDING SECTION 24-1-136
13 (11)(a)(I), the board shall require annual financial statements to be
14 submitted to the board of governors, the state treasurer, the state auditor,
15 and the joint budget committee of the general assembly. The financial
16 statements shall include, at a minimum, information concerning
17 investment income, gains, and losses, if any, of the Colorado state
18 university system. The financial statements shall report the performance
19 of investments on both a gross-of-fee and a net-of-fee basis.

20 **SECTION 14.** In Colorado Revised Statutes, 23-40-106, repeal
21 (4) as follows:

22 **23-40-106. Education innovation institute established -**
23 **purposes - appropriations.** (4) ~~On or before January 10, 2011, and on~~
24 ~~or before January 10 each year thereafter, the institute shall prepare and~~
25 ~~submit a report to the education committees of the house of~~
26 ~~representatives and the senate, or any successor committees, concerning~~
27 ~~the activities of the institute in the previous calendar year. The report~~
28 ~~shall include, at a minimum, information concerning the efforts of the~~
29 ~~institute to fulfill its purposes as described in subsection (2) of this~~
30 ~~section.~~

31 **SECTION 15.** In Colorado Revised Statutes, 23-60-306, repeal
32 (3)(m) as follows:

33 **23-60-306. Colorado customized training program - creation**
34 **- policy - functions of the state board for community colleges and**
35 **occupational education.** (3) (m) ~~Beginning January 1, 1985, and each~~
36 ~~January 1 thereafter, the state board for community colleges and~~
37 ~~occupational education shall report to the joint budget committee and the~~
38 ~~legislative audit committee on the cost-effectiveness of the Colorado~~
39 ~~customized training program in assisting economic development in~~
40 ~~Colorado."~~
