SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

HB18-1006 be amended as follows:

1 Amend reengrossed bill, page 6, line 3, after the period add "TESTING  
2 UNDER THIS SUBSECTION (1)(b) IS NOT REQUIRED IF THE PARENT OR LEGAL  
3 GUARDIAN OBJECTS."

4 Page 6, strike lines 7 through 13 and substitute:

5 "(1.5) IF THE DEPARTMENT DEEMS THAT NEW CONDITIONS FOR  
6 WHICH AN INFANT MUST BE TESTED SHOULD BE ADDED, THE DEPARTMENT  
7 SHALL REPORT THE ADDED CONDITIONS TO THE GENERAL ASSEMBLY  
8 DURING ITS PRESENTATION IN ACCORDANCE WITH THE "STATE  
9 MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT  
10 (SMART) GOVERNMENT ACT", PART 2 OF ARTICLE 7 OF TITLE 2. THE  
11 DEPARTMENT SHALL ALSO NOTIFY THE JOINT BUDGET COMMITTEE AND THE  
12 HEALTH AND HUMAN SERVICES COMMITTEE OF THE SENATE AND THE  
13 HEALTH, INSURANCE, AND ENVIRONMENT COMMITTEE AND THE PUBLIC  
14 HEALTH CARE AND HUMAN SERVICES COMMITTEE OF THE HOUSE OF  
15 REPRESENTATIVES, OR THEIR SUCCESSOR COMMITTEES, WITHIN SIXTY  
16 DAYS AFTER THE DEPARTMENT RECOMMENDS A NEW CONDITION AND  
17 INCLUDE THE ADDED CONDITIONS IN THE DEPARTMENT'S ANNUAL BUDGET  
18 REQUEST SUBMITTED TO THE GENERAL ASSEMBLY EACH NOVEMBER 1."

19 Page 10, line 10, strike "24-75-402." and substitute "24-75-402 THROUGH  
20 JULY 1, 2021."

21 Page 13, line 7, after "following:" insert "SCREENING FOR HEARING LOSS  
22 UNDER THIS SUBSECTION (3)(a) IS NOT REQUIRED IF THE PARENT OR LEGAL  
23 GUARDIAN OBJECTS."

24 Page 14, line 7, after the period add "SCREENING FOR HEARING LOSS  
25 UNDER THIS SUBSECTION (5) IS NOT REQUIRED IF THE PARENT OR LEGAL  
26 GUARDIAN OBJECTS."

27 Page 18, strike line 1 and substitute "SCREENING PROGRAM."

28 Page 18, line 4, strike "24-75-402." and substitute "24-75-402 THROUGH  
29 JULY 1, 2021."
