As a resident of Colorado who values the rule of law and believes in the importance of upholding our immigration laws, I find this proposal deeply concerning and fundamentally unjust.</p> <p>Granting state identification cards to individuals who are unlawfully present in the United States undermines the principles of legal immigration and disregards the importance of maintaining lawful residency status. As someone who has personally navigated the complex and rigorous requirements of abiding by immigration laws to sponsor my spouse for legal residency, I find it deeply unfair to extend privileges such as state identification to those who have knowingly violated immigration laws.</p> <p>Moreover, the proposed changes to the requirements for obtaining these identification documents, including the removal of the requirement to file a Colorado resident income tax return and demonstrate residency for two years, only serve to further erode the integrity of our immigration system and incentivize unlawful presence in the country.</p> <p>I urge the Senate to reconsider this bill and instead focus on upholding the rule of law and promoting legal pathways to residency and citizenship. If amendments are to be made, I implore the Senate to rescind the Colorado Road and Community Safety Act altogether</p> |
