1 Amend reengrossed bill, page 7, after line 21, insert:

2 **"SECTION 5.** In Colorado Revised Statutes, 8-20-101, **add** (6)
3 as follows:

4 **8-20-101. Division of oil and public safety - creation -**
5 **appointment of director - transfer of duties - rules.** (6) BY JANUARY
6 1, 2020, THE DIRECTOR OF THE DIVISION OF OIL AND PUBLIC SAFETY SHALL
7 PROMULGATE RULES FOR RETAIL ELECTRIC VEHICLE CHARGING STATIONS,
8 SETTING FORTH STANDARDS RELATED TO THE METHOD OF SALE OF
9 ELECTRICITY USED TO CHARGE ELECTRIC VEHICLES, INCLUDING
10 REQUIREMENTS FOR DEVICES, ACCESSORIES, AND SYSTEMS USED FOR THE
11 MEASUREMENT OF ELECTRICITY. THE UNIT OF MEASURE FOR RETAIL
12 ELECTRIC VEHICLE CHARGING MUST BE IN KILOWATTS PER HOUR. THE
13 DIRECTOR MAY PROMULGATE RULES SETTING REASONABLE FEES IN THE
14 AMOUNTS NECESSARY TO OFFSET THE DIRECT AND INDIRECT COST
15 INCURRED IN ADMINISTERING THIS SUBSECTION (6). THE RULES
16 PROMULGATED UNDER THIS SUBSECTION (6) MUST CONFORM WITH
17 NATIONAL STANDARDS AND BE REASONABLY NECESSARY TO ENSURE:

18 (a) EQUITY IN THE MARKETPLACE;
19 (b) PROTECTION OF THE PUBLIC AND PEOPLE USING RETAIL
20 ELECTRIC CHARGING STATIONS.

21 **SECTION 6.** In Colorado Revised Statutes, 8-20-201, **amend** (2)
22 as follows:

23 **8-20-201. Definitions.** As used in this part 2, unless the context
24 otherwise requires:

25 (2) "Fuel products" means all gasoline; aviation gasoline; aviation
26 turbine fuel; diesel; jet fuel; fuel oil; biodiesel; biodiesel blends;
27 kerosene; ELECTRICITY; all alcohol blended fuels; liquefied petroleum
28 gas; gas or gaseous compounds, including hydrogen; natural gas,
29 including compressed natural gas and liquefied natural gas; and all other
30 volatile, flammable, or combustible liquids, that are produced,
31 compounded, and offered for sale or used for the purpose of generating
32 heat, light, or power in internal combustion engines or ELECTRIC OR fuel
33 cells, for ELECTRIC VEHICLES OR cleaning, or for any other similar usage. ".
