

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB25-117 be amended as follows:

1 Amend printed bill, page 41, line 12, after "43-4-804," insert "**amend**  
2 (1)(a)(III); and".

3 Page 41, after line 19 insert:

4 "(a) (III) (A) The road safety surcharge shall not be imposed on  
5 any ~~rental vehicle on which a daily vehicle rental fee is imposed pursuant~~  
6 ~~to paragraph (b) of this subsection (1)~~ VEHICLE THAT IS OFFERED BY A  
7 BUSINESS THAT RENTS VEHICLES AS A SHORT-TERM VEHICLE RENTAL.

8 (B) AS USED IN THIS SUBSECTION (1)(a)(III), "SHORT-TERM  
9 VEHICLE RENTAL" MEANS THE RENTAL, OTHER THAN THROUGH A VEHICLE  
10 SHARING ARRANGEMENT, OF ANY MOTOR VEHICLE, AS DEFINED IN SECTION  
11 42-1-102 (58), WITH A GROSS VEHICLE WEIGHT RATING OF TWENTY-SIX  
12 THOUSAND POUNDS OR LESS THAT IS RENTED WITHIN THE STATE FOR A  
13 PERIOD OF NOT MORE THAN THIRTY DAYS."

14 Page 44, line 20, after "(3)(a)," insert "(5)(g)(III),".

15 Page 44, line 21, strike "(5)(g)(III) and".

16 Page 47, strike lines 20 through 22 and substitute:

17 "(g) (III) (A) The bridge safety surcharge shall not be imposed on  
18 any ~~rental vehicle on which a daily vehicle rental fee is imposed pursuant~~  
19 ~~to section 43-4-804 (1)(b)~~ VEHICLE THAT IS OFFERED BY A BUSINESS THAT  
20 RENTS VEHICLES AS A SHORT-TERM VEHICLE RENTAL.

21 (B) AS USED IN THIS SUBSECTION (5)(g)(III), "SHORT-TERM  
22 VEHICLE RENTAL" MEANS THE RENTAL, OTHER THAN THROUGH A VEHICLE  
23 SHARING ARRANGEMENT, OF ANY MOTOR VEHICLE, AS DEFINED IN SECTION  
24 42-1-102 (58), WITH A GROSS VEHICLE WEIGHT RATING OF TWENTY-SIX  
25 THOUSAND POUNDS OR LESS THAT IS RENTED WITHIN THE STATE FOR A  
26 PERIOD OF NOT MORE THAN THIRTY DAYS."

27 Page 51, strike lines 24 through 27 and substitute "fees to the  
28 transportation special fund. Any vehicle rented pursuant to a vehicle  
29 sharing arrangement that ~~is~~ WOULD HAVE BEEN exempt, pursuant to  
30 section 43-4-804 (1)(b)(III), from the daily vehicle rental fee imposed  
31 pursuant to section 43-4-804 (1)(b)(I)(A) BEFORE THE REPEAL OF SAID  
32 SECTION 43-4-804 (1)(b) BY THIS SENATE BILL 25-117, ENACTED IN 2025,  
33 is ~~also~~ exempt from the congestion impact fee."
