Second Reading

1 Amend reengrossed bill, page 21, line 4, after "(2)(c)," insert "(6),".

2 Page 23, after line 15 insert:

3 "(6) The commission has the authority, as it deems necessary and
4 convenient, to conduct any hearings or to make any determinations it is
5 otherwise empowered to conduct or make by means of an appointed
6 ADMINISTRATIVE LAW JUDGE OR hearing officer, but recommended
7 findings, determinations, or orders of any ADMINISTRATIVE LAW JUDGE OR
8 hearing officer ~~shall not become final until adopted by the commission in~~ IN
9 ACCORDANCE WITH SECTION 34-60-108 (9). Upon appointment by the
10 commission, a member of the commission may act as a hearing officer.".

11 Page 28, after line 13 insert:

12 "**SECTION 12.** In Colorado Revised Statutes, 34-60-108, **add (9)**
13 as follows:

14 **34-60-108. Rules - hearings - process.** (9) WHENEVER ANY
15 HEARING OR OTHER PROCEEDING IS ASSIGNED TO AN ADMINISTRATIVE LAW
16 JUDGE, HEARING OFFICER, OR INDIVIDUAL COMMISSIONER FOR HEARING,
17 THE ADMINISTRATIVE LAW JUDGE, HEARING OFFICER, OR COMMISSIONER,
18 AFTER THE CONCLUSION OF THE HEARING, SHALL PROMPTLY TRANSMIT TO
19 THE COMMISSION AND THE PARTIES THE RECORD AND EXHIBITS OF THE
20 PROCEEDING AND A WRITTEN RECOMMENDED DECISION THAT CONTAINS
21 THE FINDINGS OF FACT, CONCLUSIONS, AND RECOMMENDED ORDER. A
22 PARTY MAY FILE AN EXCEPTION TO THE RECOMMENDED ORDER; BUT IF NO
23 EXCEPTIONS ARE FILED WITHIN TWENTY DAYS AFTER SERVICE UPON THE
24 PARTIES, OR UNLESS THE COMMISSION STAYS THE RECOMMENDED ORDER
25 WITHIN THAT TIME UPON ITS OWN MOTION, THE RECOMMENDED ORDER
26 BECOMES THE DECISION OF THE COMMISSION AND SUBJECT TO SECTION
27 34-60-111. THE COMMISSION UPON ITS OWN MOTION MAY AND, WHERE
28 EXCEPTIONS ARE FILED SHALL, CONDUCT A DE NOVO REVIEW OF THE
29 MATTER UPON THE SAME RECORD, AND THE RECOMMENDED ORDER IS
30 STAYED PENDING THE COMMISSION'S FINAL DETERMINATION OF THE
31 MATTER. THE COMMISSION MAY ADOPT, REJECT, OR MODIFY THE
32 RECOMMENDED ORDER.".
